MULTI-ANNUAL PROGRAMME (1994-96) OF WORK FOR COOPERATIVES, MUTUAL SOCIETIES, ASSOCIATIONS AND FOUNDATIONS IN THE COMMUNITY

EXPLANATORY MEMORANDUM

At its session of 17 March 1995 (EP A4-0119/95) the Parliament adopted a series of amendments to the above-mentioned Multi-annual Programme.

The Commission accepted ten out of the eleven amendments approved (1,2, 4-9, 13, 14), either exactly as worded or subject to re-wording. The purpose of the amendments to Articles 1 and 2 and to the annex is to clarify who is entitled to benefit from the programme (definition of an commercial association) and what the guidelines for intervention should be. In addition, improvements to the Commission's text are proposed via other amendments, such as:

- that concerning the establishment of an observatory comparable to that for SMEs;
- those designed to allow the appropriations available for these actions to be scheduled on the basis of information supplied via an updated financial statement;
- that intended to simplify procedures by replacing the Management Committee provided for in Article 4 by an Advisory Committee composed of representatives of the Member States and chaired by the representative of the Commission;

The Commission accepts the above amendments.

However, the Commission cannot accept Amendment 3, since the consultation structure it proposes is too far removed from the procedures adopted by the sector itself.

Article 4

A committee shall be set up, attached to the Commission, composed of the representatives of the Member States and chaired by the representative of the Commission.

The representative of the Commission shall submit to the committee a draft of the measures to be taken. The committee shall deliver its opinion on the draft within a time limit which the chairman may lay down according to the urgency of the matter. The opinion shall be delivered by the majority stipulated in Article 148(2) of the Treaty in the case of decisions which the Council is required to adopt on a proposal from the Commission. The votes of the representatives of the Member States within the committee shall be weighted in the manner set out in that Article. The chairman shall not vote.

The Commission shall adopt measures which shall apply immediately. However, if these measures are not in accordance with the opinion of the committee, they shall be communicated by the Commission to the Council forthwith. In that event, the Commission shall defer application of the measures which it has decided for a period of two months from the date of communication.

The Council, acting by a qualified majority, may take a different decision within the time limit referred to in the previous paragraph.

Article 6, paragraph 2

2. The budgetary authority shall determine the appropriations available for each financial year in accordance with the principles of good management referred to in Article 2 of the Financial Regulation applicable to the general budget of the European Communities.

Amendment nº 7

Article 4

The Commission shall be assisted by a consultative committee composed of representatives of the Member States and chaired by the representative of the Commission

The representative of the Commission shall submit to the committee a draft of the measures to be taken. The committee shall deliver its opinion on the draft within a time limit which the chairman may lay down according to the urgency of the matter, proceeding where necessary to a vote.

The opinion shall be entered in the minutes. In addition, each Member State shall have the right to ask for its position to be included in the minutes

The Commission shall take full account of the committee's opinion. It shall inform the committee of the form in which the opinion has been taken account of.
