Amendment to the draft Council Resolution on improving the prevention and treatment of acute human poisoning

(presented by the Commission pursuant to Article 149(3) of the EEC Treaty)

Explanatory memorandum :

The Commission's initial proposal was forwarded by the Commission to the Council on 14 December 1989 (1).

The Economic and Social Committee delivered its opinion on 28 March 1990 (2).

The European Parliament delivered its opinion (Bombard Report) and voted the amendments proposed in the Bombard Report on 23 November 1990.

Further to these opinions the Commission has decided to submit to the Council the amended proposal for a Resolution (enclosed).

The amendments relate to the following points:

- A) Added information to make the text more specific by referring to:
 - data in relation to the use of illicit drugs supplied by the Poison Centres according to the resolution of the Council and the Ministers of Health meeting within the Council of 16 May 1989 concerning an European network of health data on drugs abuse (89/C185/01)
 - the EHLASS project concerning accidents involving consumer products;
 - acute poisoning and its implications for the health of the public in general;
 - collaboration with the World Health Organization and the poison centres of Community and non-Community countries.
- B) Reduction to three years (instead of five) of the time limit for updating the annexes and endeavouring to harmonize the expressions used in Annexes 1 and 2.
