Explanatory memorandum

The first instalment of the 1982 cereals food aid programme adopted by the Council on 25 April 1982 (1) allocated Mozambique 25 000 t of cereals to be delivered CIF.

When the Council adopted the supplementary cereals programme on 3 December 1982 a further 15 000 t was allocated to Mozambique, bringing its total allocation to 40 000 t.

On that second occasion it was specified by mistake that the whole allocation was to be delivered FOB; a contradiction in respect of the first allocation and inaccurate in respect of the second.

The result is that the Commission finds itself unable to mobilize this aid though it is urgently required. The Commission accordingly proposes that the Council adopt the decision at annex and amend the annex to its Decision of 3 Décember 1982 so that the aid to Mozambique can be delivered CIF instead of FOB.

Proposal for a COUNCIL DECISION

amending Decision 82/836/EEC on the 1982 cereals food-aid programme

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

whereas, in accordance with Council Decisions 81/407/EEC (1) and 82/77/EEC (2), the European Economic Community has deposited a declaration of provisional application of the Food Aid Convention 1980 and of the 1981 Protocol for the first extension of the Convention to 30 June 1983;

whereas certain developing countries and specialized agencies have requested food aid in the form of cereals from the Community; whereas their situation and that of the Community warrant a total allocation of one million tonnes of Community aid;

whereas, by Decision 82/27D/EEC (3), the Council adopted a programme of cereals aid amounting to 927 663 tonnes; whereas by its Decision 82/836/EEC (4) that quantity was increased to one million tonnes;

whereas the latter Decision contains a clerical error regarding the terms governing the delivery of the food aid to Mozambique,

HAS DECIDED AS FOLLOWS :

Sole article

The entry for Mozambique in the Annex to Decision 82/836/EEC is hereby amended as follows :

Mozambique	25 000	15 000	40 000	CIF
