STATISTICAL PROGRAMME

General priorities and objectives of Directorate E

Directorate E's activities are fully in keeping with one of EUROSTAT's fundamental objectives, which is to improve the quality of statistics.

The Council (1) and Commission (2) regulations on external trade statistics are aimed at creating a system of harmonized and comparable statistics at Community level.

From the point of view of methodology, the Directorate therefore attaches primary importance to implementing and adapting the regulations. The Directorate's programme in this field concentrates on four major topics:

a) redefinition of the Community's special trade;

- b) recording of statistics on trade between Member States on the basis of exports;
- c) definition of statistical value;
- d) warehouse traffic.

Of special importance are the Directorate's efforts to harmonize the nomenclature of goods for external trade statistics, in particular the Customs Cooperation Council's 'harmonized system, a project to which EUROSTAT has made a steady contribution since its inception.

The harmonization of definitions and nomenclatures leads to constant improvement in the comparability and quality of statistics. In the last few years the Directorate has drawn up in cooperation with the Commission's Computer Centre a 'general programme' which can be used to compile the basic external trade statistics at quarterly and yearly intervals. This programme is being adapted with a view to compiling basic data at monthly intervals some time during 1981. A back-up to the general programme is provided by the 'ranking programme', designed to facilitate systematic simple grouping of basic data.

For the purposes of implementing the Regulations and the Commission's trade agreements, the Directorate has to supply as a matter of priority the basic files to be used for statistical monitoring of imports under the various systems, such as the Generalized Preferences Schemes, the multilateral GATT negotiations, the Multifibre Agreement, the system for petroleum products, etc.

Furthermore, the problem of the rapid dissemination of basic documentation is being closely considered by the Directorate, which is studying the possibility of incorporating the external trade statistics (at the most detailed level of the NIMEXE nomenclature) into the EURONET system.

A back-up activity to which the Commission attaches particular importance (3) and which concerns Directorate E directly involves the 'managment of data banks'.

Moreover, in order to meet the needs of the various Directorates-General in connection with trade negotiations (e.g. North-South Dialogue, UNCTAD, Lomé Agreements, etc), the Directorate has developed a system of compiling GATT data in accordance with the SITC nomenclature; this data bank will be improved when the present data, supplied directly by the Member States, are replaced by the harmonized Community statistics.

The Directorate is studying a programme for the development of an online chronological bank of NIMEXE data at six-digit level; it is also stepping up the statistical analysis required to prepare international trade negotiations and study of the Community's external trade.

In the same context and in order to provide the basic documentation to describe the main features of the economic and social situation in the countries which signed the Lomé Convention and in other non-member countries, the Directorate is developing the existing CRONOS files (ZPVD and QUIC) with a view to setting up a bank of time series.

Furthermore, the DGINS Conference asked EUROSTAT to coordinate Member States' technical assistance with regard to ACP countries. This activity, which is in addition to that already under way with the countries of the Central African Customs and Economic Union (UDEAC) (Cameroon, Central African Republic, Gabon and Congo) and to the price comparison project in a number of African countries, could be stepped up in the near future, subject to the availability of funds, of course.

1. INTRODUCTION

The task is essentially the harmonisation and management of commodity nomenclatures used in the external trade statistics of the Community and statistics of trade between Member States as well as participation in the construction of new world commodity nomenclatures used in external trade.

2. SOURCE:

- Regulation (EEC) Nos 1445/72 and 3065/75 of the Council concerning the nomenclature of goods for the external trade statistics of the Community and statistics of trade between Member States (NIMEXE),
- Council Decision concerning the construction of a harmonised system of describing and codifying goods (negatiating power delegated to the Commission),
- Program set up by CCC for the Harmonised System.

3. <u>AIM</u>:

- (1) Harmonisation of the nomenclature used in the Community and comparability with other nomenclatures used throughout the world.
- (2) Creation of the conditions making possible the transmission of information by modern methods.
- (3) Simplification of formalities and facilitation of the movement of goods.

4. DESCRIPTION:

- Administration of NIMEXE (more than 7000 headings) in the 7 official languages of the Community.
- Maintenance of correlation between NIMEXE and SITC.
- Construction of the Harmonised System (about 5000 headings) based on CCCN and SITC rev. 2, complemented by explanatory notes, a list of descriptions and an alphabetical index.
- Revision of TARIC.
- Revision of SITC.

1. INTRODUCTION

One of EUROSTAT's tasks is to prepare the trade statistics required for framing Community economic and trade policy and conducting trade negotiations with non-member countries. This involves not only compiling and disseminating the basic information but also analysing and studying the trade of the Community and its main trading partners with a view to better assessment of the Member States' trade flows. In recent years studies and analyses have thus been prepared for the renewal of the EC-ACP Convention, the preparation of the UNCTAD Conference and the North-South Conference, the Euro-Arab Dialogue, EC-Latin America relations and for specific negotiations with the USA, Japan, China, EFTA, Comecon, etc.

2. SOURCE

Requests from Commission departments and other institutions, in particular the European Parliament and the Council of Ministers.

3. AIM

To carry out statistical and economic studies and analyses with a view to giving a better picture of Community trade.

4. DESCRIPTION

This work can take the form of both complex in-depth studies to be published and brief analyses accompanied by ad hoc statistics.

5. WORKPLAN

Two types of analyses are involved: firstly, studies programmed to meet specific objectives which can be laid down in advance, such as the opening of trade negotiations or the outcome of a Community measure. The following studies will be carried out in 1981:

- analysis of EC-ACP trade 1970-1980
- analysis of Community trade by branch of industry 1970-1980.

Secondly, ad hoc studies prepared on topical Community problems or in response to specific urgent requests from Commission departments or other institutions.

6. FINANCING

Will be required: firstly, some studies will have to be commissioned from research institutes, universities, etc. and, secondly, funds will have to be found for the data processing involved (staff and machine time).

1. INTRODUCTION

In order to have a correct assessment of the volume of, and trends, in external trade, indices are generally used which are above all intended as pointers to trends in the relative level of the prices of goods traded.

The aim is to calculate indices for the EC and for various country and product groupings which do not exist for all Member States and therefore cannot be generated from national data.

2. ORIGIN

EUROSTAT already publishes a monthly series of overall indices (current value, average value, volume, terms of trade, volume ratios) which is not altogether satisfactory (not harmonized, insufficiently broken down, too limited in scope and utilization, etc.). The Commission departments and, in particular, DG II have on several occasions urged that a more appropriate instrument of analysis be introduced. The Statistical Office first tackled the problem of compiling better quality average value indices which are more reliable and better adapted to user requirements.

3. OBJECTIVE

To provide a better quality preliminary assessment of trends in relative prices and volume of goods traded and with a breakdown permitting differential analysis.

4. DESCRIPTION

Selection and transcodification of NIMEXE - 6 digit data as provided monthly by the General Programme (i.e. in national currency, without regroupings). Aggregation and annual concatenation of these data according to the needs. Grouping of data to blocks designed as system management units when the whole system is operational. Calculation of rates and weights on various levels and derivity of indices thereof. Revision of rates and weights for amelioration of results and deriving improved indices thereof according to the strategies under discussion.

5. WORK PROGRAMME

In order to allow for a balanced and proven decision we are preparing a pilot study along the lines indicated above. This study will come to an end by 8/81 leading to a final proposal with the necessary software operational for direct continuation. For the SSAP it is only left to convert the programmes into production programmes.

6. FINANCING

An analyst/programmer and a programmer are currently working under study contract up to 8/81. Financing problems are therefore settled.

7. VOLUME OF WORK

At the moment it is E-3 staff and two experts working permanently on this project. Furthermore A.U.1 and A.U.2 are supporting the work with two advisers attending the project meetings.

1. INTRODUCTION

In view of the nature and volume of the data collected for both the Community and non-member countries and of their many and varied uses, the data bank is a means of making the basic statistics available quickly and of facilitating the analysis required for the study of world trade.

2. SOURCE

Increasing demand from internal (Commission departments and other institutions) and external users (national authorities, universities, the two sides of industry).

3. AIM

To provide users with a tool for rapid access to the most detailed and recent data on the trade flows of the Community and non-member countries, as well as with the analytical instruments required for the study of these flows.

4. DESCRIPTION

The data bank will contain the following basic information:

- a Annual data based on SITC Rev. 1 (5 digits) for approximately 130 reporting countries (including the Community Member States), with all trading partners from 1963 to 1979;
- b Quarterly data based on SITC Rev. 2 (5 digits) for the Member States of the Community and the main industrialized countries as reporting countries, with all trading partners since 1978;
- c Annual data based on SITC Rev. 2 (5 digits) for the other non-member countries as reporting countries, with all trading partners since 1978;
- d Quarterly data based on 'NIMEXE STANDARD' (NIMSTA nomenclature which can be used to monitor a given product over time by aggregating NIMEXE headings which have been split from one year to the next) (6 digits) for the Member States of the Community as reporting countries, with all trading partners since 1977;
- e Quarterly data based on the NIMEXE (6 digits) for the Member States of the Community as reporting countries, with all trading partners since 1977. This part of the project will replace the NIMSTA. The data bank will also include the necessary consultation, analysis and tabulation programms.

5. WORKPLAN

This project comprises two stages: the first is already well under way and is primarily intended to meet the needs of internal Commission users by making parts 4 a) to 4 d) of the project available to them. The timetable is as follows:

The work under 4 a) is completed, 4 b) and 4 c) will be completed in February 1981 and 4 d) in May - June 1981.

The software to go with this part of the project has already been prepared and comprises a series of relatively short programs which there are no plans to expand.

The second stage, the aim of which will be to set up the NIMEXE bank, is currently being studied and will meet the needs of both internal and external users. The work in 1981 and 1982 will be carried out in stages, firstly the creation of a central core and then the operating programs.

6. FINANCING

Funds will be required for all the automatic processing work.

7. VOLUME OF WORK

Very considerable, requiring the assistance of specialists in both data processing and statistics.

1. INTRODUCTION

For framing their policy towards non-member countries, in particular the developing countries, the Commission and the other institutions need both a wide range of data on the development of the economic and social situation in these countries and rapid statistics on trends in Community trade with the ACP countries in connection with the Lomé Convention.

2. SOURCE

Application of the Lomé Convention and demand from users.

3. AIM

To provide users with a selection of the main macroeconomic indicators of the various countries in the world and the most recent statistics on the Community's short-term trade with the ACP countries.

4. DESCRIPTION

Chronological data bank.

5. WORKPLAN

Development of the existing CRONOS files, i.e. ZPVD and QUIC.

6. FINANCING

No.

7. VOLUME OF WORK

Considerable, owing to the volume of statistics processed. The two files account for approximately a quarter of the whole CRONOS base.

1. INTRODUCTION

The demand for technical assistance from the statistical services of the ACP states continues to be very great. It is addressed more and more to international organizations and in particular the Community, especially since the entry into force of the Lomé Convention, one of the major aspects of which is the development of technical co-operation between the Community and the ACP states.

2. SOURCE

Request from the governments or regional organizations of the ACP states.

3. AIM

To supply technical assistance to the statistical services of the ACP states or to the statistical departments of the regional organizations in fields which are limited but of great interest to both the ACP states and the Commission.

4. DESCRIPTION

The main forms which this new activity should take are as follows:

- a) co-operation of Member States' statistical technical assistance activities;
- b) advisory services, i.e. the sending of advisers sponsored by the SOEC to observe the introduction of a system or help organize specific projects;
- c) vocational training for statisticians from developing countries by:
 - the organization of training courses at the SOEC
 - liaising with DG VIII as regards problems of financing ACP nationals' training
 - sending lecturers to training institutes in Europe and Africa.

5. WORKPLAN

- a) Coordination: organization of annual meetings attended by all bodies responsible for statistical technical assistance to developing countries;
- b) Advisory services: the aim of the first project will be to help improve the collection, processing and analysis of the external trade statistics of the UDEAC countries (Cameroon, Central African Republic, Gabon, Congo);
- c) Training of statisticians: regular work including the provision of a Secretariat for the CESD Board of Administration, organizing meetings of the CESD Scientific Committee, etc.

1. INTRODUCTION

SOEC, which already has responsibility for ICP in the Member States, has accepted the role of coordinator for a similar project in seven French-speaking African countries: Marocco, Tunisia, Senegal, Cameroon, Ivory Coast, Mali and Madagascar. In 1981-1982, the project will be extended to 8 new English-speaking African countries.

2. SOURCE

Request of the Statistical Office of the United Nations.

3. AIM

To study, in real terms, the aggregates of the national accounts of the participating countries.

4. DESCRIPTION

To organize, according to a common methodology, price enquiries on the final consumption products of households, for capital goods and for the collective consumption of administrations.

5. WORKPLAN

To collaborate with the participating countries in the setting up of a common methodology by means of working meetings in Africa and Europe. To give technical assistance to the countries for the launching and realization of the project.

6. FINANCING

Spread over the period 1980-1981, 300 000 EUA or ECU for technical assistance to the French-speaking countries. Request has been made to allow the same financing to the English-speaking countries (1981-1982).

7. VOLUME OF WORK

Work divided with Division B 3. For the moment the work in E 2 is carried out by the Head of service.

TITLE: Production of external trade statistics (general programme)

PROJECT NO: E 3 001

1. INTRODUCTION

The compilation of basic data on the Community's external trade and trade between Member States has been regarded by both the Commission and the Member States as one of the main tasks of Community statistics since the beginning of the Common Market; a special effort has been made in this field in the last few years. These data are used as a basis for Community negotiations, proposals and decisions in connection with the Customs Union, the free movement of goods, competition, Community trade and economic policy and the special agricultural and industrial policies.

The data have been collected and published at Community level since 1958. The Member States send the detailed statistics to the SOEC each month in accordance with standard classifications. In 1975 computer processing of all the basic data was included in the project 'General programme of external trade statistics'.

Since 1 January 1978, the methods of collecting and forwarding the figures have been laid down pursuant to Council Regulation (EEC) 1736/75 'concerning the external trade of the Community and trade between Member States'. In the fifth statistical programme the general programme of external trade statistics is represented by two projects, namely project E 3 001 describing the production of Community data by the SOEC, and project E 3 002 regarding the collection and dissemination of data in relation with the Member States and the users of the statistics.

2. SOURCE

Regulation (EEC) No 1736/75, in particular Article 36 (2) and (3).

3. AIM

To produce Community statistics on the basis of the data supplied by the Member States.

4. DESCRIPTION

From the monthly data forwarded by each of the nine Member States the computer produces (after checking, correction, harmonization, conversion of values into European Units of Account (ECU) and transcription) Community tables on the external trade of the Community. This general programme supplies the SOEC with data on the imports and exports of each Member State and the

Community with each trading partner in terms of value, quantities and supplementary quantities in accordance with the following specifications):

- breakdown by product and group of products, viz.
 - the nomenclature of goods as used in the external trade statistics of the Community and statistics of trade between Member States (NIMEXE), comprising some 7 100 headings;
- the Standard International trade Classification (SITC) Rev. 2, comprising some 1 000 headings;
- the Common Customs Tariff (CCT) nomenclature, comprising some 4 000 headings;
- breakdown by trading partner and groups of countries in accordance with the Geonomenclature, comprising some 200 countries and 25 zones.

- direct on-line dissemination via the EURONET network, currently being studied;
- introduction of a ranking programme for the production of tables as and when requested is under way.

PROJECT NUMBER: E 3 003

1. INTRODUCTION

In accordance with the proposal made at the United Nations Conference on Trade and Development (UNCTAD), the Community has opened up generalized tariff preferences since 1971, particularly for finished and semi-finished industrial products from developing countries. The initial ten-year period of application of the scheme ended in 1980. The Council has just adopted the new regulation extending the scheme for a period of five years and laying down the procedures for 1981. This scheme includes a monitoring system for the imports in question. The SOEC helped in the monitoring initially on a monthly basis with the help of a programme run on the WANG mini-computer between 1975 and 1977 and then on a quarterly basis with the help of the central computer from 1979 onwards. The SOEC is responsible for statistical monitoring, which permits in particular comparison with world trade for all the preferential products, whereas the Commission's Customs Union Service (CUS) is responsible for managing the scheme and for short-term monitoring of sensitive products.

Outside the GSP, the SOEC has developed programmes for statistical monitoring of imports in other sensitive sectors such as agricultural markets, textiles, petroleum products and footwear. Computer processing programmes have been set up which can be adapted to monitoring of other products.

2. SOURCE

Various Concil Regulations (EEC).

Agreements with the Commission departments responsible for implementing these regulations: DG I, CUS, DG III, DG VI, DG VIII.

3. AIM

To supply the Commission and the Member States with the information required to implement the regulations. Decisions of economic and political importance are taken on the basis of these statistics (reconstitution and changes of customs duties etc.).

With a view to making the system clearer, a study is currently under way on the dissemination of data to recipient countries, international organizations and importers.

4. DESCRIPTION

Generalized system of tariff preferences (GSP)

Annual calculation of supply and ceilings, quarterly statistical monitoring of imports in relation to quotas and ceilings, and comparison of imports.

Agricultural products

Special aggregation of agricultural products as part of the general programme. Quarterly production of statistics on the products covered.

Textile surveillance

Special production of statistical tables on textiles aggregated according to the categories laid down in the multi-fibre agreement as part of the general programme each quarter. Monthly monitoring of quotas and ceilings. Updating of a data base which can be used by the Customs Union Service (CUS).

Other products

Same system of quarterly statistical monitoring as part of the general programme as for textiles.

5. WORKPLAN

Annual adaption of the programmes and inputs, to changes in the basic regulations, Harmonization of the data collected by the Member States. Continuation of the regular work of data collection, checking, updating, processing and dissemination.

Development of the application to cover other products according to policy requirements.

6. FINANCING

None at present. Some may be required for future developments (programming).

7. VOLUME OF WORK

The project involves a considerable amount of machine time and regular programming work (see SOEC's data processing programme). The supply of the special data will involve a considerable amount of work for the Member States.

8. WORKING GROUP

Under the auspices of the Directorates-General concerned and the Council.

9. DISSEMINATION

At present the data are disseminated to Commission departments and international organizations in the form of microfiches and printouts.

The possibility of publication is being discussed.

(GATT, UNCTAD)

PROJECT NUMBER: E 3 004

1. INTRODUCTION

The Commission negotiates for the Community within the GATT framework of trade political agreements. For the last 8 years multilateral trade negotiations have been going on and came to an end in 1980 with a final agreement becoming fully operational during the next 8 years. For the forthcoming years various trade political topics will be on the agenda. Above all there is the enlargment of the Community which makes it necessary to defend the tariff of the so enlarged Community. Negotiations concerning preferential trade are also likely to start quite soon.

The SOEC has to play an important role in all these negotiations because it is the Office which has to provide the necessary information. The Office has to serve the needs of DG I, III and VI who are directly involved in these negotiations. It must also serve the needs of DG II and XIX who deal with model calculations and financial consequences in this area, and finally of the GATT secretariat organizing the exchange of information between the negotiating parties.

3. AIM

4. DESCRIPTION

The project consists of two parts. All basic activities, especially the data processing, are managed and executed by the Office. All other activities directly linked to actual GATT work are done in cooperation with the interested services.

A. Actual GATT work

- 1. Calculation of a global and partial balance of duty revenues for Greece before and after accession (for negotiations because of the enlargment under Art. XXIV/5 and 6 of the GATT).
- EC Tariff statistics from 1977 onwards for a Community with 10 Member States to monitor the impact of the last multilateral trade agreements and to fulfill obligations towards the GATT secretariat.

- 3. Calculation of ad valorem equivalents for mixed and specific duties (for a standardised comparison between the Community and either third countries or forthcoming Member States).
- 4. Standard elaborations later to be covered by the ranking programme of the general programme if it becomes available possibly in 1981.
- 5. Calculation of average duty rates for SITC.

B. Basic GATT work

- 6. Establishing a Tariff Rate Information file for the preceeding years containing preferential treatment due to either the Generalised System of Preferences (GSP) or bilateral agreements (ACP, MAGREB, MASHREK etc) leading to an extension or an overhead of SABINE.

No regular workplan exists. The deadlines are given by our clients and especially their negotiation meetings.

6. FINANCING

Part of the activities are done by SOEC staff. Two external programmers and an external analyst are financed under the DP budget.

Concerning data collection there is no extra work load besides the regular foreign trade statistics (NIMEXE) except for information about tariffs.

Consultations with the Customs Service of the Community and with the respective services of the acceding Countries are necessary. Considerable space load in the computer center (see working program for data processing at the Office).

During the 1960s there were close links between the statistical services of the African countries and the SOEC. When the Yaoundé Convention gave way to the larger Lomé Convention, the collection of these statistical data was stepped up rapidly and nowadays covers the 60 signatory countries and the countries of the Southern Mediterranean. The basicdata are supplied by the countries concerned either directly to the SOEC or via the United Nations Statistical Office.

2. SOURCE

Lomé Convention and requests from Commission departments responsible for its implementation, in particular DG I, DG VIII and the CUS. Requests from international and African organizations and the Commission delegations to the countries concerned.

3. AIM

To provide users with data on the ACP countries' external trade.

To pulish the statistical yearbook of the ACP countries' external trade.

4. DESCRIPTION

The ACP states send their annual external trade data to the Community either directly or via the United Nations or the UNCTAD.

These data are processed and harmonized by computer. They are then placed on microfiches and fed into the CRONOS data base. The CRONOS domain or file available to internal users is called ZCAl; it comprises some 120 000 annual series. The publication covering the whole of the ACP countries' external trade is produced every two years from the CRONOS data.
