COMMISSION REPORT TO THE COUNCIL

on the foreseeable developments in the planting and
replanting of vineyards in the Community and on the ratio
between production and utilisation in the wine sector

COM(78) 527 final.

Introduction

The purpose of the report which the Commission is required to present to the Council, in accordance with Article 17(4) of Regulation (EEC) No 816/70¹ is to record the ratio between production and utilisation in the wine sector and to estimate foreseeable changes in that ratio on the basis, in particular, of the forecasts provided for in paragraph 3 of the same Article. Following serious difficulties in the wine sector resulting from events during the last few years which have made the balance between supplies and utilisation precarious, the Council decided in 1976 to forbid the planting of new vineyards for two marketing years and undertook at the same time to adopt before 1 October 1978, the measures needed to ensure that wine-growing potential is adjusted to market requirements. Therefore, the Commission drew up an action programme on the progressive establishment of balance on the market in wine which contains a number of proposals to the Council. The report which accompanies these proposals contains an exhaustive analysis of the factors which contribute to market balance.. This is why although the Annex contains tables covering the sector as a whole this report only contains comments on the foreseeable developments in the wine-growing areas and in production as shown in the Member States' forecasts.

General considerations

The unreliability which was noted several times in the previous report in the data given in the national estimates on which this report is based means that the usual reservations about their validity have to be pointed out.

The most important events in the last two wine-growing years (1976/77 and 1977/78) were the prohibition on new plantings of vines imposed by Regulation (EEC) No 1162/76 and the granting of a conversion premium for areas under vines provided for by Regulation (EEC) No 1163/76.

The combined effect of these two provisions, although more limited than one might have hoped, has been quite obvious and has on the whole counteracted the previous trend towards an increase in areas.

The main points indicated by the national estimates for the present wine-growing year are as follows:

I. Foreseeable developments in the area under vines in the various producer Member States (for wine grapes)

a) Germany

The increase in the areas under vines expected in wine-growing year 1976/77 (0.2%) over existing areas under vines was in fact 0.8%. For the 1977/78 wine-growing year the German estimate indicates an increase of 0.3% in areas under vines. This increase, which only covers quality wines p.s.r., is almost entirely accounted for by new plantings since the areas grubbed up and those replanted cancel each other out. The two regions which contribute the most to the expected increase are those of Stuttgart and Unterfranken.

b) France

The forecasts for last year, that is a reduction in the area of 1.2%, were exceeded. In fact the total area was reduced by 1.5% (19 000 ha).

For the 1977/78 wine-growing year a further reduction of 1.2% in the total area under vines is expected. The areas which are being reduced are those producing table wine (- 16 642 ha) and in the Cognac region (- 343 ha), while the areas of quality wines p.s.r. are increasing. At regional level the expected reductions for table wine are considerable for Aquitaine, Midi-Pyrénées, Languedoc, Provence-Côte d'Azur and Corse; the increases in quality wines p.s.r. are concentrated in Aquitaine, Rhône-Alpes, Languedoc and Provence-Côte d'Azur.

c) Italy

For the 1976/77 wine-growing year the estimated 0.8% reduction in the total area corresponded to an actual reduction of 0.6%. The Italian estimate for the 1977/78 wine-growing year indicates a drop of 0.5% in the total area. This is due to a relatively large reduction in table wine (- 9 896 ha) and a more modest increase for quality wines p.s.r. (+ 3 856 ha). Since there are no new plantings for table wine the reduction is due to a considerable drop in replantings rather than to a greater number of grubbing up operations. The regions where large reductions for table wine are expected are in order: Apulia, Veneto, Emilia-Romagna and Piedmont. The increases for quality wines p.s.r. are in particular in Emilia-Romagna, Piemont Sardinia and Apulia.

d) Luxembourg

The increases in the total area under vines in the 1976/77 wine-growing year (+ 0.9%) were greater than those expected (+ 0.2%).

For the 1977/78 wine-growing year a reduction of 10 ha in the area for table wine and an increase of 20 ha for quality wine p.s.r. is expected. The total area should therefore increase by 10 ha (+ 0.8%).

II. Foreseeable developments in the areas under vines in the Community as a whole

The expected reversal of the trend during the 1976/77 wine-growing year was confirmed (at least partially) by the data on the operations carried out. The total area under wine grapes has in fact decreased by 15 618 ha (- 0.6%). The Member States' estimates for the 1977/78 wine-growing year point to a further reduction in the total area (20 437 ha corresponding to 0.8%). The same trend applies to areas under table grapes which should decrease by 2 124 ha (35 in France and 2 089 in Italy). However the forecasts for the 1976/77 wine-growing year have not been confirmed and the expected reduction (- 1 704 ha) will be changed into an actual increase (+ 1 601 ha).

The drop in the total area under wine grapes referred to above is due entirely to the considerable reduction planned in the areas where table wines (- 26 543 ha) and Cognac (- 343 ha) are produced while for those producing quality wines p.s.r. a further increase is expected (+ 6 454 ha).

The areas not yet in production stabilized during the 1975/76 wine-growing year, after constantly increasing during the period 1971/72-1974/75. These areas reduced considerably during the 1976/77 wine-growing year. This phenomenon could be interpreted as a slowing down in the normal rate of replanting.

III. Influence of changes in the estimated wine-growing area in 1977/78 on future production (Tables 6 and 6a)

As in the past, the foreseeable changes in production resulting from the changes expected with regard to the areas are not in proportion. If one looks at the average production during the last seven wine-growing years, the reduction in total production (510 669 hl) should be 0.3%, compared with a reduction of 0.8% in area. This expected drop in production is the result of a reduction of less than 1% for table wine and an increase of about 2% for quality wines p.s.r. and of 0.2% for other wines.

The discrepancy between the changes in the areas and in production confirms once again the increase in the yield per hectare.

The graphs No 1 to 6 were drawn up taking into account the figures on production and use of wine during the 1977/78 wine-growing year. These figures are those given in the estimate for that year. As regards those relating to production all the information available indicate that they will be confirmed, while those on use will according to information from professional circles probably be altered upwards, in particular because of a certain stability in direct human consumption in France where a considerable drop was expected. This is why the curve of internal use which in graphs 1 and 2 shows a considerable reduction may be changed when the actual figures for direct human consumption for the 1977/78 wine-growing year are available.














(in million hectolitres)




Development of internal consumption of wine
