**COMMISSION REPORT TO THE COUNCIL
ON THE FORESEEABLE DEVELOPMENTS IN THE PLANTING AND
REPLANTING OF VINEYARDS IN THE COMMUNITY AND ON THE RATIO
BETWEEN PRODUCTION AND UTILISATION IN THE WINE SECTOR**

COM(79) 533 final

Introduction

Article 31(3) of Regulation (EEC) No. 337/79¹ requires the Commission to send the Council annual reports covering, in particular, the ratio between wine production and utilization and estimating foreseeable changes in this ratio. The reports are to be largely based, until 31 March 1980, on the national plans referred to in the third subparagraph of Article 31(1).

The Council's 1976 prohibition on new plantings was extended to 30 November 1979 and the requirement that measures be adopted for adapting wine-growing potential to market requirements was deferred from 1 October 1978 to 1 October 1979. The Community's future wine-growing potential is accordingly substantially influenced by the present planting arrangements, which will certainly have an effect on the balance of supply and demand in the years to come. This balance has also been substantially altered by the fairly low volume of production in three successive years. Because of these factors influencing market balance, no reliable conclusions can be reached as to future developments on the basis of recent data, and the Commission's findings in its report on the progressive establishment of balance on the market in wine, laid before the Council with the 1979-85 action programme, accordingly remain valid.

The present report, delayed because some Member States sent in their national plans late, therefore merely sets out the changes in the factors influencing market balance. For a medium-term assessment, reference should be made to the report and programme referred to above.

II General considerations

Although the differences between the forecast change in area based on declarations of intent by producers and the actual situation has narrowed considerably (for the main producer countries at least), the usual reservations as to the accuracy of this report nevertheless remain valid.

As the prohibition on new plantings has been maintained for 1978/79, the reversal of the tendency for Community wine-growing areas to increase is continuing and it seems that there is now a period of stability or even slight reduction in area under vines.

II. Wine-growing areas

The changing situation with regard to the cultivation of wine grapes in the Community is shown in Tables 1, 2, 3 and 4. These cover wine-growing in the four main producer Member States only since producers in other Member States do not have to notify their planting, replanting or grubbing programmes. In respect of each Member State, the results of operations actually carried out during 1977/78 are given and these are compared with forecasts based on producers' declarations of intent; this makes it possible to assess the reliability of the declaration system. The estimates drawn up by the Member States on the basis of producers' declarations of intent for 1978/79 are also given.

1. Foreseeable changes in total wine-growing areas in the various producer Member States

(a) Germany : Slight increase in area for quality wines psr

An increase of 0.3% was forecast in Germany for 1977/78. In practice, the increase was as much as 1.3%.

Estimates for 1978/79 suggest an increase of 0.2%, entirely in quality wines psr. More than half the increase in area is accounted for in Franconia.

(b) France : Substantial reduction in total area following a slowdown in replanting

The estimated drop in area by 1.2% for 1977/78 was slightly exceeded (1.3%).

A further reduction of 1.6% is estimated for 1978/79, basically on account of the very definite slowdown in replanting of vines for table wine and vines in the Cognac area, which is not offset by an increase in quality wines psr based on new plantings. The most substantial variation is in the Languedoc-Roussillon area, where a decline of 8 000 ha is foreseen. Considerable reductions (some 4 000 ha) are also expected in Aquitaine and Midi-Pyrénées.

(c) Italy : Slight fall in total area - increase in quality wines psr and drop in table wine

The area under vines fell by 0.6% in 1977/78, rather more than forecast (0.5%).

Forecasts for 1978/79 show a very slight drop in total area with a reduction of 4 255 ha for table wines and an increase of 3 754 ha for quality wines psr. More substantial falls are forecast for Apulia (1 500 ha, table wines) and Piedmont (1 000 ha, table wines).

(d) Luxembourg : Increase in area for quality wines psr

The forecast drop of 0.8% for 1977/78 proved accurate (0.9%).

The forecast increase for 1978/79 is 1.4%; this is entirely accounted for by new plantings for quality wines psr.

2. Foreseeable development in area under vines in the Community as a whole

The fall in the total Community area under vines had been estimated at 0.8% for 1977/78 and was in practice 0.9%. This drop follows one of 0.6% in 1976/77 and one may reasonably suppose that it is connected with the prohibition on new planting and the aid for converting vineyards introduced by the Council in 1976.

A further fall in the total area under vines is forecast, on the basis of producers' declarations of intent, for the Community as a whole for 1978/79. This fall is forecast at 0.8% and reflects a considerable reduction in the area used for production of table wine and cognac (reductions of 25 241 ha and 632 ha respectively), only partially offset by an increase in the area intended for production of quality wines psr (+ 4 919 ha).

As for the area used for table grapes, forecasts suggest a fall of 2.2%, on top of an actual fall of 3.9% recorded for 1977/78. These reductions are both in Italy and in France, but the fall in France, expressed as a percentage, was greater (see Table 5). The apparent trend in table grapes is probably in part a consequence of the introduction, in 1976, of the requirement to distil wines made from surplus table grapes.

III. The volume of Community wine output

Influence of estimated changes in the wine-growing area in 1978/79 on future production.

Although the pattern with regard to output is broadly similar to that forecast for area, it is not exactly in proportion. Whereas a reduction in area of 0.9% is forecast for 1977/78, it appears that the combined effect of new plantings, replanting and grubbing will bring about a fall

in output of only 0.4% (compared with average output from 1970/71 to 1977/78) (see Table 6). The divergence between the two trends is very sharp in Italy, where there was a reduction of 500 ha but a forecast production increase of 0.2%. It should, however, be emphasized that a reduction in Community production of table wine of 1.1% is forecast, with falls of 2% in France and 0.5% in Italy, whereas increases are forecast for quality wines psr in all producer Member States. The percentage increase is 2.3% for the Community as a whole : 6.8% in Italy, 4.4% in Luxembourg, 0.8% in France and 0.2% in Germany (Table 6a). Production of other wines is expected to show practically no change (- 0.2%) (Table 6a).

Analysis of the data on areas and production reveals two positive trends: a reduction in total production potential and a strengthening of quality wine production structures. If this tendency persists, a better balance could well be achieved on the wine market.

V. The market situation

1. Demand for wine in the Community

The main development shown by Table 9 is the steady drop in human consumption, starting from 1975/76. This may partly be explained by the very high level of consumption in 1974/75 owing to an increase in consumption by growers, connected with the very large quantities available during that year. But the basic cause is a reduction in consumption in the large producer countries which was not compensated by increases in the other countries. In 1977/78 human consumption was again increasing, but only slightly, in Belgium and the Netherlands and it fell in the United Kingdom. It seems that, for the present at least, any forecast of an increase in consumption based on rapid gains in the non-producer countries has to be abandoned. In 1977/78, human consumption dropped to a level 1.4%

lower than the previous year; total domestic utilization dropped much more sharply (- 6.3%) on account of a very substantial fall in the quantities distilled at the Community's expense (- 4 360 000 hl, or 52%). Figures at present available indicate that there will be practically no change from 1977/78 to 1978/79 as the forecasts for a slight increase in human consumption and a larger increase in the quantities distilled have proved incorrect.

2. Prices and Community intervention

(a) 1976/77

Average prices recorded during 1976/77 at the various marketing centres, with the exception of one where the prices of table wines of Type A I remained stationary, were higher than during the previous year. The increase was not uniform, the rates varying from 0 to 171.5% according to the place of quotation. With regard to red table wines of type R I, accounting for the largest share of production, prices in France at the beginning of the year were above the guide price and, except for very short periods, remained so throughout the year. In Italy, however, prices remained below the activating price throughout practically all the year except at the end, when forecasts of a small harvest brought them up to the guide price.

The situation was more balanced for red table wines of type R II. French and Italian quotations were comparable throughout the year, always about the level of the guide price, and never went below the activating price.

The level of quotations for white table wines of type A I during the year confirmed that this market is still beset by structural

difficulties : market prices remained consistently below the activating price both in France and in Italy. The activating price was reached and exceeded only at the end of the year, when forecasts of a very low harvest had been confirmed. This was particularly apparent in France, where the white wine harvest of 1977 was severely affected by frost in the main production areas.

The prices of "German" table wines of types R II, A II and A III increased very sharply during the year, climbing well above the respective guide prices.

The ample quantities available at the beginning of the year and the unsatisfactory prices for a substantial proportion of production meant that the Commission had to deploy all the intervention measures made available by Community rules other than the exceptional ones. The average monthly quantity subject to storage contracts amounted to 12.5 million hl (17 million hl in 1975/76). "Normal" management measures led to distillation of 5 390 000 hl (as against 2 168 000 hl in 1975/76).

Distillation was particularly widely employed in France under the preventive distillation and "cognac" arrangements, which represented 89.8% of the total quantities distilled. It should be pointed out that the fairly high level of preventive distillation in France (3 899 698 hl) was achieved thanks to national measures which encouraged such distillation.

For the first time, "performance guarantee" measures, confined to the holders of long-term storage contracts, were adopted.

(b) 1977/78

The 1977 harvest was much smaller than the year's normal average requirements, and this, though partly offset by the very heavy stocks available at the beginning of the season, tended to force up the prices of the table wines of the most significant types. Accordingly, the market prices for red table wines of types R I and R II remained consistently above the activating price and, from July-August, these exceeded the relevant guide prices.

The gap between the French and Italian prices narrowed, but Italian prices still remained lower, on average, than French prices in nearly every case. However, the gap between the prices recorded in these two countries for white table wines of type A I became quite large when bad weather in France, reducing output, forced up prices. The Community representative price for this type of wine fluctuated around the activating price until April and, subsequently, apart from a short period in October, remained below that price, the fundamental weakness of this sector being thus once again confirmed.

With regard to the "German" table wines, the market situation was satisfactory for red wines of type R III, while quotations for white wines (A II and A III) slipped to a point below their respective activating prices practically from the beginning of the season and did not improve thereafter.

Community intervention and consequent expenditure (see Table 24) during 1977/78 was substantially lower than in previous seasons. The average monthly quantity subject to storage contracts was 890 000 hl as against 12.5 million in 1976/77. As the Council took no exceptional distillation measures, the "management" distillation measures covered substantially lower quantities than in earlier years. The total volume of wines distilled, including wines made from table grapes which were compulsorily distilled, did not exceed 1 030 000 hl, the smallest figure since the market organization was set up¹. It should also be stated that the quantities qualifying for export refunds were some 170 000 hl, a very low figure. "Guaranteed performance" distillation was decided upon at the end of the season for white table wines (type A I and types A II and A III).

3. Trade

Three particular remarks may be made in respect of the trade pattern during recent years. The first is that the preponderant position of intra-Community trade in total trade is confirmed (see Table 13).

The second is that imports have steadied at levels substantially below those reached during 1972/73 and 1973/74. The third is the slow but steady increase in exports, which has for the first time entailed a positive trade balance - in volume terms - in wine.

(a) Intra-Community trade

The total volume of intra-Community trade increased substantially in 1975/76 and fell sharply in 1976/77, to increase again in 1977/78 (see Tables 11 and 12). This is basically the result of the trend in Italian shipments to Germany and France, which was not fully offset by the trend in French shipments, which reached a peak in 1976/77. In 1977/78, Italian shipments took first place in intra-Community trade with 66.7% of the total, well ahead of those from France (29.4%) and Germany (3.2%) (see Table 11). For the same period, France was at the head of the list of consignee countries, with 38.2% of the total, ahead of Germany (36.3%), which fell back slightly compared with previous years. The United Kingdom, on the other hand, advanced to 9.4% of the total and took third place. It is clear that the volume of French shipments in 1977/78 was substantially lower than the volume of consignments received. This can be explained by the very low production in France for that year.

(b) Imports

The significant increase in imports in 1972/73 and 1973/74 was a result of very high Community prices but imports then steadied at a lower, but still quite significant, level. The quantity was practically stable during 1974/75, 1975/76 and 1976/77 and then rose in 1977/78, but less sharply than exports (+ 5.5% against + 11.2%) (see Tables 16, 17, 18 and 19). Spain consolidated its first place as supplier of the EEC in 1977/78. It accounts for 39.2% of Community imports and is followed by

Portugal, whose share is rising (11.5% more than in 1976/77) and represents 12.9% of the total. Imports from the Maghreb were stagnant, those from Austria, Yugoslavia (which has become the EEC's third supplier), Hungary and Argentina rose, whereas imports from Greece, which occupies fourth place amongst suppliers, and from Cyprus fell. Greece, Spain and Portugal together exported 3 171 147 hl to the EEC in 1977/78, 59.2% of the total.

(c) Exports

Tables 20 to 23 give data on exports by the Member States to the main importing non-member countries.

In general, these exports have expanded since 1974/75. The increase was very substantial in 1975/76 (27.9% higher than 1974/75) but slower in 1976/77 (2.6%) and in 1977/78 (11.9%). The country with the biggest export growth is Italy, whose wines have been very successful in the USA.

French exports are increasing slowly, whereas those from the other countries are tending to mark time.

The very significant rise in imports by the USA has made this country far and away the Community's best customer. That country alone absorbed 41.6% of Community exports in 1977/78. Switzerland imported 4.2% less in 1977/78 but remains the number two importer (16.7% of the total) ahead of Canada, which took 11.3% of the total and whose imports are rising steadily (14% higher in 1977/78 than in 1976/77). There had been some optimism for exports to Japan, but these in fact showed little change, whereas those to Austria and the free ports fell slightly. Four countries (USA, Switzerland, Canada and Sweden) together account for 75.3% of the Community's market.





(in million hectolitres)




(in million hectolitres)









Development of internal consumption of wine


