## **COMMUNICATION FROM THE COMMISSION**

**TO THE COUNCIL**

**CONCERNING THE FINAL SUPPLY BALANCE FOR WINE**

**FOR THE 1985/86 WINE YEAR**

**COM(87) 406 final**

Under Article 31(3) of Council Regulation (EEC) No 822/87 of 16 March 1987 (1), the basic Regulation on wine, the Commission is required to provide the Council each year with a final statement of Community resources and consumption in the preceding wine year.

In fulfilment of the above requirement, this Communication contains the final supply balance for wine for the 1985/86 wine year. A comparison of the balances for 1985/86 and 1984/85 attached to this Communication leads to the following observations:

#### I. PRODUCTION

Total production of wine in the Community in 1985/86 (1985 harvest) was 142.7 million hectolitres compared with the record 168.2 million hl from the 1979 harvest and 171.9 million hl from the 1982 harvest. There was a decrease in Italy to 61.7 million hl as against 70.2 million hl in 1984 (- 12.1%), with quality wines psr totalling 8.1 million hl, and an increase in France to 70.1 million hl as against 63.4 million hl in 1984/85 (+ 10.6%), with quality wines psr (19.9 million hl) accounting for 28.4% of total production. Germany's production at 6.1 million hl was down (- 31.5%) as was production in Luxembourg with 107 000 hl (- 29.6% compared with 1984/85). In Greece, the decrease was slighter (4.8 million hl as against 5.0 million hl in 1984/85, i.e. - 4.0%) while the share of quality wines psr in this figure went up slightly to 7.6%.

Community production as a whole in 1985 was down by 4.9 million hl compared with 1984 (- 3.3%).

#### II. CONSUMPTION

Total internal Community consumption in 1985/86 came to 139.8 million hl compared with 152.4 million hl in 1984/85 (- 12.6 million hl or - 8.3%). These figures cover direct human consumption and quantities processed; details are given below.

## 1. Direct human consumption

Directe human consumption totalled 107.6 million hl, down by 7 million hl (- 6.2%) on the previous wine year. These figures confirm that the trend continues to be downwards, affecting the two main producing countries (France and Italy), without this being offset by the increases in consumption in the other Member States.

In France, wine consumption per head/year still averaged som 97 l in 1976-80 but is now down to 80.4 l in 1985/86 after being 83.1 l in 1983/84. The trend is much more marked in Italy: 62.2 l per head/year in 1985/86 compared with 80.4 l i, 1983/84, 71.3 l in 1984/85 and an average of 90 l in 1976-80. Taking the Community as a whole, per capita wine consumption fell by 2.7 l in 1985/86 (- 6.4%). The trend over the last 15 years is apparent from the selected figures set out below.

## 2. Quantities processed

Quantities processed in 1985/86, which are made up of quantities intended for making into wine spirits with a designation of origin (i.e. wine produced specially for distillation), wine distilled with Community aid and quantities intended for the manufacture of other products such as vinegar, accounted for 31.6 million hl as against 37.1 million hl in 1984/85 (- 5.5 million hl or - 14.8%).

The quantities of wine distilled with Community aid, which reached 29.9 million hl in 1984/85, came to 23.8 million hl in 185/86. France and Italy alone accounted for the distillation of some 23.2 million hl, with Greece distilling 0.6 million hl.

Disregarding distillation schemes financed from the Guarantee Section of the European Agricultural Guidance and Guarantee Fund (EAGGF), total internal consumption for 1985/86 corresponds to a self-sufficiency rate of 123.0%. This degree of self-sufficiency comes down to 102.1% if intervention distillation is taken into account.

### III. END-OF-YEAR STOCKS

Community wine stocks at 31 August 1986 amounted to 97 million hl as against 99 million hl at 31 August 1985 (- 2 million hl or - 2%).

### IV. EXTERNAL TRADE

In the wine year under review, the Community imported 4.6 million hl from non-member countries compared with 5.0 million hl in 1984/85 (- 8.1%). There was a downturn in exports from 11.0 million hl in 1984/85 to 9.4 million hl in 1985/86 (- 15.0%).

The external trade balance therefore remains in surplus, by 4.8 million hl against 6.0 million hl in 1984/85.
