THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No. 1302/78 of 12 June 1978 on the granting of financial support for projects to exploit alternative energy sources<sup>1</sup>, and in particular Article 6(2) thereof,

After consultation with the Advisory Committee on the Management of Projects for the exploitation of Geothermal Energy,

Whereas Regulation (EEC) No. 1302/78 provides for the granting of financial support for demonstration projects to exploit alternative energy sources in the Community, which by their nature may serve as examples and which prior studies and research have shown to offer prospects of industrial and commercial viability;

Whereas it is important to promote projects particularly likely to make best use of the geothermal reserves of the Community;

Whereas the Commission, by its Decisions of 29 November 1978, of 24 July 1980 and of 22 July 1981 has already adopted three series of projects within the meaning of Article 6 (2) of Regulation (EEC) No. 1302/78; whereas a further series of projects should be adopted,

HAS ADOPTED THIS DECISION

Article 1

The demonstration projects listed in the Annex shall receive financial support under the provisions of Regulation (EEC) No 1302/78 by means of a financial contribution which shall be repayable on certain conditions.

Article 2

The financial support referred to in Article 1 shall be granted to each of the projects on the basis of the percentages of the final cost, as verified and accepted by the Commission and indicated in the Annex and within the limits of the maximum amounts also specified in the Annex.

Article 3
