About the author:

Zoë Bray worked at the European Bureau for Lesser Used Languages Brussels Information Centre from October 1997 to June 1998. Born 8th of July 1974, of dual British and French nationality, Miss Bray has lived in various European countries, including Spain, which has enabled her to become fluent in Spanish. Tracing her origins on her mother's side back to the northern Basque country, Miss Bray expresses a great interest in minority cultural issues. This has led her already to learn Basque and to do field research on the Basque education system and its socio-political impact in a village in the French Basque countryside, for her Masters degree in Social Anthropology at the University of Edinburgh, Scotland. She is now due to begin a PhD in Social and Political Science at the European University Institute in Florence, Italy. Her research will focus on European identity and minority languages. During her time at the EBLUL Miss Bray was responsible for the research and editing of two publications. The first involved the production of the first Compendium of its kind, which lists all the minority language projects financed by the EU during 1995 and 1996. This guidebook is the product of the second project. It is also the first edition of its kind which, as a consequence, involved an exhaustive amount of investigation work over a period of six months. At a time when the Commission has been developing and changing many of its programmes and when the legal bases for many of its budget lines are being questioned, research attempted to follow as closely as could be permitted and to keep itself up to date with official proceedings.

Preface

The aim of this guidebook is to present all the funding programmes and opportunities within the European Union which could be of interest to minority languages in Europe. These funds are managed by the European Commission, the executive body of the European Union, through its Directorates General (commonly known simply as "DGs").

The European Commission officially offers only one programme specifically for minority languages in Europe. This comes in the form of the budget line B3-1006, run by the DG XXII of the European Commission in charge of all matters concerning Education, Training and Youth. However, depending on the type of project pursued by the minority language group in question, there are many programmes that could also be relevant. The best example is that of cultural projects. Projects by minority language groups can for instance easily fit the criteria of the programmes run by the DG X (Culture, Media and Communication). But there are others, which could concern for example, professional training in the minority language, promotion of local employment through local initiatives, rural development and educational innovation.

However, as a result of a desire to motivate representatives of minority languages and provide a rich collection of financial opportunities and contact networks, this guidebook also contains a tentative list of foundations and private trusts so as to illustrate other grant possibilities on offer.

Nonetheless, since this guidebook was initially conceived to include only EU funding, this list does not claim to be complete.

The guidebook is organized into separate themes chapters in order to facilitate the search for programmes relevant to the project in mind. In each, section A will list the EU programmes and section B foundations and private trusts.

This comprehensive outlay of programmes and grants is then followed by a concise list of addresses of associations and institutions of diverse interest. This includes specific lobby groups, advisory, consulting and representative bodies, as well as the UNESCO, the Council of Europe, and the Committee of the Regions.

The author and the European Bureau for Lesser Used Languages wish to make it clear that they are in no way responsible for any of the consequences that may result from any applications following information given in this guidebook. All the information gathered in this guidebook remains to be treated merely as funding possibilities in many cases which have for the most part never received funding under the guise of minority languages interest.

This guidebook is the result of six months extensive research. It is the first of what aims at being an annual edition. EU programmes however tend to change regularly, and this guidebook has attempted to maintain itself as up-to-date as possible.

Introduction

The European Union

European Commission

The European Commission has 20 members - two of each from France, Germany, Italy, Spain and the United Kingdom, and one from each of the other Community countries. The Commission is appointed for five years. The current Commissioners took office on 1 January 1995.

The Commission is the Union's executive body. It must carry out the rules agreed under the Treaty and issues rules as to the implementation of certain Treaty Articles. It administers budget appropriations earmarked for Union operators and manages the programmes designed for this.

Charged with making proposals for all new legislation, it can also exert influence at every stage of the process leading up to the adoption of a new European law, which is ultimately taken by the Council and Parliament.

The Commission has an administrative staff based mainly in Brussels and, to a lesser extent, in Luxembourg. It comprises approximately 16,000 officials divided between some 26 Directorates General.

European Parliament

The European Parliament is made up of 626 members - 99 from Germany, 87 from France, Italy and the United Kingdom, 64 from Spain, 31 from the Netherlands, 25 each from Belgium, Greece and Portugal, 22 from Sweden, 21 from Austria, 16 from Finland, 15 from Ireland and 6 from Luxembourg.

General meetings mostly take place in Brussels to facilitate contact with the Commission and the Council. Its Secretariat is based in Luxembourg and Brussels. However, the Parliament will also sit in Strasbourg once a month for its plenary session.

In a number of important areas, the Maastricht

Treaty introduced a co-decision procedure which gives Parliament the power to adopt regulations and directives on a near equal footing together with the Council, on issues as the single market, social policy, economic and social cohesion, research and the new areas covered by the Union Treaty: trans-European networks, consumer protection, education, culture and health. This involves a complex system of two readings of legislative proposals. Besides that, for decisions of major importance (international agreements, accession of new members, right of residence of EU citizens, etc.) the Council must obtain Parliament's assent.

Parliament's main role is as a political driving force, generating various initiatives for the development of Community policies. It supervises the activity of the Commission and can dismiss it on a censure motion carried by two thirds majority. Together, Parliament and the Council form the budgetary authority. It is thus possible to seek the support and advice from local Members of the European Parliament (MEPs) on projects.

MEPs also organize themselves into Committees, depending on the interests they have. There are Committees representing cultural concerns, human rights, agricultural interest etc. Over 60 MEPs have also joined together to create a less official intergroup specifically for Minority Language issues.

Council of European Union

The Council is made up of the Member State ministers who take up different responsibilities in the EU framework, such as foreign affairs, agriculture, internal market, economic matters, environment etc. Council meetings take place generally in Brussels, though three meetings a year are held in Luxembourg. Each Member State acts as President of the Council for six months in rotation.

In the Community context, the Council has the task of ensuring that the objectives laid down by the Treaty are attained by coordinating the general economic policies of the Member States and by adopting, on proposals from the Commission, the main decisions relating to the common policies. Council powers are also widespread in common, foreign and security policy as in justice and home affairs.

Heads of State and the President of the Commission assisted by the Foreign Ministers and a Member of the Commission also meet twice a year for what is called the "European Council" to provide the impetus and to set the guidelines for future action.

Economic and Social Committee

The Economic and Social Committee is made up of 222 members from three different public areas: employers, workers and other interests (farmers, craftsmen, small and medium-sized manufacturing and other businesses, the professions, representative of consumers, cooperatives, families, ecological movements, etc.). Counsellors are also chosen from employers organizations, trade unions and other interest groups. It meets in Brussels.

Its role is mainly consultative but it can also deliver its opinions in its own initiative. It also cooperates with the European Parliament for the exchange of information between parliamentary committees as well as for liaison between chairmen and rapporteurs.

Committee of the Regions

The Committee was formally inaugurated in March 1994. Its principal role is to enhance the

democratic legitimacy of the EU. It aims at involving more directly local and regional authorities in the deliberations at Community level. It is made up of 222 members from the 15 Member States, plus an equal number of alternate members representing local and regional authorities. The Committee must be consulted by the European Council and the European Commission before any measure is taken, especially when regional interests are involved, notably in education, youth, culture, public health, economic and social cohesion, trans-European cohesion, transport, telecommunications etc.

The EU budget

The EU budget is altered according to the convergence criteria for Economic and Monetary Union, for achieving social and economic cohesion across the European Community and being prepared for further European integration with the arrival of new Member States from Eastern Europe. The major priorities for 1998 are research and technological development (RTD), Transeuropean networks (TENs) and to a lesser extent education and training, information and communication and other social operations. This is a change to the strategies of 1997, when the common agricultural policy consisted in 46.3% of the budget, and structural funds 35.6%. 70% of Structural Fund money - social, regional, agricultural and cohesion funding - goes to regions lagging behind, mainly in Southern Italy, Spain, Portugal, Ireland and Greece. However, through the setting up of a particular form of categorization, where regions are categorized according to certain objectives, regions of inner countries are also eligible.

Structural Funds

The Structural Funds have been divided into five different funds and are managed by different DGs. These include the European Regional Development Fund (ERDF) and the Cohesion Fund, both managed by DG XVI (which is in charge of all matters concerning Regional Policy and Cohesion), the European Social Fund managed by DG V (in charge of Employment, Industrial Relations and Social Affairs), the European Agricultural Guidance and Guarantee Fund (EAGGF), managed by DG VI (Agriculture), and the Financial Instrument of Fisheries Guidance (FIFG), managed by DG XIV (Fisheries).

While the criteria for accessing these funds remain on the whole expressed in terms of large scale macro-economic projects (such as road-building, infrastructure projects) it is nonetheless possible to find niches in the application procedures. It is being increasingly recognised that economic development cannot rely effectively on large scale funding, and so smaller initiatives have been launched. Furthermore it is also being appreciated that economic thriving only takes place when there is cultural and social well-being. Culture is thus increasingly appreciated as going hand in hand with economic progress.

Applicants from minority language groups should therefore not restrict their search for funding to only cultural programmes but look closer at initiatives launched by the Structural Funds and justify their projects in the context of social integration, local initiative and employment.

Eligibility to these funds depends on the project's geographical situation. As already mentioned, regions are organized into "Objective" areas, according to how needy the area is believed to be.

Objective 1 concerns the development and structural adjustment of regions whose development is lagging behind: Greece, Portugal, Ireland,

South of Italy, Spain, and the peripheries of the EU such as the 5 new German *Länder*, the Highlands and Islands enterprise area in Scotland, and a few pockets of heavy industry in other Member States (N.B. Many EU projects require partnerships to be found in an Objective 1 region).

Objective 2 includes regions affected by industrial decline. These areas, in having a higher than average unemployment rate, and being heavily dependent on industry, can also include cities.

Objective 3 focuses on combatting long-term unemployment which is over 12 months and promoting occupational integration of young people who are under 25 years of age. In this effort it supports local community initiatives to meet particular needs specific to the area concerned - cultural, linguistic and social projects.

Objective 4 aims at facilitating workers' adaptation to changes in the industry and production systems.

Objective 5a focuses on areas needing assistance in readapting their socioeconomic structures for more effective processing and marketing of agricultural and fisheries products.

Objective 5b concerns development and structural adjustment of rural areas.

Objective 6 deals with the economic adjustment of very sparsely populated regions, essentially Finland and Sweden.

Each programme in this guidebook will specify which Objectives it supports.

While most EU funding is annual, structural funding is longer term. This means that some programmes last about 6 years, and if the applicant did not apply at the beginning of the launch of the programme it may be too late to receive money since the emphasis is not on programme's timing but on the project's. Where relevant to the programmes listed here, this will be pinpointed.

Application procedure

On the whole, programmes of the European Commission have common characteristics with regard to their criteria. Clear statements are required, explaining the short and long term objectives of the project, the reasons justifying the application, and a concise and realistic budget outline and spending plan. The applicant must also explain in detail the results expected of the project and the degree of impact it is foreseen to have on the target group. For all programmes a special application form must be obtained from the relevant contact point.

The following common characteristics have been determined:

Time span - Most of the programmes of the EU run only for a certain limited period of time, in order then to be able to reassess and evaluate the impact these programmes have had. Many have been running for some three years now and are due to finish this year. In awaiting of renewal or change, some provisional programmes may be proposed.

Transnationality - This is an absolute requirement for a lot of the programmes. The project must have a European dimension in the sense that participants of the projects must either come from different Member States or contribute to co-operation of a transnational, communitarian nature. The work should aim at a sharing of ideas, skills and initiative.

Although applicants are not favoured according to their country of origin, there is an equal repartition of funds on a geographical scale. Particularly valued are the quality of the project, the professional experience of the project organizers, the amount of participants and partners involved, and its originality. In the case of projects involving several partners, one individual or group must be chosen to stand as the one

responsible for all financial matters and for the possible reception of a grant. Applicants must demonstrate their professional capacities in dealing with financial accounts and respect mid-term report deadlines. Their budget outline must appear realistic and feasible.

It is also important to point out that projects look even more impressive if co-financed by other bodies, be they public authorities, private enterprises, foundations etc.

When ringing the relevant contact point in order to obtain further information and an application form, expect to be asked to formalise your request with a fax. For many of the programmes, organisms known as Offices of Technical Assistance have been set up to work with the European Commission for assisting people with their requests and applications. Where relevant, their address will be noted as one of the main contact points.

Advice on Community programmes and how to apply is also available directly through the Commission's own network of Euro Info Centres.

Council of Europe

The Council of Europe (not to be confused with the European Council which gathers together the heads of EU Member States) is an intergovernmental organization with about 40 countries as members. It is not an institution of the European Union. It looks at all the grand issues concerning European society, such as culture, heritage, education, sport & youth and seeks to promote increased awareness and co-operation in these domains.

The Council of Europe has also published a report on the situation of the different minority languages of the EU.

The Council of Europe includes a Congress of European Local & Regional Authorities which has put forth the foundations for a European Charter for Regional or Minority Languages. In 1992 the European Charter for Regional or Minority Languages was given legal status as a European Convention by the Council of Europe, and was opened for signature. In signing the Charter, each state can choose the provisions which it wishes to apply in the various fields of adminis-

tration, education, media, justice, economic, social and cultural life. The Charter officially came into force on 1 March 1998.

Directorate-General V (Employment, Industrial Relations & Social Affairs)

Measures to Combat Racism, Xenophobia and Antisemitism

Total budget for 1997 was 8,000,000 Ecu.

Objectives:

To support projects combatting racism and discrimination on the ground of race, colour, religion & national, social or ethnic origin. Projects can take place at either a local, regional, national or European level and must aim at promoting exchanges of experience and information.

Eligibility:

Actions must be based on the problem of racism in Member States. Priority will be given to those themes on racism in everyday life, racism in professional life, enhancing awareness among the public and legislators. These can take the form of conferences, seminars, cultural events, meetings for the exchange of experience between different types of partners, dissemination of educational material and translation into EU languages.

Deadlines:

There are two deadlines, the first before 1st March and the second before 1st May.

Directorate-General X (Audiovisual, Information, Communication and Culture)

Ariane

Total budget for 1997 was 2,775,000 Ecu.

Objectives:

To encourage a wider dissemination of literary works of the variety of European cultures, by means of translation. It seeks to support developments of cultures, respecting their national and regional diversity, and to increase their knowledge and access to European peoples. Three Actions: 1) The translation of literary works; 2) Co-operation projects carried out in partnership; and 3) Improvement of the skills of professionals in this field.

Eligibility:

Translation grants apply to works of 20th century literature which are representative of the culture of the applicant, are illustrative of contemporary literary trends and are likely to appeal to a broad European audience. Unless it is written in a

minority language, the work must have already been translated and published in two European Union languages (in addition to the original language). The grant serves to subsidise translation into at least one other European Union language, with priority being given to translations into less widely used European Union languages.

Financing:

Grant covers about 35% of translator's fees. However if projects aim a particularly wide dissemination of results, it is likely to cover more.

Deadline:

Deadlines are normally beginning of May each year. However, 1998 is the last year that the programme will be in effect. Decisions as to its future will not be made till the end of the year.

**Kaleidoscope 2000 -
Programme to Support Artistic and
Cultural Activities
With a European Dimension**

Total budget for 1997 was 8,550,000 Ecu.

Objectives:

To promote greater public access to, and broader dissemination of the culture and history of the European peoples and to promote artistic and cultural co-operation between professionals. To offer support for cultural events.

Eligibility:

Artistic and cultural events with a view to improving knowledge and dissemination of the culture and history of the peoples of Europe, such as a European youth music festival, festivals of dance and drama and exhibitions. Measures for promoting non-commercial culture exchanges and artistic creation in all areas (performing arts, visual arts and multimedia). Artistic and cultural projects jointly organized by partners in at least three Member States or by cultural networks and involving creative artists from at least three Member States.

This programme also covers the "European Prize for Visual Arts" which is presented annually to outstanding young artists whose works constitute an outstanding expression of regional and European characteristics.

Deadline:

The last deadline for submission of applications was 1 January 1998. Since this budget line was only running from 1995 to 1998 it is unsure how it will continue as from this year. Decisions will be taken at the end of 1998.

Raphael

Total budget for 1997 was 10,600,000 Ecu.

Objectives:

To encourage the development of European cultural heritage (buildings, monuments and arte-

facts, archaeology, museums and collections, archives, as well as photographic and cinematographic, literary etc.).

Eligibility:

Actions in connection with "major" or "exceptional" heritage, including measures under way; measures to maintain and conserve town centres classified by UNESCO as world heritage sites; support for European heritage workshops on common themes developed at national, local or regional level, but also covering heritage relating to buildings, monuments and artefacts; development of standards/methods concerning conservation practices developed by international professional organizations (e.g. documentation on cultural assets, loans of work, conservation etc.); culture-centred projects complementing other Community activities; cross-border networks and partnerships to improve exchanges of knowledge and experience between museums and heritage professionals; organization of colloquia, seminars and conferences on heritage concerns.

Deadline:

5 June and 10 September 1998. The programme is in its last year of a five-year period. Decisions will be made at the end of 1998 as to its new format.

Note: In 2000-2004 167 million Ecu will support cultural co-operation in Europe, including networks, major events and innovative promotion of creativity and cultural expression. Guidelines in the programme foresee the integration of cultural objectives into EU policy along three main lines: legislation favourable to culture (such as copyright); the cultural dimension of existing support policies; and culture in the EU's external relations. The programme will replace the Kaleidoscope, Ariane and Raphael schemes.

Directorates-General XVI-IA

Ecos-Ouverture 1998-2001

Total budget for 1998-2001 is 25-30 million Ecu from the ERDF (Article 10) and 15 million Ecu from Phare.

Objectives:

Inter-regional co-operation between the EU and Central Europe. It will contribute to projects between regions and towns in EU countries and those in Albania, Bosnia-Herzegovina, Bulgaria, the Czech Republic, Estonia, the former Yugoslav Republic of Macedonia, Hungary, Latvia, Lithuania, Poland, Romania, Slovakia and Slovenia. The NIS and Mediterranean partner countries may also be associated. One of the areas of co-operation is the economic development of the cultural heritage.

Eligibility:

The main partners must be local authorities or bodies controlled by them. At least two EU countries and at least one non-EU country must take

part. Half of EU principal partners must be from Objective 1, 2, 5b or 6 regions. Grant is up to 75%, between 200,000 and 800,000 Ecu.

Grants are provided for research in language maintenance and linguistic field work. Work most

likely to be funded is that serving the community and the linguistic field directly. Publishing subventions are a low priority, although they will also be considered.

Eligibility:

Priority of projects will depend on the urgency of the language's survival. Eligible expenses include travel, tapes, films, consultant fees, etc. Grants are normally for one year periods, though extensions may be applied for.

A brief description of the state of endangerment of the language in question is also required. On another page, an itemised budget that lists expected costs. Estimates are acceptable if realistic. These must be translated into US dollars. Other sources of support must be listed, including other grant applications. Two letters of support are recommended but not essential. Include email address or self-addressed post-card in order to receive acknowledgement of receipt. If a grant is awarded, the recipient is required to provide the Endangered Language Fund with a brief report of the project and copies of all publications resulting from materials obtained with the assistance of the grant.

Applications must be received around 20 April each year. Decisions are delivered end of May.

Leonardo

Leonardo is an action programme for the implementation of a European Community vocational training policy. However, this policy operates in close liaison with the European Union's other priorities. In the first place with education and the Socrates programme. There are close links between training and research and development, and with policies for economic and social cohesion. Vocational training is also an important way of contributing to regional and local development.

The programme is adopted for a period of five years 1995-1999.

Total budget over this period of 620,000,000 Ecu.

Objectives:

To promote vocational training, including vocational guidance. Three types of measures are provided:

1) Transnational pilot projects - to devise, develop and test those concerning in particular the development of common training modules, the anticipation of training needs, the adaptation of content and methods, the training of trainers

and language training. Maximum duration of project is 2-3 years.

2) Transnational placement and exchange programmes - to enable different groups, such as young people in initial training, university students, managers of human resources, to receive part of their training in another Member State and enable trainers and specialists in the area of training to improve the quality of their work through the opportunity of an exchange. The maximum and minimum duration of the project depends on the type of training (e.g. 9 months maximum for young people in initial training; 12 months maximum and 3 months minimum for young workers undergoing university training and young graduates; 12 weeks maximum and 2 weeks minimum for exchanges between undertakings and universities and/or training bodies; and 8 weeks maximum and 2 weeks minimum for exchanges of instructors and specialist language training bodies).

3) Development of knowledge - through surveys and analysis undertaken on the basis of a European Community work plan, concerning in particular, the fields of the anticipation of training needs, investment in training, incentives for training as well as statistics on training provision, finance and beneficiaries.

Eligibility:

Projects must seek to promote different types of organizations: actions will be carried out by partnerships or networks bringing together different actors and operators, such as public authorities, enterprises, training organizations, social partners, universities and training schools. They must also be seen to anticipate training needs and the dissemination of innovation and to be encouraging links between different areas of training, overcoming outdated conventions or compartmentalisation of actions.

It is open to all practitioners of training, both public and private.

The programme includes a full set of support measures designed to strengthen the network co-operation between Member States and to provide support for the setting up of transnational vocational training partnerships. Measures concerning information, monitoring and assessment; also covers the creation of telematic links and data banks in the programme's products and results.

Action 1 has a budget of 100,000 Ecu per year. Projects can receive up to 75% financial support. Action 2 projects can receive up to 5,000 Ecu. Action 3 projects can receive 50 to 100% of expenses.

Field 1: Higher Education (Erasmus)

Aims at supporting universities in an effort to 1) enhance the European dimension of studies and 2) encourage the mobility of teachers and students. Assistance is provided in the form of institutional contracts which cover exchanges of teaching staff and students.

Eligibility:

Projects promoting a European dimension within the university framework: of particular interest to minority languages is the support of thematic networks in specific disciplines and fields of interest and the creation of links between certain universities with common interests. Field 2: School Education (Comenius)

This programme includes 3 types of actions.

The Prix Iris is also based on the concept of free and independent mass media, the individual responsibility of media workers and the idea that freedom of speech and press cannot be guaranteed without the protection and expression of all other human rights.

Eligibility:

The Prix Iris is created for local, regional, national or international (co)productions, designed for the European Communities. Eligible organizations are those which provide local, regional, national or pan-European broadcasting service, public or private in countries which are

member of the EU and the Council of Europe. The independent jury will look for programmes which break new ground in terms of subject matter, are initiative in approach, and appeal to the general viewer. Eligible productions include those which help to dispel stereotyped beliefs and prejudices against ethnic and cultural minorities. The Prize is directed at television, radio and print media.

Awards will be made to programmes in different categories: drama, play, episode from a serial, situation comedy, entertainment, documentary, feature, news report, magazine programme, talk show.

Financing:

Each award will consist of a cash prize of 5,000 Ecu, to be received by the winning programme maker, journalist or production team, and a trophy to be received by the broadcasting organization under whose responsibility the programme was transmitted.

A set of photographs from the programme and a curriculum vitae of the programme-makers should be enclosed with the completed entry form, along with a synopsis of the programme. Philoxenia - Multiannual Programme to Assist European Tourism

This programme was introduced in 1997 but has as yet not been launched. It will be the first multiannual programme of its kind.

Objectives:

To stimulate the quality and competitiveness of European tourism taking in particular into account the balanced and sustainable development of the sector, the satisfaction of the tourists' needs and the rational use of the natural, cultural and infrastructural resources. The programme is also particularly concerned with the promotion of sustainable tourism at the grassroots level.

The actions of this programme will be implemented through reinforced co-operation with national authorities and with the regional and local authorities, as well as the industry and other parties concerned.

There are 4 actions:

Action 1: Improving knowledge in the field of tourism

1. Developing tourism related information: consolidation of the European statistical system for tourism, improving the availability of reliable and up-to-date statistics; development of surveys, studies and desk/field analyses, taking into account the tourism industry needs.

2. Pooling tourism information from other sources: establishment of a European research and documentation network on tourism.

3. Facilitating the assessment of Community measures affecting tourism: establishment of a legal and financial watch allowing for a systematic assessment of Community measures affecting tourism.

Action 2: Improving the legislative and financial environment for tourism

Reinforcing co-operation with Member States, the Industry and other stakeholders. Organization and follow-up of regular meetings with the parties concerned, to reinforce co-operation at European level and to raise awareness of Community initiatives (technical/thematic meetings, round-tables, fora).

Action 3: Raising quality in European tourism

1. Promoting sustainable tourism: support to local initiatives geared towards sound management of visitors flows and stimulation of their networking; support to the implementation of environmentally friendly management systems in tourist accommodations; organizations of a "European Prize for Tourism and the Environment" (every two years).

2. Removing obstacles to tourism development: identification of the principal obstacles at European level faced by various forms of tourism as well as by specific categories of tourists (such as young people, the elderly and disabled people), development of appropriate responses.

Action 4: Increasing the number of visitors from Third Countries

Promoting Europe as a tourist destination: support for multi-annual promotional campaigns in

major issuing countries and/or emerging zones, with the support of participating sponsors.

The Tourism Unit of DG XXII does not have in itself a budget for funding individual projects. Individual project fundseekers must therefore make themselves fit into the programme's own projects.

Phare Programme: Aid for Economic Restructuring of the Countries of Central and Eastern Europe

Budget for the year 1997 was 1,397,200,000 Ecu.

Objectives:

It assists in the restructuring of the economies of Central and Eastern European countries. These countries include Albania, Bulgaria, Hungary, Poland, Romania, the Czech Republic, Slovakia, Estonia, Latvia, Lithuania, Slovenia, Bosnia-Herzegovina and the former Yugoslav Republic of Macedonia. Projects can involve humanitarian aid, assistance to disadvantaged groups, promotion of democracy and measures reinforcing civil society.

Different Actions are outlined below for each type of project:

LIEN Programme (Link Inter-European NGOs):

Budget from 1997 to year 2000 is 10,000,000 Ecu.

Objectives:

To contribute to the development of non-governmental organizations working in social areas and carrying out activities to assist disadvantaged groups in the countries listed above. Activities should cover the integration of marginalised groups, training and assistance for social reintegration of the unemployed, promotion of the position of women, development of social welfare, and health care for groups at risk.

Eligibility:

The partnership between at least one NGO from the EU and one from a beneficiary country is an essential requisite. Nonetheless, some NGOs from different Eastern and Central European countries can directly submit projects without partners in the EU, as long as they still meet the necessary requirements of experience and skills. As from 1997, in the framework of the European Volunteer Centre (see chapter on Youth), EU NGOs can also send young people to work in a project in one of the beneficiary countries. The funding for this however is separate. Duration of a project must not be less than 10 months and must not exceed 24 months.

Deadline:

As from 1998 there is no deadline. Projects can be presented at any time, simply bearing in mind that applications take an average three months to get processed.

Financing:

Cannot cover more than 80% of the project's costs and will include a maximum of 5% of administrative costs. Grants have ranged between 50,000 and 300,000 Ecu.

Phare Democracy Programme

The budget from 1997 to the year 2000 is 10,000,000 Ecu.

Objectives:

To promote democracy in Central and Eastern Europe by promoting the understanding of democratic principle. To encourage NGO activities to promote a democratic and pluralist society, to transfer democratic know-how, skills and the rule of law to professional groups and associations.

Eligibility:

Priority is given to those projects with good quality of partnership between the NGOs involved and which includes the participation of local NGOs in the implementation of projects. Partnership between at least one NGO from the EU and at

least one from a beneficiary country is indispensable. Nonetheless some NGOs of different countries in Central and Eastern Europe may submit their projects directly, without EU partners, provided they have good past experience and appropriate skills. Projects may not run for longer than 36 months, although an extension may be granted after evaluation.

Deadline:

As from 1998 there is no deadline. Projects can be sent at any time, bearing in mind that applications take an average of 3 months to get processed.

Financing:

Cannot cover more than 80% of the total costs. A minimum of 10% of the costs must be covered in cash by the applicants themselves. Administrative costs cannot exceed 5% of the total budget.

The budget is also set aside for funding micro-projects (for whom a separate budget has been reserved of 2 million Ecu and which is supposed to increase as micro-projects are favoured increasingly to the expense of the macro-projects) The aim is to encourage the emergence of local projects which would otherwise lack the contacts or budget needed to take part in the main democracy programme. In short, micro-projects are not required to work with a European partner. Grants can cover up to 90% of the budget. Amounts allocated can range from between 3,000 and 10,000 Ecu. Partnership and Institution Building Programme

Objectives:

Objectives:

To develop the capacities of youth workers and to encourage non-governmental bodies to act and cooperate on a European level. It aims to encourage young people to view the European Community as a part of their historical, political, cultural and social environment by enabling them to take an active role in the organization of a variety of activities.

There are 4 main Actions:

A: Intra-community activities

i) Youth exchanges and mobility grants lasting from six days to three weeks. For young people between 15-25 years of age. Priority will be given to groups from disadvantaged backgrounds.

This action also includes support for voluntary service. Such projects must be of a transnational nature, involving voluntary service in other Member States lasting between a month and a year. Associations in the field of heritage, environment and social activities are given priority, especially in countries with little tradition of voluntary service.

B: Youth workers and training

Support is available for partner-finding, preparation of exchange and co-operation projects, and training projects focusing on intercultural learning and linguistic preparation projects. Projects can involve study visits, seminars, and placements.

C: Creation of partnerships and networks between youth structures of EU Member States

These can be at either a transnational, inter-regional or translocal dimension. Priority again, will be given to under-developed areas.

D: Exchanges with non-Member States

Support for multilateral youth exchanges that

involve at least two Member States. Eligible projects include study visits, training courses, practical experiences, and youth exchanges of six to twenty-one days.

E: Information for young people and research

This action involves the dissemination of information, aimed at providing opportunities for networking, rationalising and operating data banks relating to young people for young people. This can take place either on a centralised basis, whereby applications must be submitted directly to the Commission, or on a decentralised basis, where the project involves local youth groups and for which application must be made directly to the National Agencies.

The programme began in 1995 and will last till 1999 included. Deadline is usually around mid June.
