EXPLANATORY MEMORANDUM

At its request, the Commission was informed by all the Member States that they no longer saw any value in the application of Regulation (EEC) No 353/79 laying down the conditions for coupage and wine-making in the free zones or that they have never carried out operations covered by that Regulation. With a view to simplifying the regulations in the wine sector, that Regulation should accordingly be repealed.

This Regulation has no impact on the Community budget, nor on the SME or employment.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 822/87 of 16 March 1987 on the common organization of the market in wine (1), as last amended by Regulation (EEC) No 1236/89 (2), and in particular Article 70(3) thereof,

Whereas Council Regulation (EEC) No 353/79 of 5 February 1979 laying down the conditions for coupage and wine-making in the free zones on Community territory for wine products originating in third countries (3) is no longer of practical value; whereas it should therefore be repealed,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 353/79 is hereby repealed.

Article 2

This Regulation shall enter into force on 1 November 1989.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
