Proposal for a COUNCIL REGULATION (EEC)

increasing the volume of the Community tariff quotas
opened for 1989 for polyvinyl butyral and magnetrons

(presented by the Commission)

EXPLANATORY MEMORANDUM

1. Council Regulations (EEC) Nos 3984/88 of 19 December 1988 (1) and 1878/89 of 21 June 1989 (2) opened for 1989 or for the 2nd semester only Community tariff quotas at zero duty for polyvinyl butyral and magnetrons, which provisional volumes have been fixed respectively at 1 500 tonnes and 600 000 pieces.
2. Subsequent to requests presented by the German and Benelux authorities, the Commission Services have examined in conjunction with national experts the possibility of increasing the volume of these tariff quotas.

This examination has shown that the requested increases can be accepted by all the Member States without prejudice to the Community markets of these products.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,
and in particular Article 28 thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulations (EEC) Nos 3984/88 of 19 December 1988 (1)
and 1878/89 of 21 June 1989 (2) opened for 1989, or for the second semester
only, Community tariff quotas at zero duty for polyvinyl butyral and
magnetrons, which volumes have provisionally been fixed respectively at
1 500 tonnes and 600 000 pieces; that on the basis of the data currently available,
it seems that these volumes will be insufficient to cover the
needs of the Community until 31 December 1989 and that it is in the
interest of the Community to allow the providing of the customer industry
with favourable conditions; that it is appropriate to modify the above-
mentioned regulations with a view to increasing the volumes of the tariff
quotas to the levels of real needs that have been ascertained.

HAS ADOPTED THIS REGULATION:

Article 1

The volume of the Community tariff quota opened by Regulation (EEC) No
3984/88 for polyvinyl butyral in the form of powder, for the production
of film for laminated safety glass, shall be increased from 1 500 tonnes
to 4 000 tonnes.

Article 2

The volume of the Community tariff quota opened by Regulation (EEC) No
1878/89 for magnetrons with a power output of less than 1 000 W, for the
manufacture of microware ovens, shall be increased from 600 000 pieces to
1 000 000 pieces.

Article 3

This Regulation shall enter into force on the seventh day following its
publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable
in all Member States.
