1. RECITALS

Amendment No. 1

New recital after existing 2nd recital :

"Whereas this Decision shall apply *inter alia* to every type of small and medium-sized enterprise, including craft undertakings, cooperatives and enterprises involving employee share ownership."

Amendment No. 2

4th recital, to read as follows :

"Whereas it is necessary to strengthen this enterprise policy in the light of the completion of the Internal Market and the other reforms resulting from the Single Act, and from the Commission's White Paper of June 1985 (COM(85)310 final)."

2. ARTICLES

Article 4

Add the following paragraph :

"To the extent that new decisions of the Council are necessary, these will be adopted, by qualified majority, on proposal of the Commission, after consultation of the European Parliament and of the Economic and Social Committee."
