EXPLANATORY MEMORANDUM

In the multilateral trade negotiations under the GATT which started in 1986, following the Ministerial Declaration adopted at Punta del Este, the Tropical Products sector was identified as a priority sector. This priority applied to both the timing of the negotiations and the implementation of the results.

The Community's commitment to this objective was demonstrated by it being the first developed country to submit a detailed offer in October 1987 an example which was not followed until much later by the other participants. However, as the Mid-term Review in Montreal approached other participants, both developed and developing, tabled their proposals. In November 1988 the Commission sent to the Council a proposal which elaborated the Community's position on Tropical Products. It consisted of four elements:

a special action in favour of the least-developed developing countries:

tariff reductions on a selected list of tropical products;

elimination of certain quantitative restrictions on tropical products applied by Member States;

invitation to Member States applying excise duties on tropical beverages to indicate their intentions, if possible, on their eventual reduction or elimination;

The Council gave its agreement to the Commission proposal and at Montreal accepted that further small modifications were necessary in order to reach a result in the negotiations that was acceptable to all parties. The Community's contribution provides for tariff concessions on trade amounting to more than 10 bn Ecu, the elimination of certain national quantitative restrictions and a number of specific measures in favour of the LLDCs. The aim of this proposal for a Council Regulation is to put into effect the elimination of certain quantitative restrictions on tropical products applied by Member States.

THE COUNCIL OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas the multilateral trade negotiations under the GATT opened pursuant to the Ministerial Declaration adopted at Punta del Este on 20 September 1986 resulted in an interim result in the Tropical Products Negotiating Group at the Montreal Mid-term Review in December 1988:

Whereas the Community's contribution to this result on Tropical products consists of three elements: first, a significant number of tariff reductions on a mfn basis, secondly, the elimination of a number of quantitative restrictions on tropical products applied by Member States and finally a series of concessions for least-developed developing countries that would ensure duty free access for practically all tropical products as well as improved access where necessary for tropical roots and rice;

Whereas the Community has found the concessions made by other countries participating in the negotiations constitute an acceptable result;

Whereas the Punta del Este Ministerial Declaration provides for the early implementation of results obtained in the area of Tropical Products and the Community has found it necessary, therefore, to implement its contribution on Tropical Products on an autonomous basis, pending the end of the current round of muitilateral trade negotiations;

Whereas it is now necessary to delete those quantitative restrictions on tropical products, set out in the Community's contribution to the result obtained at the Montreal Mid-term Review, from Annex I of Regulation (EEC) N° 288/82;

HAS ADOPTED THIS REGULATION:

Article 1

- 1. The quantitative restrictions on certain products originating in third countries maintained by certain Member States as set out in the Annex shall be abolished from 1 July 1989.
- 2. The products to which these quantitative restrictions apply shall be deleted from Annex I of Regulation N $^{\circ}$ 288/82.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply with effect from the 1 July 1989.

This Regulation shall be binding in its entirety and directly applicable in all Member States concerned.


