COUNCIL REGULATION (EC)

**amending Regulation (EC) 1416/95 establishing certain concessions in the form of
Community tariff quotas in 1995 for certain processed agricultural products**

(presented by the Commission)

Explanatory memorandum

1. Pursuant to Articles 76, 102 and 128 of the Act of Accession, Austria, Finland and Switzerland must apply, with effect from 1 January 1995, the provisions of the preferential agreements concluded by the Community with certain third countries (Switzerland and Norway), it being understood that all the amendments required as a result of enlargement will be the subject of additional protocols to be negotiated with the third countries in question.

However, the above Articles stipulate that if the protocols are not concluded by 1 January 1995, the Community must take the necessary steps to regulate the situation.

2. It is therefore necessary to apply autonomous transitional measures so as to take account of the trade arrangements for processed agricultural products which existed between the new Member States and the third countries in question.

These measures were adopted by the Council (Regulation (EC) No 1416/95) subject to the express condition that the third countries concerned also take reciprocal autonomous measures.

3. As it is not possible to conclude an additional protocol before 1 January 1996, it will be necessary to extend the measures adopted for 1995 to cover 1996.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the Act of Accession of Austria, Finland and Sweden,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EC) No 1416/95 establishing certain concessions in the form of Community tariff quotas in 1995 for certain processed agricultural products¹ opened tariff quotas for 1995 in favour of Switzerland in accordance with the conditions set out in Annex I thereto;

Whereas it is not possible to conclude an additional protocol before 1 January 1996; whereas, therefore, it is necessary to extend the measures provided for in Annex I to Regulation (EC) No 1416/95 to cover 1996,

HAS ADOPTED THIS REGULATION:

Article 1

The measures provided for in Annex I to Regulation (EC) No 1416/95 shall be extended to cover 1996.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply with effect from 1 January 1996.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
