COUNCIL REGULATION (EC)

amending Council Regulation No 2178/95 opening and providing for the administration of Community tariff quotas and ceilings for certain industrial and fishery products originating in Estonia, Latvia and Lithuania, and establishing the detailed provisions for adapting these quotas and ceilings, and Regulation (EC) No 1798/94 opening and providing for the administration of Community tariff quotas for certain agricultural products originating in Bulgaria, the Czech Republic, Hungary, Poland, Romania and Slovakia, and establishing the detailed provisions for adapting these quotas (1994-97)

(presented by the Commission)

EXPLANATORY MEMORANDUM

1. On 19 June 1995 the Council adopted negotiating directives for the adjustment of the Europe Agreements and free trade agreements following enlargement of the European Union.

Part of this mandate relates to textiles, stipulating that existing preferential trade arrangements between Sweden and Lithuania and Latvia, on the one hand, and between Finland and Lithuania and Latvia, on the other, will be added to the existing tariff ceilings.

The mandate also concerns fishery products: it was decided that a number of zero-duty tariff quotas for fishery products would be opened for Poland, Estonia, Latvia and Lithuania to take account of the preferential trade arrangements between those countries and the new Member States.

2. Regulation (EC) No 1275/95 provides for certain procedures for applying the Agreement on free trade and trade-related measures the European Community, the European Atomic Energy Community and the European Coal and Steel Community, of the one part, and the Republic of Estonia, of the other part.

To apply those provisions, Community tariff quotas should therefore be opened for potatoes as set out in Annex V to this Agreement.

3. For Bulgaria and Romania, the Commission has opened tariff quotas for preserved mushrooms falling under CN codes 0711 90 40, 2003 10 20 and 2003 10 30 (Regulation (EC) No 2125/95) on the adjustments and transitional arrangements in the agricultural sector in order to implement the agreement concluded during the Uruguay Round of multilateral commercial negotiations provided for in Council Regulation (EC) No 3290/94.

The tariff quotas with order numbers 09.6115 and 09.6239 (mushrooms of CN codes 0711 90 40, 2003 10 20 and 2003 10 30) opened by Council Regulation (EC) No 1798/94 to apply the preferences provided for in the Europe Agreements with Bulgaria and Romania should therefore be eliminated.

Similarly, the second additional protocols to the Europe Agreement between the European Community, of the one part, and Bulgaria and Romania, of the other part, provide that the opening of the zero-rate tariff quotas provided for in Annex III to Regulation (EC) No 1798/94 for the period 1 July 1996 to 30 June 1997 be brought forward to the period 1 July 1995 to 30 June 1996.

4. Council Regulation (EC) No 2179/95, provided the autonomous and transitional adjustment of certain agricultural concessions laid down by European agreements. These concessions must be extendible to the products figuring at annexes II and III of Regulation (EC) No 1798/94.
5. It is, therefore, time to proceed to the modifications proposed by this Council Regulation.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the Treaty of Accession of Austria, Finland and Sweden,

Having regard to the proposal from the Commission,

Whereas the existing preferential agreements between the European Community, of the one part, and Poland, Estonia, Latvia and Lithuania, of the other part, (hereinafter referred to as "third countries") provide that certain goods originating in those countries may, within the limits of tariff quotas or ceilings, attract a reduced or zero rate of duty on import into the Community;

Whereas, following the accession of Austria, Finland and Sweden, these concessions should be adapted in particular to take account of trade in fishery and textile products existing between Austria, Finland and Sweden, of the one part, and Poland, Estonia, Latvia and Lithuania of the other part;

Whereas, to that end, exploratory talks are under way with these third countries with a view to concluding additional protocols to the aforementioned agreements;

Whereas, however, as the deadlines were too short, those additional protocols could not come into effect on 1 January 1995;

Whereas, therefore, and in accordance with Articles 76, 102 and 128 of the 1994 Act of Accession, the Community should adopt the necessary measures to remedy this situation; whereas the measures should take the form of autonomous Community tariff quotas and tariff ceilings which include the contractual preferential duty concessions granted by Austria, Finland and Sweden;

Whereas pursuant to Regulation (EC) No 1275/95¹, the Council introduced certain procedures for applying the Agreement on free trade and trade-related matters between the European Community, the European Atomic Energy Community and the European Coal and Steel Community, of the one part, and the Republic of Estonia, of the other part; whereas it is necessary, therefore, pursuant to Article 13 (2) and (3) of that Agreement to open Community tariff quotas for certain agricultural products asset out in Annex V;

Whereas pursuant to Regulation (EC) No 2125/95², the Commission opened tariff quotas for preserved mushrooms falling under CN codes 0711 90 40, 2003 10 20 and 2003 10 30 on the adjustments and transitional arrangements in the agricultural sector in order to implement the agreements concluded during the Uruguay Round of multilateral commercial negotiations provided for in Council Regulation (EC) No 3290/94³; whereas, to put this into effect, the tariff quotas with order numbers 09.6115 and 09.6239 (mushrooms of CN codes 0711 90 40, 2003 10 20 and 2003 10 30) opened by Council Regulation (EC) No 1798/94⁴ applying the preferences provided for in the Europe Agreements with Bulgaria and Romania should be eliminated;

Whereas the second additional protocols to the Europe Agreements between the European Community, of the one part, and Bulgaria and Romania, of the other part, provide that the opening of the zero-rate tariff quotas provided for in Annex III to Regulation (EC) No 1798/94 for the period 1 July 1996 to 30 June 1997 be brought forward to the period 1 July 1995 to 30 June 1996;

Whereas Council Regulation (EC) No 2179/95⁵ provided the autonomous and transitional adjustment of certain agricultural concessions laid down by European agreements. These concessions must be extendible to the products figuring at annexes II and III of Regulation (EC) No 1798/94.

Whereas Regulations (EC) Nos 2178/95⁶ and 1798/94 should therefore be amended with effect from 1 January 1995,

HAS ADOPTED THIS REGULATION:

Article 1

1. Article 1 of Regulation (EC) No 2178/95 shall be amended as follows:

- for "Annexes I, II, III and IV" read "Annexes I to VIII".

2. The table in Annex I shall replace the table in Annex IV to Regulation (EC) No 2178/95, and the tables in Annexes II, III, IV and V shall be added as Annexes V, VI, VII and VIII to Regulation (EC) No 2178/95.

Article 2

1. Article 1 of Regulation (EC) No 1798/94 shall be amended as follows:

"The goods originating in Bulgaria, Hungary, Poland, Romania, Slovakia and the Czech Republic, listed at annexes I, II, III and IV of the present regulation, benefiting from the tariff preferences in the framework of the Community's tariff quotas according to the provisions contained in the aforementioned annexes, without prejudice to Regulation (EC) No 2179/95."

2. The quotas corresponding to order numbers 09.6115 and 09.6239 shall be deleted in Annexes II and III to Regulation (EC) No 1798/94.

3. The references to Bulgaria and Romania in Annex II shall be deleted.

4. In Annex III to Regulation (EC) No 1798/94, for "1996 to 30 June 1997" read "1995 to 30 June 1996".

5. The table in Annex VI shall be appended to Regulation (EC) No 1798/94 as Annex IV.

Article 3

This Regulation shall enter into force on the day following its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 January 1996.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
