EXPLANATORY MEMORANDUM

The aim of the double-checking system is to improve transparency and to avoid possible diversions of trade. It is founded on the provision in the EC-Slovak Republic Europe Agreement¹ which allows either Party to introduce an administrative procedure having as its purpose the rapid provision of information on the trend of trade flows. The Parties agreed to establish such a system in 1996 in respect of certain ECSC and EC steel products by means of Association Council Decision N° 2/95². Council Regulation (EC) N° 3054/95³ established the corresponding implementing legislation for the Community.

At its meeting on 7 October 1996, the Contact Group agreed to recommend that the Association Council should extend the double-checking system, with certain amendments, for the period between 1 January and 31 December 1997.

The attached proposals consequently seek to extend Association Council Decision N° 2/95 and Council Regulation (EC) N° 3054/95, with certain amendments, for the period between 1 January and 31 December 1997.

In view of the time which these procedures could take, the Contact Group also agreed, if necessary, to extend the double-checking system on a temporary basis by means of autonomous measures, pending the entry into force of the Association Council Decision and of the implementing legislation.

The Council of the European Union,

Having regard to the Treaty establishing the European Community, and in particular Article 113 together with Article 228, para 2, first sentence,

Having regard to the proposal from the Commission,

Having regard to the Decision of the Council and the Commission of 19 December 1994 on the conclusion of the Europe Agreement between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part, and in particular Article 2(1) thereof,

Whereas the Contact Group referred to in Article 10 of Protocol 2 of the Europe Agreement between the European Communities and their Member States of the one part and the Slovak Republic of the other part, which entered into force on 1 February 1995¹, met on 7 October 1996 to discuss trends in imports of ECSC and EC products from the Slovak Republic into the Community and recognised the need to find appropriate solutions in the framework of Article 34.2 of the Agreement in order to ensure that the attainment of the objectives of the Agreement will not be jeopardised;

Whereas the Contact Group therefore agreed to recommend to the Association Council established under Article 104 of the Agreement that the double-checking system introduced in 1996 by Association Council Decision N° 2/95² should be renewed for the period between 1 January and 31 December 1997;

Whereas the Parties are desirous to promote the orderly and equitable development of trade in steel between the Community and the Slovak Republic;

Whereas the Association Council, having been supplied with all relevant information, has determined that the solution acceptable to the two parties which least disturbs the functioning of the Agreement is the renewal of the double-checking system, without quantitative limits, for the import into the Community of certain steel products covered by the ECSC and EC Treaties between 1 January and 31 December 1997,

HAS DECIDED AS FOLLOWS:

The position to be taken by the Community within the Association Council established by the Europe Agreement between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part, concerning the export of certain steel products from the Slovak Republic to the European Communities, and in particular the renewal of the double-checking system, shall be based on the draft decision of the Association Council annexed to this Decision.

THE ASSOCIATION COUNCIL

Whereas the Contact Group referred to in Article 10 of Protocol 2 of the Europe Agreement establishing an association between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part, which entered into force on 1 February 1995¹, met on 7 October 1996 and agreed to recommend to the Association Council established under Article 104 of the Agreement that the double-checking system introduced in 1996 by Association Council Decision N° 2/95² should be extended for the period between 1 January and 31 December 1997 subject to certain amendments;

Whereas the Association Council, having been supplied with all relevant information, has agreed with this recommendation,

HAS DECIDED AS FOLLOWS:

Article 1

The double-checking system established by Association Council Decision N° 2/95 for the period 1 January to 31 December 1996 shall continue to apply for the period between 1 January and 31 December 1997, subject to the amendments to that Decision shown in Article 2. In the Preamble and Article 1 (1) and (3) of the Decision, references to the period 1 January to 31 December 1996 are hereby replaced by the words "1 January to 31 December 1997". Article 1 (4) shall be deleted.

Article 2

1. In Article 2 of the Decision, the first sentence of paragraph 2 shall be amended to read as follows:

"The Community undertakes to supply the Slovak authorities with precise statistical information on import documents issued by Member States in respect of the export documents issued by the Slovak authorities pursuant to Article 1."

- 2. Annex I shall be replaced by the text contained in the Annex to this Decision.
- 3. In Annex III, the following change shall be made: delete "Export Licence" and insert "Export Document".
- 4. In Annex IV, paragraph 3 shall be deleted.

Article 3

This Decision shall enter into force on the date of signature.

It shall apply with effect from 1 January 1997.

COUNCIL REGULATION (EC) No/96

concerning the export of certain ECSC and EC steel products from the Slovak Republic to the European Communities for the period 1 January to 31 December 1997 (extension of the double-checking system)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas a Europe Agreement establishing an association between the European Communities and their Member States, of, the one part, and the Slovak Republic, of the other part, entered into force on 1 February 1995;

Whereas the Parties decided in Association Council Decision N°/96² to extend the double-checking system introduced by Decision N° 2/95³ for the period between 1 January and 31 December 1997 subject to certain amendments;

Whereas it is consequently necessary to extend the Community implementing legislation introduced by Council Regulation (EC) N° 3054/95⁴,

HAS ADOPTED THIS REGULATION:

Article 1

Council Regulation (EC) N° 3054/95 shall continue to apply for the period between 1 January and 31 December 1997, in accordance with the provisions of Association Council Decision N°/96 between the European Communities and their Member States, of, the one part, and the Slovak Republic, of the other part, subject to the amendments to that Regulation shown in Article 2. In the Preamble and Article 1 (1) and (3) of the Regulation, references to the period 1 January to 31 December 1996 are hereby replaced by 1 January to 31 December 1997. Article 1 (4) shall be deleted.

Article 2

- 1. Annex III shall be replaced by the text contained in the Annex to this Regulation.
- 2. In Annex IV, the following change shall be made: delete "Export Licence" and insert "Export Document".

Article 3

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply with effect from 1 January 1997.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
