amending Regulation (EC) No 2505/96 opening and providing for the administration of autonomous Community tariff quotas for certain agricultural and industrial products

EXPLANATORY MEMORANDUM

- 1. In response to requests from several Member States, the Commission's departments, together with the government experts concerned, considered whether to open, increase and extend autonomous tariff quotas for certain industrial products.
- 2. Following the discussion, at a meeting of the Economic Tariff Questions Group, it was concluded that the Member States could approve new quotas, increases or extensions to quotas for the products covered by the proposal for a Regulation, without disturbing the markets for such products.

Hence the attached proposal for a Regulation.

COUNCIL REGULATION (EC) No/98

amending Regulation (EC) No 2505/96 opening and providing for the administration of autonomous Community tariff quotas for certain agricultural and industrial products

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 28 thereof,

Having regard to the proposal from the Commission,

Whereas, by virtue of Regulation (EC) No 2505/96¹, the Council opened Community tariff quotas for certain agricultural and industrial products; whereas Community demand for the products in question should be met under the most favourable conditions; whereas Community tariff quotas should therefore be opened at reduced or zero rates of duty for appropriate volumes, and increased or extended in the case of certain existing tariff quotas, avoiding any disturbance to the markets for these products;

Whereas Regulation (EC) No 2505/96 should therefore be amended,

HAS ADOPTED THIS REGULATION:

Article 1

- 1. For the quota period from 1 January to 30 June 1998, Annex I to Regulation (EC) No 2505/96 is hereby amended as follows:
 - order number 09.2935: the amount of the tariff quota shall be altered to 70,000 tonnes,
 - order number 09.2967: the amount of the tariff quota shall be altered to 3,000,000 units.
- 2. For the quota period from 1 January to 31 December 1998, Annex I to Regulation (EC) No 2505/96 is hereby amended as follows:
 - order number 09.2947: the amount of the tariff quota shall be altered to 1,300 tonnes,
 - order number 09.2959: the amount of the tariff quota shall be altered to 45,000 tonnes.
 - order number 09.2963: the amount of the tariff quota shall be altered to 500,000,000 units.

Article 2

The quota period for tariff quota with order number 09.2965 in Annex I to Regulation (EC) No 2505/96 is amended in 1.1.-31.12.1998.

Article 3

The tariff quotas shown in the Annex to this Regulation shall be added to Annex I to Regulation (EC) No 2505/96.

Article 4

This Regulation shall enter into force on the seventh day following that of its publication in the Official Journal of the European Communities.

Articles 1 and 2 shall apply with effect from 1 January 1998, Article 3 with effect from 1 July 1998.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
