By letter of 4 October 1990, the Council consulted the European Parliament on the proposal for a Council regulation on financial assistance for the countries most immediately affected by the Gulf crisis.

At the sitting of 8 October 1990 the President of Parliament announced that he had referred this proposal to the Political Affairs Committee as the committee responsible and to the Committee on Budgets, the Committee on External Economic Relations and the Committee on Development and Cooperation for their opinions.

At its meeting of 15 October 1990 the committee appointed Mr Crampton rapporteur.

At its meeting of 15 October, 24 October, 7 November and 21 November 1990, it examined the Commission proposal and draft report.

At the latter meeting it adopted the draft legislative resolution unopposed with three abstentions.

The following took part in the vote: Crampton, first vice-chairman, acting chairman and rapporteur; Defraigne and van den Brink, vice-chairmen, Baget-Bozzo, Bertens (for Capucho), Cassanmagnago Cerretti, Coates, Lacaze, Langer, Metten (for Cheysson), Moorhouse (for Lord Bethell), Newens (for Balfe), Newton Dunn, Paisley, Perschau (for Habsburg), Pesmazoglou, Pirkl, Robles Piquer, Saby (for Dury), Stavrou (for Ferrer), Vecchi (for Castellina) and White.

The explanatory statement will be presented orally in plenary sitting.

The opinion of the Committee on Budgets, the Committee on External Economic Relations and the Committee on Development and Cooperation will be published separately.

The report was tabled on 21 November 1990.

The deadline for tabling amendments will be announced by the President in plenary sitting.

However, the financial provisions of this Regulation cannot be implemented until the budget for the financial year 1991 and the budget estimates have been duly amended by the appropriate procedure in each instance.

#### DRAFT LEGISLATIVE RESOLUTION

embodying the opinion of the European Parliament on the proposal from the Commission to the Council concerning a proposal for a regulation on financial assistance for the countries most immediately affected by the Gulf crisis

#### The European Parliament,

- having regard to the proposal from the Commission to the Council (SEC(90) 1862 final)<sup>1</sup>,
- having been consulted by the Council pursuant to Article 235 of the Treaty (C3-0313/90),
- having regard to the report of the Political Affairs Committee and the opinions of the Committee on Budgets, the Committee on External Economic Relations and the Committee on Development and Cooperation (A3-0321/90),
- 1. Approves the Commission proposal subject to Parliament's amendments and in accordance with the vote thereon;
- 2. Calls on the Council to notify Parliament should it intend to depart from the text approved by Parliament;
- 3. Calls for the conciliation procedure to be opened if the Council should intend to depart from the text approved by Parliament;
- 4. Asks to be consulted again should the Council intend to make substantial modifications to the Commission proposal;
- 5. Instructs its President to forward this resolution to the Council and Commission.
