B. EXPLANATORY STATEMENT	9

At its sitting of 10 October 1990 the European Parliament delivered its opinion at first reading on the proposals from the Commission to the Council with a view to the adoption of a decision on the conclusion of Cooperation Agreements between the European Economic Community on the one hand and the Republic of Austria, the Republic of Finland, the Kingdom of Norway, the Kingdom of Sweden and the Swiss confederation on the other on a European Stimulation Plan for Economic Science (SPES).

At the sitting of 12 December 1990 the President of Parliament announced that he had received the common positions of the Council and had referred them to the Committee on Energy, Research and Technology as the committee responsible and to the Committee on Budgets, the Committee on Economic and Monetary Affairs and Industrial Policy and the Committee on External Economic Relations for their opinions.

At its meeting of 19/20 December 1990 the committee considered the common positions and the draft recommendation.

At that meeting the committee adopted the recommendation unanimously.

The following were present for the vote: La Pergola, chairman and rapporteur; Sälzer and Adam, vice-chairmen; Bettini, Carvalho Cardoso (for Rinsche), Chiabrando, Desama, Falqui (for Anger), Gasoliba I Böhm, Görlach (for Linkohr), Hervé, Pierros, Porrazzini, Regge, Robles Piquer, Samland (for Schinzel), Sanz Fernandez, Schlee, Seligman and West.

This recommendation was tabled on 19 December 1990.

The deadline for tabling amendments to the common position or proposals to reject it will appear on the draft agenda for the part-session at which the recommendation is to be considered.
