B. EXPLANATORY STATEMENT	7

At its sitting of 10 October 1990 the European Parliament delivered its opinion at first reading on the Commission proposals for Council decisions on:

- the conclusion of the Cooperation Agreement between the European Economic Community and the Republic of Finland on a research and development programme for the European Economic Community in the field of applied metrology and chemical analysis (BCR);
- the conclusion of the Cooperation Agreement between the European Economic Community and the Kingdom of Sweden on a research and development programme for the European Economic Community in the field of applied metrology and chemical analysis (BCR);
- the conclusion of the Cooperation Agreement between the European Economic Community and the Swiss Confederation on a research and development programme for the European Economic Community in the field of applied metrology and chemical analysis (BCR).

At its sitting of 12 December 1990 the President of Parliament announced that the common positions had been received and referred to the Committee on Energy, Research and Technology as the committee responsible and to the Committee on Economic and Monetary Affairs and Industrial Policy, the Committee on External Economic Relations, the Committee on Budgets and the Committee on the Environment, Public Health and Consumer Protection for their opinions.

At its meeting of 19 and 20 December 1990 the Committee on Energy, Research and Technology considered the common positions and the draft recommendations.

At the latter meeting it adopted the following recommendations unanimously.

The following were present at the vote: La Pergola, chairman and rapporteur; Sälzer, first vice-chairman; Adam, third vice-chairman; Anger, Bettini, Carvalho Cardoso (for Quisthoudt-Rowohl), Chiabrando, Desama, Falqui (for Breyer), Gasòliba I Böhm, Görlach (for Ford), Hervé, Porrazzini, Regge, Robles Piquer, Sanz Fernández, Samland (for Schinzel), Schlee, Seligman and West.

The recommendations were tabled on 19 December 1990.

The deadline for tabling amendments to the common positions or proposals to reject them will appear on the draft agenda for the part-sessions at which the recommendations are to be considered.

EXPLANATORY STATEMENT

The European Parliament considered the Commission proposal at first reading. Having considered the common position, and found that it does not differ substantially from the original proposal, Parliament may approve the common position without amendment.
