Proposal for a

COUNCIL DECISION

concerning the Community's position with respect
to the duties applied by the Slovak Republic to imports
of processed agricultural goods originating
in the Community

(presented by the Commission)

Explanatory memorandum

According to Article 4 of Protocol 3 of the Europe Agreement, the Slovak Republic shall determine the agricultural component of the levy on the goods referred to in the Annex to that Protocol. Elimination of the non-agricultural component of the levy must be completed by 1 January 1998 at the latest.

The Slovak Republic has submitted to the Commission a proposal providing for a timetable for the reduction of the non-agricultural component from 1995 to 1998. This proposal has now to be endorsed by the Association Council.

Proposal for a Council Decision concerning the Community's position with respect to the duties applied by the Slovak Republic to imports of processed agricultural goods originating in the Community

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, in particular Article 113 thereof,

Having regard to Decision of the Council and the Commission of 19 December 1994 concerning the conclusion of a Europe Agreement establishing an association between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part¹, and in particular to Article 2(1) thereof,

Having regard to the proposal of the Commission,

Whereas the Europe Agreement establishing an association between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part, in particular Article 6(1) of Protocol 3, stipulates that for processed agricultural products not covered by Annex II to the EC Treaty and listed in Table 2 to the Annex to Protocol 3 the Slovak Republic will notify the agricultural element calculated for imports from the Community, and that the Association Council will decide on the duties to be applied,

DECIDES:

The attached Draft for a Decision of the Association Council sets out the Community's position and shall be presented to the Association Council.

DECISION NO 196 OF THE ASSOCIATION COUNCIL

concerning the duties applied by the Slovak Republic to imports of processed agricultural goods originating in the Community

THE ASSOCIATION COUNCIL,

having regard to the Europe Agreement establishing an association between the European Communities and their Member States, of the one part, and the Slovak Republic, of the other part¹, and in particular to Article 6(1) of Protocol 3 on trade between the Slovak Republic and the Community in agricultural products not covered by Annex II to the EC Treaty,

whereas under the provisions of Protocol 3 the Slovak Republic has undertaken to determine both the agricultural part and the non-agricultural part of the levies applied on import from the Community to the goods covered by that Protocol, and to reduce the non-agricultural part in accordance with the timetable set out in Table 2 of the Annex to that Protocol,

whereas the Slovak Republic has calculated in accordance with Articles 1 and 2 of Protocol 3 the agricultural components which will, in accordance with the timetable referred to in Article 5(2) of that Protocol, replace the current levies,

DECIDES:

Article 1

The duties applicable on import into the Slovak Republic to processed agricultural products listed in Protocol 3 on trade between the Slovak Republic and the Community in agricultural products not covered by Annex II to the EC Treaty and originating in the Community are set out in the Annex to this decision.
