EXPLANATORY MEMORANDUM

1. The transitional period laid down in the Treaty of Accession for the application of national anti-dumping/anti-subsidies measures by the United Kingdom and Ireland expires on 30 June 1977.
  
2. Both countries have adopted a number of such measures, some very recently, as permitted by Article 133 of the Treaty of Accession.
  
3. If the spirit of the Community regulations suggests that such measures should be reviewed, the precise means of re-examining them are not, however, clearly defined.
  
4. To fill this gap, the Commission is forwarding to the Council the following draft regulation modifying Regulation 459/68.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 113 and 227 thereof,

Having regard to the Regulations establishing the common organisation of agricultural markets and the Regulations adopted under Article 235 of the Treaty, applicable to goods manufactured from agricultural products, and in particular the provisions of those Regulations which allow for derogation from the general principle that protective measures at frontiers may be replaced solely by the measures provided for in those Regulations,

Having regard to the proposal from the Commission;

Whereas the transitional period provided for in Article 133 of the Treaty of Accession for the introduction by the United Kingdom and Ireland of national measures against dumping or the granting of bounties or subsidies by third countries expires on 30 June 1977;

Whereas it will be necessary to review such national measures as are in operation on 30 June 1977 in order to examine their effects after that date and to ascertain whether the conditions for their application are satisfied;

Whereas accordingly it is now necessary to extend to such national measures the provisions with respect to the amendment or revocation of anti-dumping measures set out in Article 18(2) of Regulation (EEC) 459/68 on protection against dumping or the granting of bounties or subsidies by third countries (1) as amended by Regulation (EEC) 2011/73 (2);

HAS ADOPTED THIS REGULATION:

Article 1

The following shall be substituted for Article 18(2)(a) of Regulation (EEC) 459/68:

"Where measures are enforced under Article 15 and the Council has taken no action under Article 16 or under Article 17, or where measures have been taken under the transitional provisions of the Treaty of Accession, the Commission shall itself forthwith amend, or revoke with or without retro-active effect, measures in force under Article 15 or introduced under the transitional provisions of the Accession Treaty and shall immediately report on this to the Council; the latter may, acting by a qualified majority, decide that different action be taken."

Article 2

This Regulation shall enter into force on 1 July 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
