At its sitting of 11 March 1992 the European Parliament delivered its opinion at first reading on the Commission proposal for a Council decision concerning the conclusion of a cooperation agreement between the European Community and the Kingdom of Sweden on a research and technological development programme in the fields of renewable raw materials: forestry and wood products (including cork) (FOREST) and the recycling of waste (REWARD (1990-1992)).

At the sitting of 15 May 1992 the President of Parliament announced that the common position had been received and referred to the Committee on Energy, Research and Technology as the committee responsible and to the Committee on Budgets and the Committee on External Economic Relations for their opinions.

At its meeting of 21 January 1992 the Committee on Energy, Research and Technology had appointed Mr Desama rapporteur.

At its meeting of 18/19 May 1992 it considered the common position and the draft recommendation.

At that meeting it adopted this recommendation unanimously.

The following were present for the vote: Desama, chairman and rapporteur; Quisthoudt-Rowohl and Adam, vice-chairmen; Bettini, Caudron (for Ford), Delcroix (for West), Garcia Arias, Lannoye, Mayer, Pierros (for Robles Piquer), Pompidou, Regge and Sanz Fernandez.

The explanatory statement will be presented orally in plenary sitting.

The recommendation was tabled on 20 May 1992.

The deadline for tabling amendments to the common position or proposals to reject it will appear on the draft agenda for the part-session at which the recommendation is to be considered.
