On 29 April 1991 the Council took a decision on supplementary and amending budget No. 1 for the financial year 1991, as amended and modified by Parliament at first reading on 17 April.

At the same meeting it considered and adopted the motion for a resolution as a whole unanimously.

The following were present for the vote: Lamassoure, 1st vice-chairman and rapporteur; Cornelissen, 2nd vice-chairman; Arias Cañete, Blot, Böge, Colom i Naval, Desama, Elles, Goedmakers, Kellett-Bowman, Langes, Marques Mendes, Miranda da Silva, Onur (for Ferri), Pasty, Samland, Theato, Tomlinson, Wynn and Zavvos.

The explanatory statement will be presented orally in plenary sitting.

The report was tabled on 13 May 1991.

The deadline for tabling amendments will be announced by the President in plenary sitting.

The Committee on Budgets hereby submits the following motion for a resolution to the European Parliament:

Α

MOTION FOR A RESOLUTION

on draft supplementary and amending budget No. 1 for the financial year 1991, as amended by the Council

The European Parliament,

- having regard to preliminary draft supplementary and amending budget No. 1/91 (SEC(91) 190 final),
- having regard to draft supplementary and amending budget No. 1/91 (C3-0105/91),
- having regard to the joint decision of to revise the financial perspective,
- having regard to Letter of amendment No. 1 established on 15 April 1991 (C3-0190/91),
- having regard to Letter of amendment No. 2 established on 13 May 1991 (C3-0218/91),
- having regard to the Council's decision on the draft supplementary and amending budget as amended by Parliament (C3-0198/91),
- having regard to the report of the Committee on Budgets (A3-0133/91),
- Draws attention to the dangers of the late presentation of Letter of amendment No. 1 and accordingly considers it to have lapsed, because it is covered by the amendments;
- Confirms its amendments concerning the remarks on the budget headings relating to guaranteed loans in accordance with the statement of the ECOFIN Council of 28 January 1991;
- 3. Reaffirms that Article 203(4) of the EEC Treaty allows Parliament to adopt amendments to the statement of revenue in the budget;
- 4. Considers that Letter of amendment No. 2, established by the Council on 13 May 1991, is in line with the undertakings given by the three Institutions at the trialogue of 2 May 1991 and, in view of the urgent nature of the measures it contains, may be considered a special case under the terms of Article 14 of the Financial Regulation;
- 5. Decides, therefore, to accept it in full;
- 6. Instructs its President to forward this resolution, together with the amendments it has adopted to the draft supplementary and amending budget, to the Council and Commission as the outcome of Parliament's second reading.
