At its sitting of 10 October 1990 (¹) the European Parliament delivered its opinion at first reading on the Commission proposal for a Council directive amending Directive 83/477/EEC on the protection of workers from the risks related to exposure to asbestos at work.

On 24 January 1991 the President of the European Parliament announced that the common position had been received (Doc. C3-0015/91) and referred to the Committee on Social Affairs, Employment and the Working Environment as the committee responsible.

At its meeting of 17 September 1990 the Committee on Social Affairs, Employment and the Working Environment had appointed Lord O'HAGAN rapporteur.

The Committee on Social Affairs, Employment and the Working Environment considered the common position and the draft recommendation at its meetings of 31 January, 27 February and 21 March 1991.

At the last meeting it adopted the following recommendation by 16 votes to 1.

The explanatory statement will be presented orally in plenary sitting.

The recommendation was tabled on 21 March 1991.

The deadline for tabling amendments to the common position or proposals to reject it will appear on the draft agenda for the part-session at which the recommendation is to be considered.

A. RECOMMENDATION

(Cooperation procedure: second reading)

on the common position established by the Council with a view to the adoption of a directive amending directive 83/477/EEC on the protection of workers from the risks related to exposure to asbestos at work (second individual Directive within the meaning of Article 8 of Directive 80/1107/EEC) (COM(90) 184 final (2) and COM(90) 539 final (3)

The Committee on Social Affairs, Employment and the Working Environment

- having regard to the common position of the Council (C3-0015/91 - SYN 256), recommends that the European Parliament amend the common position as follows:

Common position of the Council

Amendments

(Amendment No 1)
ARTICLE 1 (1)
Article 3(3) of Directive 83/477/EEC

- 3. If the assessment referred to in paragraph 2 shows that the concentration of asbestos fibres in the air at the place of work in the absence of any personal protective equipment <u>is</u>, at the option of the Member States, at a level as measured or calculated:
- a) for chrysotile:
- lower than 0.20 fibres per cm3 in relation to an eight-hour reference period and/or
- lower than a cumulative dose of 12,00 fibre-days per cm3 over a three-month period;
- b) for all other forms of asbestos either alone or in mixtures, including mixtures containing chrysotile:

^{3.} If the assessment referred to in paragraph 2 shows that the concentration of asbestos fibres in the air at the place of work in the absence of any personal protective equipment at a level as measured or calculated at the option of the Member States and concentrations of chrysotile in the absence of other forms of asbestos and of all other forms of asbestos either alone or in mixtures, including mixtures containing chrysotile, are inferior to the limit values set out in Article 8. Articles 4, 7, 13, 14(2), 15 and 16 shall not apply.

Amendments

- lower than 0.10 fibres per cm3 in relation to an eight-hour reference period and/or
- lower than a cumulative dose of 6,00 fibre-days per cm3 over a threemonth period,

Articles 4, 7, 13, 14(2), 15 and 16 shall not apply.

(Amendment No 2) ARTICLE 1(2) Article 5 of Directive 83/477/CEE

The application of asbestos by means procedures that involve using lowdensity (less than 1 g/cm3) insulating or soundproofing materials which contain asbestos shall be prohibited.

The use of asbestos shall be of the spraying process and working prohibited except in cases classified as essential by a Commission group of experts.

(Amendment No 3) ARTICLE 1(4) Article 8(a) and (b) of Directive 83/477/EEC

- (a) concentration of chrysotile fibres in the air at the place of work:
- 0.60 fibres per cm3 measured or calculated in relation to an eighthour reference period;
- b) concentration in the air at the place of work of all other forms of asbestos fibres, either alone or in mixtures, including mixtures containing chrysotile:
- 0.30 fibres per cm3 measured or 0.10 fibres per cm3 measured or hour reference period;

- (a) concentration of chrysotile fibres in the air at the place of work:
- 0,25 fibres per cm3 measured or calculated in relation to an eighthour reference period;
- b) concentration of crocidolite. amosite or any form of asbestos other than chrysotile, either alone or in combination in the air at the place of work:
- calculated in relation to an eight- calculated in relation to an eighthour reference period;

Amendments

(Amendment No 4) ARTICLE 2(1), first and second subparagraph

- 1. Member States shall <u>bring into</u>
 <u>force</u> the laws, regulations and
 administrative provisions necessary
 to comply with this Directive <u>not</u>
 <u>later than 1 January 1993.</u>
- They shall forthwith inform the Commission thereof.
- 1. Member States shall <u>adopt</u> the laws, regulations and administrative provisions necessary to comply with this Directive <u>by 31 December 1992 and</u> shall forthwith inform the Commission thereof.

(Amendment No 5)
ARTICLE 2(2a) (new)

2a. The Commission will publish an annual report on the implementation of this Directive in the Member States. This report will be submitted to the European Parliament, for examination and discussion by the Social Affairs Committee which may decide to make a further report to the European Parliament as a whole.
