By letter of 5 November 1990 the Council consulted the European Parliament, pursuant to the Article 235 of the EEC Treaty on European Union, on the Commission proposal for a Council decision on the conclusion of an agreement on trade and commercial and economic cooperation between the European Economic Community and Romania.

At the sitting of 19 November 1990 the President of Parliament announced that he had referred this proposal to the Committee on External Economic Relations as the committee responsible and to the Political Affairs Committee, the Committee on Agriculture, Fisheries and Rural Development, the Committee on Budgets, the Committee on Economic and Monetary Affairs and Industrial Policy, the Committee on Energy, Research and Technology, the Committee on Transport and Tourism, the Committee on the Environment, Public Health and Consumer Protection and the Committee on Youth, Culture, Education, the Media and Sport for their opinions.

At its meeting of 21 February 1990 the Committee on External Economic Relations appointed Mrs AGLIETTA rapporteur.

At its meetings of 26 April 1990, 30 October 1990, 9 January 1991 and 6 February 1991 it considered the draft report.

At the last meeting it adopted the draft legislative resolution by 8 votes to 7, with 3 abstentions.

The following were present for the vote: De Clercq, chairman; Cano Pinto and Moorhouse, vice-chairmen; Aglietta, rapporteur; Chabert, de Vries, da Cunha Oliviera (for Benoit), Hindley, Izquierdo Rojo (for Bird), Junker, Lenz (for Estgen), Miranda de Lage, Neubauer, Peijs, Rossetti, Spencer, Tsimas, Visser (for Titley) and von Wechmar (for Porto).

The opinions of the Political Affairs Committee, the Committee on Agriculture, Fisheries and Rural Development, the Committee on Budgets, the Committee on Economic and Monetary Affairs and Industrial Policy, the Committee on Energy, Research and Technology, the Committee on the Environment, Public Health and Consumer Protection and the Committee on Youth, Culture, Education, the Media and Sport are attached. The Committee on Transport and Tourism decided not to deliver an opinion.

The report was tabled on 7 February 1991.

The deadline for tabling amendments will appear on the draft agenda for the part-session at which the report is to be considered.

DRAFT LEGISLATIVE RESOLUTION

Embodying the opinion of the European Parliament on the Commission proposal for a Council decision on the conclusion by the European Economic Community of an agreement on trade and commercial and economic cooperation between the European Economic Community and the European Atomic Energy Community and Romania

The European Parliament,

- having regard to Articles 113, 235 and 228 of the EEC Treaty,
- having regard to the draft agreement on trade and commercial and economic cooperation initialled by the Commission (SEC(90) 1872 final),
- having been consulted by the Council pursuant to Article 235 of the EEC Treaty and to the procedure under Article 228 of that Treaty (C3-374/90),
- having regard to the report of the Committee on External Economic Relations and the opinions of the Political Affairs Committee, the Committee on Agriculture, Fisheries and Rural Development, the Committee on Budgets, the Committee on Economic and Monetary Affairs and Industrial Policy, the Committee on Energy, Research and Technology, the Committee on the Environment, Public Health and Consumer Protection and the Committee on Youth, Culture, Education, the Media and Sport (A3-0021/91),
- 1. Approves the conclusion and entry into force of the agreement on trade and commercial and economic cooperation between the European Economic Community and Romania, in accordance with international public law and international practice;
- 2. Instructs its President to forward this resolution to the Council and Commission, and to the governments of the Member States and of Romania.
