At it; sitting of 22 November 1990 the European Parliament delivered its opinion at first reading on the Commission proposal for a Council regulation amending Regulation (EEC) No 3/84 introducing arrangements for movement within the Community of goods sent from one Member State for temporary use in one or more other Member States.

At the sitting of 24 January 1991 the President of Parliament announced that the common position had been received and referred to the Committee on Economic and Monetary Affairs and Industrial Policy as the committee responsible.

At its meeting of 29/30 January 1991 the committee considered the common position.

At the latter meeting of 29 January 1991 it adopted the recommendation unanimously.

It was decided to apply the procedure without debate, pursuant to Rule 38(1) of the Rules of Procedure.

The following took part in the vote: Beumer, chairman; Cassidy, rapporteur; Barton, P. Beazley, Bofill Abeilhe, David (for Ford), de Piccoli, de Donnea, Ernst de la Graete, Herman, Hoff, Hoppenstedt, Mattina, Nielsen (for P. Riskaer), Siso Cruellas, Titley (for Seal) and van der Waal.

This recommendation was tabled on 1st February 1991.

The deadline for tabling amendments to the common position or proposals to reject it will appear on the draft agenda for the part-session at which the recommendation is to be considered.

RECOMMENDATION

(Cooperative procedure: second reading)

on the common position established by the Council with a view to the adoption of a regulation amending Regulation (EEC) No 3/84 introducing arrangements for movement within the Community of goods sent from one Member State for temporary use in one or more other Member States (COM(90) 354 final¹)

The Committee on Economic and Monetary Affairs and Industrial Policy,

- having regard to the common position of the Council (C3-0019/91 - SYN 283), Recommends that the European Parliament approve the common position.

B EXPLANATORY STATEMENT

The common position is to be approved of. It provides for a simplification of controls notably in the interests of museums and artists as well as for the repeal of the regulation at the date of completion of the internal market.
