At its meeting of 10 September 1990 the Temporary Committee to consider the Impact of the Process of German Unification on the European Community appointed Mr Donnelly rapporteur.

The committee responsible considered the Commission proposals and the draft report at its meeting of 4 and 5 October 1990.

At that meeting the committee recommended that the proposal set out in Doc. C3-317/90 - COM(90) 400/26, which concerns the amendment of a proposal already referred to the European Parliament, together with that proposal, should be considered separately by the Committee on Economic and Monetary Affairs and Industrial Policy, the committee responsible.

At that meeting, the committee also adopted all the draft legislative resolutions by 11 votes to nil with one abstention.

The following took part in the vote: Fernandez Albor, chairman; Veil, first vice-chairman; Donnelly, rapporteur; Brok, Chabert, Desama (for Woltjer), Fernex (for Cramon Daiber), Holzfuss (for von Wechmar), Pasmazoglou (for Zeller), PirkI, Welsh and Wettig.
