- Comments: This refers to the effect of increasing the guide prices on the withdrawal prices and buying price bearing in mind the modifications of the withdrawal classification. This increase is to be added to the 2 million u.a. allowed in budget item 7110, however this can be financed within the framework of credits available in chapter 71 of the 1976 budget (Credits available: 4 million u.a.)

EXPLANATORY MEMORANDUM

Under Regulation (EEC) No 2142/70 on the common organization of the market in fishery products, a guide price is to be fixed for each of the products listed in Annex I A and C of the Regulation. This price is fixed for each fishing season on the basis of the average prices on the wholesale markets, or representative ports, during the three fishing years preceding the fixing of the price for a significant proportion of the Community output, for a product of defined market characteristics.

The starting point in the price fixing procedure has been the comparison of the mean of the prices set out below established during the period 1973/75 (1975: six months) and that of the period 1972/74, the latter having been the base for the fixing of the guide price for 1975. It follows from this comparison that there are price increases which, for most species qualified as being high or very high.

The mathematical method is not the only starting base. The results of this calculation have been further modified, taking into account the following points:

- the nature of the fish type: destined for the processing industry, or for direct human consumption,
- the general development of costs (it is not possible to evaluate point by point the exact increase in costs),
- the effect of the guide price on the level of the price of withdrawal and the relationship desired between these two prices in relation to the lowest market prices,
- the level of prices quoted in the different representative ports during the years 1974 and 1975.

A synthesis between these effects has been sought after and this has resulted in proposals for price increases according to the species of 2-5-7-12-15-20- and 30%.

These price proposals at the same time serve equally well the fishermen, the consumers and the tax payers.

For the fishermen the withdrawal price - derived from the guide price - will have, during a specific temporary situation, a real and not a theoretical significance.

For the consumers, it is important to emphasize that the price increases do not have an inflationary effect, since market prices are in general higher than the withdrawal prices and are expected to remain so.

With regard te

haddock, for which a 15% increase in the guide price, is proposed, the Commission proposes to adjust the rates of percentage of the guide price, which are taken into consideration for fixing the withdrawal prices in order to comply with market requirements. The Commission intends to increase the rate of percentage of the guide price for haddock from 75% to 8%.

The present regulation is intended to fix the guide price for the products of Annex I A and C of Regulation (REC) No 2142/70 for 1976.

Whereas the application of the criteria aforesaid defined in Article 8 of Regulation (EEC) No 2143/70 involves an increase in prices by comparison with those valid for the current fishing year; whereas in the absence of complete information concerning price trends for each fishery product with given commercial specifications consideration should be given in the case of most products, to the relationship between the average weighted market prices recorded when the guide prices were fixed for the previous fishing year for these products. and the average weighted market prices now current;

EXPLANATORY MEMORANDUM

Under Regulation (EEC) No 2142/70 on the common organization of the market in fishery products, a guide price is to be fixed for each of the products listed in Annex II to the Regulation. It is to be fixed for a product with given commercial characteristics and based on the average of prices recorded on representative wholesale markets or in representative ports during the three fishing years immediately preceding the fixing of the price for a significant proportion of the Community output.

The development of prices for the products in question is characterised by an important increase (excluding sea-bream). It is proposed to increase the guide prices by 10% to 30%.

EXPLANATORY MEMORANDUN

Under Regulation (EEC) No 2142/70 on the common organisation in fishery products, the intervention price for fresh or chilled sardines and anchovies is fixed and this intervention price can be fixed at a level of between 35 and 45% of the guide price according to the production characteristics and the character of the particular market for each product.

The present regulation is intended to fix the intervention price in conformity with the dispositions of Regulation (EEC) No 2142/70.

The present proposal reflects the Council declaration relating to the level of these prices. "The Council invites the Commission to take into consideration, at the submission of the proposal relating to intervention prices, the importance which is attached to the need for these prices to be near the upper limit of the bracket shown in Article 8, paragraph 3" (of R/2129/70 (AGRI 691) of 20 October 1970).

Whereas the guide prices for fishery products listed in Annex I (A) and (C) to Regulation (EEC) No 2142/70 have been fixed for the 1976 fishing year by Regulation (EEC) No (3);

Whereas, given the present state of information on the market situation for the products in question and the absence of any experience in relation to purchase on the open market of these products, the intervention prices should be fixed at a level such as to ensure maximum support of the market.

EXPLANATORY MEMORANDUM

Under Regulation (EEC) No 2142/70 on the common organization of the market in fishery products, a community production price for tunny intended for canning is fixed, and this price can be fixed for a product defined by its market characteristics on the base of the mean of the wholesale market prices or in the representative ports during the three fishing seasons preceding the fixing of this price and for a significant part of the Community production.

Examination of the market situation has established that the price of the product in question has increased since the last price fixing on the Community production in 1975 in such a way that an increase in the Community production price is justified.

The present Regulation is intended to fix the Community production price for 1976 in conformity with the dispositions of Regulation (EEC) No 2142/70.

Whereas by Regulation (EEC) No 1182/75, hake was added to Annex I.A of Regulation (EEC) No 2142/70; whereas, therefore, marketing standards should be determined for this species;
