EXPLANATORY MEMORANDUM

1. Council Regulation (EEC) No 3164/76 of 16 December 1976 on the Community quota for the carriage of goods by road between Member States¹ provides inter alia that :

<u>=-2</u>]=

- (i) the authorization is personal and may not be transferred to a third person;
- (ii) it may be used for only one vehicle at a time (this may be a single vehicle or a coupled combination of vehicles).

These provisions sometimes cause difficulties for hauliers who use a Community authorization for haulage by their own tractor of trailers or semitrailers which are not registered in their name. Some authorities require the holder of a Community authorization to prove that the load-carrying vehicle belongs to him as well and, if it does not, he is required to produce a Community authorization for this vehicle too.

2. The Council Directive of 13 May 1965 on the standardization of certain rules relating to authorizations for the carriage of goods by road between Member States², provides inter alia that :

(i) authorizations required for the international carriage of goods by road to or from the territory of a Member State or passing across the territory of one or more Member States shall be issued by the competent authorities of the Member State in which the vehicle to be used for such carriage is registered;

(ii) these authorizations shall apply to a single vehicle or a coupled combination of vehicles.

As in the case of Community authorizations, the use of a coupled combination of vehicles sometimes causes problems when the tractor and the load-carrying vehicle do not belong to the same firm or are registered in different countries. Some Member States require a bilateral authorization for the load-carrying vehicle and have regard only to the movement of goods while others disregard the vehicle in which the transport is effected and only require an authorization for the tractor. Yet other States are concerned with both the means of transport and the goods transported and so require authorizations for both the tractor and the load-carrying vehicle if these are registered in the names of two firms or in different Member States.

3. In view of these differing practices, measures should be taken to standardize procedures. To issue authorizations only in respect of the tractor would introduce a simple and uniform arrangement for effecting goods transport by road in those cases where the authorization system for transport between Member States is still in use.

4. To issue transport authorizations in respect of the tractor would also have the following additional advantages :

Whereas the application of the abovementioned Regulation has revealed difficulties in the use of such authorizations in the case of certain coupled combinations of vehicles;

Whereas the system of issuing authorizations in respect of tractors has administrative, economic and legal advantages and should, in the light of experience, be extended to cover the use of coupled combinations of vehicles;

Whereas Community-level uniform rules for the issuing of such authorizations are needed;

Whereas Regulation (EEC) No 3164/76 should therefore be amended, :

HAS ADOPTED THIS REGULATION :

Article 1

Regulation (EEC) No 3164/76 ' is hereby amended as follows:

Whereas by its Dinective of 65/269/EEC¹ as amended by the Directive 73/169/EEC², the Council established a system of authorizations for the carriage of goods by road between Member States;

Whereas the application of Directive 65/269/EEC has revealed difficulties in the use of these authorizations in the case of certain coupled combinations of vehicles;

Whereas the system of issuing authorizations in respect of tractors has administrative economic and legal advantages and should, in the light of the experience acquired, be extended to cover the use of coupled combinations of vehicles; $\frac{1}{11}$

Whereas Community-level uniform rules for the issuing of such authorizations are needed;

Whereas Directive 65/269/EEC should therefore be amended,

HAS ADOPTED THIS DIRECTIVE :

Article 1

+ 2 -

The following subparagraph shall be added to Article 1 of Directive 65/269/EEC:

" If the transport operation is carried out by a coupled combination "of vehicles, the authonizations required shall be issued by the competent authorities of the Member State in which the tractor is registered. Such authorizations shall cover the coupled combination of vehicles."

Article 2

The Member States shall inform the Commission before 1 January 1982 of the measures taken to implement this Directive.

Article 3

This Directive is addressed to the Member States.
