EXPLANATORY MEMORANDUM

Consultations between delegations from the Community and the Faeroe Islands about their reciprocal fishing rights in 1981 have not been concluded in time to make it possible to adopt before 31 December 1980 final arrangements for 1981 based on the conclusions of the said consultations.

In order to avoid an interruption of the reciprocal fishing from 1 January 1981 it is necessary for the Community to adopt interim arrangements for fishing by Faeroese vessels valid from 1 January until the entry into force of definitive arrangements for 1981. The Commission considers that the definitive arrangements can enter into force on 1 April 1981. For this reason the Commission proposes that the Council adopt a Regulation establishing an interim regime permitting Faeroese vessels to fish in the Community fishing zone from 1 January until 31 March 1981.

In order to ensure that the interim arrangements are not more restrictive than the definitive arrangements to be agreed with the Faeroe Islands, and in view of the fact that catches taken during the period covered by the interim arrangements will in any event be counted against the quotas to be set for the entire year 1981, the Commission proposes that the quotas fixed under the interim arrangements be set at a level which is relatively high in relation to the length of the period covered by these arrangements. The Commission considers it appropriate as a general rule to set these quotas at 50 % of the quotas agreed with the Faeroe Islands for 1980 with the exception, however, of the mackerel stock in the North Sea and Skagerrak and the stocks of Northern deepwater prawn in the NAFO division 1 and the ICES divisions XIV and V for which a p.m. quota is proposed. The Commission intends to complete the proposal at a later stage in the light of recommendation concerning these stocks of Northern deepwater prawn to be drawn up by the Scientific Council of NAFO and ICES, and as a result of the arrangement between the parties concerned on the TAC for mackerel.

With regard to the stocks of halibut in the sub-area NAFO 1 and the ICES divisions XIV and V, the Commission proposes that no quota should be allocated to the Faeroese vessels.

In conformity with Article 2 of the Framework agreement on fisheries between the Community and the Faeroe Islands, the Commission has consulted the Faeroese authorities concerning the interim arrangements provided for in the present proposal. The Faeroese authorities have said that they are satisfied that these arrangements constitute an adequate provisional arrangement.

As to fishing by Community vessels in the Faeroese fisheries zone, interim arrangements should not be necessary provided that the consultations are concluded before mid-December. Under these conditions, the Faeroese authorities should be able to establish, before 1 January, definitive arrangements in conformity with the outcome of the consultations.

In the event that the consultations were not concluded before mid-December, the Commission would consult the Faeroese authorities on the subject of interim arrangements to permit fishing by Community vessels in Faeroese waters.

For the reasons given above, the Commission proposes that the Council adopt the Regulation, a draft of which is attached, at the latest during the session of the Fisheries Council of 15/16 December 1980.

laying down certain interim measures for the conservation and management of fishery resources applicable to vessels registered in the Faroe Islands

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 103 thereof,

Having regard to the proposal from the Commission,

Whereas the Community, on the one hand, and the Government of Denmark and the Home Government of the Faroe Islands on the other hand, have concluded a framework fisheries agreement (1) under which the two parties have agreed to consult annually on reciprocal fishing possibilities ;

Whereas the consultations held between the Community and the Faroe Islands on mutual fishing rights for 1981 have not been concluded in time to permit the adoption, before the 31 December 1980, of definitive arrangements for fishing by vessels registered in the Faroe Islands in the fisheries zone of the Community in conformity with the conclusions of such consultations;

Whereas fishing from Faroese vessels in the Community's fishing zone is authorized until 31 December 1980 by virtue of Council Regulation (EEC) No 1718/80 of 30 June 1980 laying down certain measures for the conservation and management of fishery resources applicable to vessels registered in the Faroe Islands (2) ;

Whereas, in order to avoid an interruption of reciprocal fishing by vessels of the two parties, in the fisheries zone of the other, the two

parties have agreed on reciprocal interim arrangements, and it is therefore necessary that the Community adopt, before 1 January 1981, the arrangements thus agreed authorizing fishing by Faroese vessels in the fisheries zones of the Community from 1 January 1981 until the entry into force of definitive arrangements for 1981;

Whereas, in order to comply with this date it is necessary to adopt these interim measures on the basis of Article 103 of the Treaty.

HAS ADOPTED THIS REGULATION:

Article 1

1. Fishing by vessels registered in the Faroe Islands in the 200-mile zone of the Member States in the North Sea, Skagerrak, Kattegat, the Baltic Sea, the Labrador Sea, Davis Strait, Baffin Bay and the Atlantic Ocean north of 43° N shall be authorized during the period from 1 January 1981 until 31 March 1981 for species mentioned in Annex I within the geographical and quantitative limits laid down therein and in accordance with the conditions laid down in this Regulation.
2. Fishing authorized under paragraph 1 shall be limited to the parts of the 200-mile fishing zone lying seawards of 12 nautical miles from the base-lines from which the territorial seas of Member States are measured with the exception that fishing in the Skagerrak is allowed seawards of four nautical miles from the base-lines of Denmark.
3. Notwithstanding paragraph 1 unavoidable by-catches of a species for which no quota is established in a zone shall be permitted within the limits fixed in the conservation measures in force in the zone concerned.
4. By-catches in a given zone of a species for which a quota is established in that zone shall be counted against the quota concerned.

Article 2

1. Vessels fishing under the quotas established in Article 1 shall comply with the conservation and control measures and all other provisions governing fishing in the zones referred to in that Article.

2. Vessels referred to in paragraph 1 shall keep a logbook in which the information set out in Annex II is to be entered.

3. Vessels referred to in paragraph 1 except those fishing in ICES division IIIa shall transmit to the Commission the information set out in Annex III. This information is to be transmitted according to the rules set out in this Annex.

4. The registration letters and numbers of the vessels referred to in paragraph 1 must be clearly marked on the bow of the vessels on both sides.

Article 3

XIV 1. Fishing within ICES sub-areas IV, V, VI, VII and and in NAFO sub-area 1 under the quotas established

in Article 1 shall be permitted only where a licence issued by the Commission on behalf of the Community is held on board and where the conditions set out in the licence are observed.

2. The delivery of licences for the purpose of paragraph 1 shall be subject to the condition that the number of licences valid on any one day shall not exceed:

(a) 17 for fishing mackerel and horse mackerel in ICES sub-area IV and division VI a) (north of 56° 30' N) and ICES divisions VII e), f) and h) and sprat in ICES sub-area IV and division VI a) (north of 56° 30' N);

(b) 18 for fishing Norway pout in ICES sub-area IV and division VI a) (north of 56° 30' N) and sandeel in ICES sub-area IV;

(c) for fishing northern deep-water prawn (*Pandalus borealis*) in ICES sub-area XIV and V and NAFO sub-area 1,

(d) 21 for fishing ling and tusk in ICES division VI b);

(e) six for fishing redfish in NAFO sub-area 1 and ICES sub-area XIV and V,

(f) 14 for fishing blue whiting in ICES sub-area VII (west of 12° W) and ICES divisions VI a) (north of 56° 30' N) and VI b).

3. The number of vessels holding a licence which shall be allowed to fish simultaneously shall be limited as follows:

(a) in fishing for northern deep-water prawn:

— at any one time: ... in NAFO sub-area 1 and in ICES sub-area XIV and V,

— the average number per month, calculated for the entire year: ... in NAFO sub-area 1 and in ICES sub-area XIV and V,

(b) in fishing for ling and tusk in ICES division VI b): 10.

4. Each licence shall be valid for one vessel only. When several vessels are taking part in the same fishing operation, each vessel shall be in possession of a licence.

5. Licences may be cancelled with a view to the issue of new licences. The cancellation shall take effect from the date of the surrender of the licence to the Commission.

6. Licences issued in pursuance of Regulation No 1718/80 and valid on 31 December 1980

shall remain valid until 31 January 1981 at the latest, if so requested by the Faroese authorities.

Article 4

When an application for a licence is submitted to the Commission, the following information shall be supplied:

- (a) name of the vessel;
- (b) registration number;
- (c) external identification letters and numbers;
- (d) port of registration;
- (e) name and address of the owner or charterer;
- (f) gross tonnage and overall length;
- (g) engine power;
- (h) call sign and radio frequency;
- (i) intended method of fishing;
- (j) intended area of fishing;
- (k) species for which it is intended to fish;
- (l) period for which a licence is requested.

Article 5

Fishing for the quotas referred to in Article 1 for ling and tusk shall be allowed only by use of the method commonly known as 'long-lining'.

Article 6

The competent authorities of the Member States shall take appropriate steps, including the regular inspection of vessels, to ensure the enforcement of this Regulation.

Article 7

Where an infringement is duly found to have taken place, the Member States shall, without delay, inform the Commission of the name of the vessel involved and of any action they have taken.

Article 8

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply from 1 January
~~until~~ 31 March 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

ANNEX III

1. The information to be transmitted to the Commission and the timetable for its transmission are as follows :

1.1. On each occasion the vessel enters :

1.1.1. the 200 nautical mile fishing zone off the coasts of the Member States of the Community which is covered by the fisheries jurisdiction of these Member States ;

1.1.2. that sub-zone 1 as defined by the Convention on Future Multilateral Cooperation in the North West Atlantic Fisheries situated in the jurisdiction of Denmark :

- (a) the information specified under point 1.4 below ;
- (b) the quantity (in kg) of each species of fish in the hold ;
- (c) the date and NAFO sub-zone or ICES division within which the captain intends to commence fishing.

Where the fishing operations necessitate more than one entry into the zones referred to under 1.1.1 and 1.1.2 on a given day one communication shall suffice on first entry.

1.2. On each occasion the vessel leaves :

1.2.1. the zone referred to under 1.1.1 :

- (a) the information specified under point 1.4 below ;
- (b) the quantity (in kg) of each species of fish in the hold ;
- (c) the quantity (in kg) of each species caught since the previous transmission ;
- (d) the ICES division or NAFO sub-zone in which the catches were taken ;
- (e) the quantity (in kg) of each species transferred to other vessels since the vessel entered the zone and the identification of the vessel to which the transfer was made ;
- (f) the quantity (in kg) of each species landed in a port of the Community since the vessel entered the zone ;

1.2.2. the zone referred to under 1.1.2 after notification at least 48 hours before the vessel leaves, the information referred to under (a), (b), (c), (d), (e), (f) ;

- (g) the quantity (in kg) of discards specified by species since the previous transmission.

1.3. At weekly intervals, commencing on the seventh day after the vessel first enters the zones referred to under 1.1.1 and 1.1.2 :

- (a) the information specified under point 1.4 below ;
- (b) the quantity (in kg) of each species caught since the previous transmission ;
- (c) the ICES division or NAFO sub-zone in which the catches were made.

1.4. (a) the name, call sign, identification numbers and letters of the vessel name, the name of its master ;

- (b) the licence number if the vessel is under licence ;
- (c) the serial number of the message ;
- (d) identification of the type of message ;
- (e) the date, the time and the geographical position of the vessel.

2.1. The information specified under point 1 shall be transmitted to the Commission of the European Communities in Brussels (telex address 24189 FISEU-B) via one of the radio stations listed under point 3 below and in the form specified under point 4.

- 2.2. If it is impossible for reasons of *force majeure* for the message to be transmitted by the vessel, it may be transmitted on the vessel's behalf by another vessel.

4. Form of communications

The information specified under point 1 concerning the fishing operations in the zones referred to under 1.1.1 and 1.1.2 shall contain the following elements, which shall be given in the following order :

- name of vessel,
- call sign,
- external identification letters and numbers,
- serial number of the message for the voyage in question,
- indication of the type of message according to the following code :
 - message — when entering one of the zones referred to under 1.1.1 and 1.1.2: IN,
 - message — when leaving one of the zones referred to under 1.1.1 and 1.1.2: OUT,
 - weekly message : WKL,
- the geographical position,
- the ICES division or NAFO sub-zone in which fishing is expected to commence,

- the date on which fishing is expected to commence,
- the quantity in kg of each species of fish in the hold using the code mentioned in point 5,
- the ICES division or NAFO sub-zone in which the catches were made,
- the quantity (in kg) of each species transferred to other vessels since the previous transmission,
- the name and call sign of the vessel to which the transfer was made,
- the quantity (in kg) of each species landed in a port of the Community since the previous transmission,
- the name of the master,
- the quantity (in kg) of each species discarded since the previous transmission using the code mentioned in point 5 only in the case of fisheries operations in the zones referred to under 1.1.2.

In order to ensure that the interim arrangements are not more restrictive than the definitive arrangements to be agreed with Sweden, and in view of the fact that catches taken during the period covered by the interim arrangements will in any event be counted against the quotas to be set for an entire year 1980. The Commission considers that it is appropriate to fix these quotas, in the Kattegat and Skagerrak at 50 % of the quotas agreed with Sweden for 1980, and in the North Sea and Baltic at 50 % of the quotas sought by the Swedish delegation during the discussions of 13 November 1980 with the exception of the mackerel stock in the North Sea, Skagerrak and Kattegat and the haddock stock in Skagerrak and Kattegat for which a p.m. quota is proposed. The Commission intends to finalise its proposal later in the light of an arrangement between the parties concerned about the TACs for these stocks.

In conformity with Article 2 of the Framework agreement on fisheries between the Community and Sweden, the Commission has consulted the Swedish authorities concerning the interim arrangements provided for in the present proposal. The Swedish authorities have said that they are satisfied that these arrangements constitute an adequate provisional arrangement.

As to fishing by Community vessels in the Swedish fisheries zone, interim arrangements should not be necessary provided that the consultations are concluded before mid-December. Under these conditions, the Swedish authorities should be able to establish, before 1 January, definitive arrangements in conformity with the outcome of the consultations.

In the event that the consultations were not concluded before mid-December, the Commission would consult the Swedish authorities on the subject of interim arrangements to permit fishing by Community vessels in Swedish waters.

For the reasons given above, the Commission proposes that the Council adopt the Regulation, a draft of which is attached, at the latest during the session of the Fisheries Council of 15/16 December 1980.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 103 thereof,

Having regard to the proposal from the Commission,

Whereas the Community and the Kingdom of Sweden have concluded a framework fisheries agreement (1) under which the two parties have agreed to consult annually on the management of joint stocks and on reciprocal fishing possibilities

Whereas the consultations held between the Community and Sweden on the one hand, and between the Community, Sweden and Norway on the other hand, on the subject of reciprocal fishery rights for 1981 and of the management of certain joint stocks occurring in Skagerrak and in Kattegat

have not been concluded in time to permit the adoption, before 31 December 1980, of definitive arrangements for fishing by Swedish vessels in the fisheries zone of the Community in conformity with the conclusions of such consultations ;

Whereas fishing from Swedish vessels in the Community's fishing zone is authorized until 31 December by virtue of Council Regulation (EEC) No 1716/80 of 27 June 1980 laying down certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of Sweden (2) ;

Whereas, in order to avoid a interruption of reciprocal fishing by vessels of each of the two parties in the fisheries zone of the other, the two parties have agreed on reciprocal interim arrangements it is therefore necessary that the Community adopt, before 1 January 1981, the arrangements agreed authorising fishing by Swedish vessels in the fisheries zones of the Community from 1 January 1981 until the entry into force of definitive arrangements for 1981;

Whereas, in order to comply with this date, it is necessary to adopt measures authorizing interim fishing by Swedish vessels in the Community fisheries zone on the basis of Article 103 of the Treaty,

Whereas the Agreement of 19 December 1966 between Denmark, Norway and Sweden on mutual access to fishing in Skagerrak and Kattegat provides that each party shall grant access to fishing by vessels of the other parties within its fishing zone in Skagerrak and part of Kattegat seawards of four nautical miles from the base-lines ;

Whereas the Convention of 31 December 1932 between Denmark and Sweden concerning fishing conditions in the maritime waters bordering both parties provides that each party shall grant access to fishing by vessels of the other party within its fishing zone in the Kattegat seawards of three nautical miles from the coast and in certain parts of Øresund and the Baltic Sea up to the base-lines ;

HAS ADOPTED THIS REGULATION :

Article 1

1. Fishing by vessels flying the flag of Sweden in the 200-mile zone of the Member States in the North Sea, Skagerrak, Kattegat, the Baltic Sea, the Labrador Sea, Davis Strait, Baffin Bay and the Atlantic Ocean north of 43° N shall be authorized during the period to 31 March 1981 for the species referred to in Annex I within the geographical and quantitative limits laid down therein and in accordance with the provisions laid down in this Regulation. 1 January 1981

2. Without prejudice to the provisions of paragraph 1, fishing by vessels flying the flag of Sweden for species other than those for which quotas are established in Annex I is authorized in Kattegat,

Skagerrak and Øresund, east of a line drawn from the lighthouse of Hanstholm to the lighthouse of Lindesnes and north of a line drawn from the lighthouse of Stevns to the lighthouse of Falsterbo.

3. For the purposes of this Regulation:

- the Skagerrak is the area limited in the west by a line drawn from the lighthouse of Hanstholm to the lighthouse of Lindesnes and in the south by a line drawn from the Skagen lighthouse to the lighthouse of Tistlarna and from there to the nearest coast of Sweden,
- the Kattegat is the area limited in the north by a line drawn from Skagen lighthouse to the lighthouse of Tistlarna and from there to the nearest coast of Sweden and in the south by a line drawn from Hasenøre Head to Griben Point, from Korshage to Spodsbjerg, and from Gilbjerg Head to the Kullen,
- Øresund is the area limited in the north by a line drawn from Gilbjerg Point to the Kullen and in the south by a line drawn from the lighthouse of Steenhus to the lighthouse of Falsterbo.

4. Fishing authorized under paragraphs 1 and 2 shall be limited to the parts of the 200-mile fishing zone lying seawards of 12 nautical miles from the base-lines from which the territorial waters of Member States are measured, with the following exceptions:

- (a) fishing in Skagerrak is authorized seawards of four nautical miles from the base-lines of Denmark;
- (b) fishing in Kattegat is authorized seawards of three nautical miles from the coast of Denmark;
- (c) fishing in the Baltic Sea is authorized seawards of three nautical miles from the base-lines of Denmark;
- (d) fishing in Øresund is authorized within the areas and in accordance with the conditions set out in Annex II.

5. Notwithstanding paragraph 1, unavoidable by-catches of a species for which no quota is established in a zone shall be permitted within the limits fixed in the conservation measures in force in the zone concerned.

6. By-catches in a given zone of a species for which a quota is established in that zone shall be counted against the quota concerned.

Article 2

1. Vessels fishing under the quotas established in Article 1 shall comply with the conservation and control measures and all other provisions governing fishing in the zones referred to in that Article.

2. Vessels referred to in paragraph 1 shall keep a logbook in which the information specified in Annex III is to be entered.

3. Vessels referred to in paragraph 1, except those fishing in Skagerrak, Kattegat and Øresund, shall transmit to the Commission, according to the rules set out in Annex IV, the information specified in that Annex.

4. The registration letters and numbers of the vessels referred to in paragraph 1 must be clearly marked on the bow of the vessel on both sides.

Article 3

1. Fishing within ICES sub-areas IV and VI, and ICES division IIIb, c, d under the quotas established in Article 1, shall be permitted only where a licence issued by the Commission on behalf of the Community at the request of the Swedish authorities is held on board and where the conditions set out in the licence are observed.

2. Licences shall be issued for the purposes of paragraph 1 subject to the condition that the number of licences valid on any day shall not exceed:

- 79 for fishing cod and herring in the Baltic Sea,
- 6 for fishing salmon in the Baltic Sea,
- 14 for fishing in ICES sub-areas IV and VI all species referred to in Annex I other than ling,
- 3 for fishing ling in ICES sub-areas IV and VI.

3. When an application for a licence is submitted to the Commission, the following information shall be supplied:

- (a) name of the vessel;
- (b) registration number;
- (c) external identification letters and numbers;
- (d) port of registration;
- (e) name and address of the owner or charterer;
- (f) gross tonnage and overall length;
- (g) engine power;
- (h) call sign and radio frequency;
- (i) intended method of fishing;
- (j) intended area of fishing;
- (k) species for which it is intended to fish;
- (l) period for which a licence is requested.

4. Each licence shall be valid for one vessel only. When several vessels are taking part in the same fishing operation, each vessel shall be in possession of a licence.

5. Licences may be cancelled with a view to issuing new licences. Cancellation shall take effect from the date of the surrender of the licence to the Commission. New licences shall take effect from the first of the month following that in which they are issued.

6. Licences issued under Regulation (EEC) No 1716/80 and valid until 31 December 1980 shall remain valid until 31 January 1981 at the latest if the Swedish authorities so request.

Article 4

1. The use of trends and purse seines for catching pelagic species shall be prohibited in Skagerrak from Saturday midnight to Sunday midnight and in Kattegat from Friday midnight to Sunday midnight.
2. Directed fishing for herring in Skagerrak and Kattegat for purposes other than human consumption is prohibited.
3. Only long-liners shall be permitted to fish for ling.

Article 5

The competent authorities of the Member States shall take appropriate steps, including the regular inspection

of vessels, to ensure the enforcement of this Regulation.

Article 6

Where an infringement is duly found to have taken place, the Member States shall, without delay, inform the Commission of the name of the vessel involved and of any action they have taken.

Article 7

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply from 1 January
until 31 March 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

EXPLANATORY MEMORANDUM

Consultations between delegations from the Community and Norway about their reciprocal fishing rights in 1981 have not been concluded in time to make it possible to adopt before 31 December 1980 final arrangements for 1981 based on the conclusions of the said consultations.

In order to avoid an interruption of the reciprocal fishing from 1 January 1981 it is necessary for the Community to adopt interim arrangements for fishing by Norwegian vessels valid from 1 January until the entry into force of definitive arrangements for 1981. The Commission considers that the definitive arrangements can enter into force on 1 April 1981. For this reason the Commission proposes that the Council adopt a Regulation establishing an interim regime permitting Norwegian vessels to fish in the Community fishing zone during the abovementioned period.

In order to ensure that the interim arrangements are not more restrictive than the definitive arrangements to be agreed with Norway, and in view of the fact that catches taken during the period covered by the interim arrangements will in any event be counted against the quotas fixed under the interim arrangements be set at a level which is relatively high in relation to the length of the period covered by these arrangements. The Commission considers it appropriate as a general rule to set these quotas at 50 % of the quotas agreed with Norway for 1980 with the exception, however, of the mackerel stock in the North Sea and Skagerrak and the stocks of Northern deepwater prawn in the NAFO division 1 and the ICES divisions XIV and V for which a p.m. quota is proposed. The Commission intends to complete the proposal at a later stage in the light of recommendation concerning these stocks of Northern deepwater prawn to be drawn up by the Scientific Council of NAFO and ICES, and as a result of the arrangement between the parties concerned on the TAC for mackerel.

With regard to the stocks of halibut and greenland halibut in the sub-area NAFO 1 and the ICES divisions XIV and V, the Commission proposes that no quota should be allocated to the Faeroese vessels.

In conformity with Article 2 of the Framework agreement on fisheries between the Community and Norway, the Commission has consulted the Norwegian authorities concerning the interim arrangements provided for in the present proposal. The Norwegian authorities have said that they are satisfied that these arrangements constitute an adequate provisional arrangement.

As to fishing by Community vessels in the Norwegian fisheries zone, interim arrangements should not be necessary provided that the consultations are concluded before mid-December. Under these conditions, the Norwegian authorities should be able to establish, before 1 January, definitive arrangements in conformity with the outcome of the consultations.

In the event that the consultations were not concluded before mid-December, the Commission would consult the Swedish authorities on the subject of interim arrangements to permit fishing by Community vessels in Norwegian waters.

For the reasons given above, the Commission proposes that the Council adopt the Regulation, a draft of which is attached, at the latest during the session of the Fisheries Council of 15/16 December 1980.

laying down certain interim measures for the conservation and management of fishery resources applicable to vessels flying the flag of Norway

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 103 thereof,

Having regard to the proposal from the Commission,

Whereas the Community and the Kingdom of Norway have concluded a framework fisheries agreement (1) under which the two parties have agreed to consult annually on the management of joint stocks and on reciprocal fishing possibilities;

Whereas the consultations held between the Community and Norway on the one hand, and between the Community, Norway and Sweden, on the other hand, on the subject of mutual fishery rights for 1981 and of the management of certain joint stocks occurring in Skagerrak and in Kattegat have not been concluded in time for the adoption, before 31 December 1980 of definitive rules for fishing by Norwegian vessels in the Community fisheries zone in accordance with the conclusions of these consultations;

Whereas fishing from Norwegian vessels in the Community's fishing zone is authorized until 31 December 1980 by virtue of Council Regulation (EEC) No 1717/80 of 27 June 1980 laying down certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of Norway (2).

Whereas in order to avoid the interruption of reciprocal fishing by vessels of the two parties in the fisheries zone of the other, the two parties have agreed on reciprocal interim arrangements and it is therefore necessary that the Community adopt before 1 January 1981 the arrangements agreed authorizing fishing by Norwegian vessels in the Community fisheries zone from 1 January 1981 until the entry into force of definitive arrangements for 1981;

Whereas in order to comply with this date it is necessary to adopt these interim measures on the basis of Article 103 of the Treaty,

Whereas the Agreement of 19 December 1966 between Denmark, Norway and Sweden on mutual access to fishing in Skagerrak and Kattegat provides that each party shall grant access to fishing by vessels of the other parties within its fishing zone in Skagerrak and part of Kattegat seawards of four nautical miles from the base-lines;

Whereas the Fishery Agreement of 1964 between the United Kingdom and Norway provides that Norwegian vessels are authorized to fish for dogfish and basking shark in certain areas between six and 12 nautical miles from the base-lines of the United Kingdom;

HAS ADOPTED THIS REGULATION:

Article 1

1. Fishing by vessels flying the flag of Norway in the 200 mile zone of the Member States in the North Sea, Skagerrak, Kattegat, the Baltic Sea, the Labrador Sea, Davis Strait, Baffin Bay and the Atlantic Ocean north of 43° N shall be authorized during the period 1 January to 31 March 1981 for the species mentioned in Annex I within the geographical and quantitative limits laid down therein and in accordance with the conditions laid down in this Regulation.
2. Fishing authorized under paragraph 1 shall be limited to the parts of the 200 mile fishing zone lying seawards of 12 nautical miles from the base-lines from which the territorial seas of Member States are measured with the following exceptions:
 - (a) fishing in the Skagerrak is allowed seawards of four nautical miles from the base-lines of Denmark;
 - (b) fishing for dogfish and basking shark is allowed in the areas defined in Annex II.

3. Notwithstanding paragraph 1, unavoidable by-catches of a species for which no quota is established in a zone shall be permitted within the limits fixed in the conservation measures in force in the zone concerned.

4. By-catches in a given zone of a species for which a quota is established in that zone shall be counted against the quota concerned.

Article 2

1. Vessels fishing under the quotas established in Article 1 shall comply with the conservation and control measures and all other provisions governing fishing in the zones referred to in that Article.

2. Vessels referred to in paragraph 1 shall keep a logbook in which the information set out in Annex III is to be entered.

3. Vessels referred to in paragraph 1 except those fishing in ICES division IIIa shall transmit to the Commission the information set out in Annex IV. This information is to be transmitted according to the rules set out in this Annex.

4. The registration letters and numbers of the vessels referred to in paragraph 1 must be clearly marked on the bow of the vessel on both sides.

Article 3

1. Fishing within ICES sub-area XIV and V and NAFO sub-area 1 under the quotas established in Article 1 shall be subject to the holding on board of a licence issued by the Commission on behalf of the Community and to the observance of the conditions set out in the licence.

2. The delivery of licences for the purpose of paragraph 1 shall be subject to the condition that the number of licences shall not exceed:

- for fishing redfish,
- for fishing northern deep-water prawn (*Pandalus borealis*) within ICES sub-area XIV and V and NAFO sub-area 1

However, the number of vessels fishing simultaneously for northern deep-water prawn may not exceed:

- as an average calculated per month for the whole year, the maximum being vessels per month, in NAFO sub-area 1,
- as an average calculated per month for the whole year, the maximum being vessels per month, in ICES sub-area XIV and V

3. Each licence shall be valid for one vessel only. When two or more vessels are taking part in the same fishing operation, each vessel shall be in possession of a licence.

4. Licences may be cancelled with a view to the issue of new licences. The cancellation shall take effect from the date of the surrender of the licence to the Commission.

5. Licences issued in pursuance of Regulation (EEC) No 1717/80 and valid on 31 December 1980 shall remain valid until 31 January 1981 at the latest, if so requested by the Norwegian authorities.

Article 4

When an application for a licence is submitted to the Commission, the following information shall be supplied:

- (a) name of the vessel;
- (b) registration number;
- (c) external identification letters and numbers;
- (d) port of registration;
- (e) name and address of the owner or charterer;
- (f) gross tonnage and overall length;
- (g) engine power;
- (h) call sign and radio frequency;
- (i) intended method of fishing;
- (j) intended area of fishing;
- (k) species for which it is intended to fish;
- (l) period for which a licence is requested.

Article 5

Fishing for the quotas referred to in Article 1 for blue ling, ling, rusk, and redfish is only allowed by use of the method commonly known as 'long-lining'.

Article 6

The use of trawls and of purse seines for catching pelagic species shall be prohibited in Skagerrak from Saturday midnight to Sunday midnight.

Article 7

The competent authorities of the Member States shall take appropriate steps, including the regular inspection of vessels, to ensure the enforcement of this Regulation.

Article 8

Where an infringement is duly found to have taken place, the Member States shall, without delay, inform the Commission of the name of the vessel involved and of any action they have taken.

Article 9

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply from 1 January until 31 March 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

 - (a) the information specified under point 1.4 below;

 - 1.2.2. the zone referred to under 1.1.2 after notification at least 48 hours before the vessel leaves, the information referred to under (a), (b), (c), (d), (e), (f);
 - (g) the quantity (in kg) of discards specified by species since the previous transmission.
 - 1.3. At weekly intervals, commencing on the seventh day after the vessel first enters the zones referred to under 1.1.1 and 1.1.2:
 - (a) the information specified under point 1.4 below;
 - (b) the quantity (in kg) of each species caught since the previous transmission;
 - (c) the ICES division or NAFO sub-zone in which the catches were made.
 - 1.4.
 - (a) the name, call sign, identification numbers and letters of the vessel and the name of its master;
 - (b) the licence number if the vessel is under licence;
 - (c) the serial number of the message;
 - (d) identification of the type of message;
 - (e) the date, the time and the geographical position of the vessel.
- 2.1. The information specified under point 1 shall be transmitted to the Commission of the European Communities in Brussels (telex address 24189 FISEU-B) via one of the radio stations listed under point 3 below and in the form specified under point 4.

2.2. If it is impossible for reasons of *force majeure* for the message to be transmitted by the vessel, it may be transmitted on the vessel's behalf by another vessel.

4. Form of communications

The information specified under point 1 concerning the fishing operations in the zones referred to under 1.1.1 and 1.1.2 shall contain the following elements, which shall be given in the following order:

- name of vessel,
- call sign,
- external identification letters and numbers,
- serial number of the message for the voyage in question,
- indication of the type of message according to the following code:
 - message – when entering one of the zones referred to under 1.1.1 and 1.1.2: IN,
 - message – when leaving one of the zones referred to under 1.1.1 and 1.1.2: OUT,
 - weekly message: WKL,
- the geographical position,
- the ICES division or NAFO sub-zone in which fishing is expected to commence,

- the date on which fishing is expected to commence,
- the quantity in kg of each species of fish in the hold using the code mentioned in point 5,
- the ICES division or NAFO sub-zone in which the catches were made,
- the quantity (in kg) of each species transferred to other vessels since the previous transmission,
- the name and call sign of the vessel to which the transfer was made,
- the quantity (in kg) of each species landed in a port of the Community since the previous transmission,
- the name of the master,
