## EXPLANATORY MEMORANDUM

## 1. General background of aid to non-associated developing countries

A recapitulation of the general information relating to financial and technical assistance to non-associated developing countries can be found in the 1983 implementation report. The report outlines the origins of the programme in 1976 and its development up to the present day, the basic objectives and the main conditions governing the aid, the principal procedural points, including the requirement to draw up specific annual guidelines for the coming year's programme.

## 2. Experience to date

The 1983 implementation report also takes stock of the experience to date in the implementation of aid to non-associated developing countries. All the projects completed by 31 December 1983 are reviewed and the lessons that can be learned are summed up in a chapter of the report.

Broadly speaking, it is revealed that

- (i) the aid has indeed gone mainly to the poor rural populations of the countries in direst need and that the guidelines adopted in successive years - without any major changes - have indeed provided an appropriate framework for the achievement of this objective;
- (ii) as the programme has developed, experience gained in earlier programmes has been able to be put to good use in the drawing up of later programmes, especially as regards the preparation and preliminary study of the projects, administrative procedures, the technical assistance input, adjustments in the pace of implementation, a more in-depth knowledge of the countries in general, and this despite the fact that the limited resources necessarily impose certain restrictions on the extent to which all these requirements can be met.

## 3. Guidelines proposed for 1985

In view of what has been said above and the fact that the guidelines for 1984 have proved to be well suited to the objectives and the conditions governing the administration of aid to the non-associated developing countries, the Commission proposes renewing for 1985 the guidelines approved by the Council for 1984.

Angola and Mozambique already participate in the Lome III negociations with a view to joining the ACP group of countries. However, in order to assure continuity, they remain eligible for credits under Art. 930, on a temporary basis, until they are able to take advantage in real terms of the benefits reserved for ACP countries.

It is also proposed that the aid granted to the People's Republic of China in 1983 be renewed in 1985 on comparable terms. This initial experiment now under way seems to be providing the necessary assurances as to the usefulness and mutual interest of cooperation with this country in the framework chosen.
