Whereas negotiations for the conclusion of a new Agreement have not yet been completed and therefore the said arrangements should again be extended.

HAS ADOPTED THIS REGULATION:

## Sole Article

In Article 1 of Regulation (EEC) No 2107/75 for "31 December 1975" read "30 June 1976".

This Regulation shall be binding in its entirety and directly applicable in all Member States.
