PROPOSAL FOR A REGULATION (REC) OF THE COUNCIL

amending Regulation (LEC) No 1127/74 fixing for the 1974/75 marketing year, the monthly price increases for cereals, wheat and rye flour and wheat groats and meal.

EXPLANATORY NOTE

Subject : Draft Regulation amending Council Regulation (EDC) No 1127/74 fixing, for the 1974/75 marketing year, the monthly price increases for cereals, wheat and rye flour and wheat groats and meal.

The reasons which led to the change in the dates of the beginning and end of the marketing year for maize, to 1 October and 30 September respectively (Council Regulation (EEC) No 1125/74 of 29 April 1974), also led to the application the same system for sorghum, a cereal which in terms of the cultural cycle, the timing of sales and the price level, as well as the nutritive value, has the same characteristics as maize.

For the reasons given above the same timing and amount of monthly price increases as apply to maize should be adopted for sorghum, the beginning of the monthly increases being fixed for 1 November.

The clarification which appeas in Article 1 of the draft Regulation is necessary in order to emphasise that (because the intervention prices valid for the two last months of the marketing year are the same as those valid for the first month of the following marketing year) the monthly increases for all the products in the last two months of the marketing year only apply to the target and threshold prices.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community; Having regard to Council Regulation No 120/67/FECA⁽¹⁾ of 13 June 1967 on the common organization of the market in cereals, as last amended by Regulation /74 ⁽²⁾ and in particular Article 6 (2) thereof; (EEC) No

Having regard to the proposal from the Commission;

Whereas the monthly price increases laid down for this group of products for the last two months of the marketing year do not apply to the intervention price since, according to Article 4 (3) of Regulation No 120/67/EEC, the intervention prices valid in the last two months of the marketing year are the same as those valid in the first month of the following marketing year; whereas however those monthly increases do apply to the threshold price and the target price; whereas consequently the second sentence of Article 2 of Council Regulation (IEC) No 1127/74 (3) should be clarified in this respect;

Whereas, according to Article 3 of Council Regulation No 120/67/EEC, as last /74, the marketing year for sorghum begins amended by Regulation (EEC) No on 1 October, with effect from the 1975/1976 marketing year, and finishes on 30 September of the following year; whereas however as a temporary measure for the 1974/1975 marketing year the marketing year for this product begins on 1 August 1974 and ends on 30 September 1975; hwereas nevertheless in the circumstances of the new system the same timing and the same monthly increases as are laid down for maize should be adopted for this product; whereas this results in the first of the monthly increases for sorghum being fixed for 1 November;

HAS ADOPTED THIS REGULATION :

Article 1

The text of the last paragraph of Article 2 of Regulation (EEC) No 1127/74 is replaced by the following :

"The monthly increases in brackets shall not apply to the intervention price".

Article 2

The text of Article 3 (1) of Regulation (EEC) No 1127/74 is replaced by the following :

"1. The monthly increases to be applied to the threshold price operative for the first month of the marketing year for oats, buckwheat, millet and canary seed shall be the same as those which apply to the threshold price for barley and for sorghum they shall be the same as those which apply to the threshold price for maize".

Article 3

This Regulation shall enter into force on 1 August 1974.

This Regulation shall be binding in its entirety and directly applicable in all Nember States.
