THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC⁽¹⁾ of 22 September 1966 on the establishment of a common organization of the market in oils and fats, as last amended by Regulation (EEC) No 1707/73⁽²⁾, and in particular the second paragraph of Article 4 thereof;

Having regard to the proposal from the Commission;

Whereas the threshold price must be fixed in such a way as to enable the selling price of the imported product, as the frontier crossing point referred to in Article 13 (2) of Regulation No 136/66/EEC, to be maintained at the level of the market target price; whereas, when the present costs incurred by the importer from the cif stage are taken into account, the level of the threshold price should be maintained at 2 units of account below the level of the market target price,

HAS ADOPTED THIS REGULATION :

Article 1

The threshold price for olive oil for the 1974/1975 marketing year shall be 93 units of account per 100 kilogrammes.

Article 2

This Regulation shall enter into force on 1 November 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

fixing the monthly increases in the market target price, the intervention price and the threshold price for olive oil for the 1974/1975 marketing year.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC⁽¹⁾ of 22 September 1966 on the establishment of a common organization of the market in oils and fats, as last amended by Regulation (EEC) No 1707/73⁽²⁾, and in particular Article 9 thereof;

Having regard to the proposal from the Commission;

Whereas under Article 9 of Regulation No 136/66/EEC the market price, the intervention price and the threshold price for olive oil must be increased each month for a period of 10 months beginning on 1 January 1975; whereas these increases must be the same for all three prices;

Whereas in fixing these increases the same for each month, account being taken of average storage costs and interest charges in the Community, the storage costs should be established on the basis of the cost of storing oil in the appropriate premises and of the handling required for preserving the oil in good condition; whereas the interest charges can be calculated on the average price of olive oil in production areas,

HAS ADOPTED THIS REGULATION :

Article 1

For the 1974/1975 marketing year the amount of the monthly increases referred to in Article 9 of Regulation No 136/66/EEC and applicable with effect from 1 January 1975 shall be 0,75 unit of account per 100 kilogrammes.

Article 2

This Regulation shall enter into force on 1 November 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Proposal for a
REGULATION (EEC) OF THE COUNCIL

amending Regulation (EEC) No 3209/73 on the subsidy for olive oil.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 136/66/EEC⁽¹⁾ of 22 September 1966 on the establishment of a common organization of the market in oils and fats, as last amended by Regulation (EEC) No 1707/73⁽²⁾, and in particular Article 10 (2) thereof;

Having regard to Council Regulation No 162/66/EEC⁽³⁾ of 27 October 1966 on trade in oils and fats between the Community and Greece, and in particular Article 8 thereof;

Having regard to the proposal from the Commission;

Whereas Council Regulation (EEC) No 3209/73⁽⁴⁾ of 27 November 1973, on the subsidy for olive oil, adopted the principles according to which the subsidy referred to in Article 10 of Regulation No 136/66/EEC should be granted to olive oil producers for the 1973/1974 marketing year; whereas these principles should cover the 1974/1975 marketing year;

Article 1

In Article 1 of Regulation (EEC) No 3209/73 the phrase "for the 1973/1974 marketing year" shall be replaced by the phrase "for the 1973/1974 and 1974/1975 marketing years".

Article 2

The following paragraph shall be added to Article 2 of Regulation (EEC) No 3209/73 :

"When the cultivation declarations have already been registered for preceding marketing years, they shall likewise be valid for the 1974/1975 marketing year except if the producer's farm has undergone such changes as would alter its potential for producing olives and oil."

Article 3

The second subparagraph of Article 7 of Regulation (EEC) No 3209/73 shall be replaced by the following :

"- compare the information given in the last cultivation declaration submitted by each person concerned with the information contained in the oil register or, if this is not available, in the previous cultivation declaration."

Article 4

This Regulation shall enter into force on 1 November 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
