## Proposal for a

#### COUNCIL REGULATION

emending the Annex to Regulation (EEC) No 2824/72 laying down general rules for the financing of interventions by the Guarantee Section of the European Agricultural Guidance and Guarantee Fund

#### EXPLAMATORY MEMORANDUM

1. Article 3 of Regulation (EEC) No 729/70 provides that the Council is to lay down general rules for the financing of intervention by the Guarantee Section of the EAGGF. The Council accordingly listed in the Annex to Regulation (EEC) No. 2824/72 the measures which constitute intervention intended to stabilize agricultural markets. That Annex , which was drawn up at the end of 1972, has been brought up to date twice, by Regulations (EEC) Nos 3536/73 and 330/74. However, a number of agricultural measures have been adopted since that time. Some of these measures provide for intervention to stabilize agricultural markets and have not yet been included in the Annex to Regulation (EEC) No. 2824/72. They are :

- (a) Commission Regulation (EEC) No. 723/74 concerning aid to Irish pig producers
- (b) Council Regulation (EEC) No. 1067/74 on the common organization of the market in dehydrated fodder;
- (c) Council Regulation (EEC) No. 3576/73 introducing subsidies for wine products similar to "Cyprus sherry" produced in the Community.
- (d) Commission Regulation (EEC) No. 1159/74 on aid for private storage in the pigmeat sector on account of the health situation in Belgium.

It is therefore proposed to add those measures to the Annex to Regulation (EEC) No. 2824/72.

## Financial effects

This proposal does not introduce any new measures, it merely adds to the Annex to Regulation (EEC) No. 2824/72 intervention measures which have been adopted since that Annex was last brought up to date. Accordingly, this proposal involves no new expenditure or income.

THE COUNCIL OF THE EUROPEAN COMFUNITIES,

Having regard to Council Regulation (EEC) No.  $729/70^{(1)}$  of 21 April 1970 on the financing of the common agricultural policy, as last amended by Regulation (EEC) No.  $2788/72^{(2)}$ , and in particular Article 3(2) thereof;

Having regard to the proposal from the Commission;

Whereas the Annex to Council Regulation (EEC) No.  $2824/72^{(3)}$  of 28 December 1972 laying down general rules for the financing of interventions by the Guarantee Section of the European Agricultural Guidance and Guarantee Fund, as last amended by Regulation (EEC) No.  $330/74^{(4)}$ , lists the measures which constitute intervention intended to stabilize the agricultural markets within the meaning of Article 3(1) of Regulation (EEC) No. 729/70; whereas since the last amendment of that Annex certain measures have been adopted which provide, in respect of the financing of the common agricultural policy, for intervention to stabilize agricultural markets; whereas that Annex should therefore be extended;

HAS ADOPTED THIS REGULATION :

## Article 1

The Annex to Regulation (EEC) No. 2824/72 is amended as follows :

1. In Section VI "Pigmeat" the following points are added :

- "3. The aid to pig producers provided for in Article 1 of Regulation (EEC) No. 723/74.
- 4. Any private storage aid granted under Article 20 of Regulation No. 121/67/EEC".
- 2. In Section VIII "<u>Wine</u>" the phrase "and in Article 4 of Regulation (EEC) No. 3576/73" is added to point 5.

3. Section XV "Provisions concerning various sectors" becomes Section XVI.

- 4. The following section is inserted : "XV. <u>Dehydrated fodder</u>
  - The production aid provided for in Article 3 of Regulation (EEC) No. 1067/74".

#### Article 2

This Regulation shall enter into force on the third day following its publication in the <u>Official Journal of the European Communities</u>.

. It shall apply with effect from 1 January 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
