Proposal for a
REGULATION (EEC) OF THE COUNCIL

extending the common liberalisation list
annexed to Council Regulation (EEC) No
1439/74 on common rules for imports

(submitted to the Council by the Commission)

Explanatory Statement

1. The Council of the European Communities, by Regulation (EEC) No. 1439/74 of 4 June 1974 (1), established a list of those products the importation of which into the Community is liberalised.

2. In Article 2 thereof, the Regulation provided that the Council may, acting by a qualified majority on a proposal from the Commission, decide to include other products on the common liberalisation list if it considers that such action is not liable to create a situation where the application of protective measures would be justified.

3. The Commission has ascertained that a number of products, which are not yet included in the list, have been liberalised by all the Member States. It considers, therefore, that it would be convenient to include them thereon, since the conditions set out in Regulation (EEC) No. 1439/74 have been fully met. In effect, the import rules (liberalisation) are the same for all nine countries of the Community and there is no danger that a situation justifying the application of protective measures is liable to arise, at least in the near future.

4. The Commission proposes, therefore, the inclusion of these products in the list contained in Annex I of Regulation (EEC) No. 1439/74. In future, this list will comprise 996 C.C.T. positions, i.e. 934 complete positions and 62 partial positions, out of a total of 1091 positions covered entirely or partially by the EEC Treaty.

5. Also, the Commission proposes that, in column 4 of the aforesaid list, those Member States which apply national surveillance to the new products thereon should be indicated. This information, which is not yet available, will be requested from Member States during the discussions on this proposal.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No. 1439/74 of 4 June 1974 on common rules for imports (1), and in particular Article 2 thereof;

Having regard to the proposal from the Commission;

Whereas certain products not yet included in the common liberalisation list annexed to Regulation (EEC) No. 1439/74 have been liberalised by all Member States;

Whereas their inclusion in the aforementioned list is not liable to create a situation where the application of protective measures would be justified;

Whereas, therefore, it would be convenient to include these products on the said list and to state that they are subject to national surveillance measures taken by Member States, if such be the case;

HAS ADOPTED THIS REGULATION :

Article 1

The products indicated in the Annex to this Regulation shall be included in the common liberalisation list contained in Annex I to Regulation (EEC) No. 1439/74.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
