COMMUNICATION FROM THE COMMISSION TO THE COURCIL

concerning the final estimates for the 1979/80 wine-growing year

Purcuant to Article 5(3) of Regulation (EEC) No 337/79, "For each wine-growing year, the Commission shall provide the Council with final estimates of Community resources and uses in the preceding wine-growing year".

The final estimates for the 1979/80 wine-growing year are annexed to this Communication.

Compared with the 1978/79 estimates, it can be seen that:

- overall production increased by about 39.1 million hl;
 imports from non-member countries decreased by 0.4 million hl;
 imports to non-member countries rose by some 2.4 million hl;
- processing increased by about 19.0 million hl; of which 16.6 million as a result of Community intervention;
- - direct human consumption increased by about 2.1 million h1;
 - stocks at the end of the wine-growing year increased by about 16.0 million hl;
 - per capita consumption increased by 0.7 litres.

The Community harvest of 177.171.000 hl in the autumn of 1979 was 19.375.000 hl more than total domestic uses.

Total domestic uses, including quantities distilled pursuant to Regulation (EEC) No 337/79, rose by about 21.9 million hl.

Excluding the quantities affected by the distillation measures, total domestic uses rose by 5.3 million hl.
