Explanatory memorandum

- 1. In so far as it is laid down in the Treaty of Rome, the French overseas departments are subject to its provisions. In accordance with the first subparagraph of Article 227 (2) of the Treaty, the provisions concerning the European Agricultural Guidance and Guarantee Fund do not apply to the French overseas departments. However, the second subparagraph of this Article states that the conditions under which provisions of the Treaty not already covered by the first subparagraph are to apply shall be determined by decisions of the Council, acting unanimously on a proposal from the Commission. This is therefore also true of the provisions relating to the EAGGF.
- 2. The economic structure of the French overseas departments is essentially agricultural. Moreover, agriculture in these departments suffers from certain natural disadvantages, in particular the climatic conditions and the distance from Community markets.

It therefore appears desirable to extend the field of application of the Guidance Section of the EAGGF to these departments in order to allow them to improve their agricultural structure with the aid of the Community, in particular with regard to the principle laid down in the third subparagraph of Article 227 (2) of the Treaty which lays down that "the economic and social development of these areas (should be) made possible".

3. Since the agricultural structure of the French overseas departments needs to be improved, it appears desirable to allow them to receive Community aid as soon as possible and to make provisionifrom 1975 onwards: for applications for aid for projects designed to improve agricultural structures, within the meaning of Regulation No 17/64/EEC. Regulation (EEC) No 1215/75 fixed 1.Jung 1975 as the final date for the submission of applications for aid for 1975. It is therefore necessary to make provision for a derogation in respect of projects in the French overseas departments.

THE COUNCIL OF THE EUROPEAN COMMUNITIES. Having regard to the Treaty establishing the European Economic Community. and in particular Articles 43 and 227 thereof ; Having regard to the proposal from the Commission ; Having regard to the Cpinion of the European Parliament : Whereas the field of application of the Guidance Section of the Rerowan Appicultural Guidence and Guarantee Fund should be extended to include the French overseas departments so that they may receive the Community aid for the improvement of agricultural structures provided for in Article 6 of Council Regulation (EEC) No 729/70 of 21 April 1970 on the financing of the common agricultural policy, as last amended by Regulation (EEC) No 2783/72 and thus promote the economic and social development of these areas which care basically agricultural; Whereas the activities of the Guidance Section should be extended as to the Frehen oversees departments as soon as possible; whereas provision should be made for applications for aid under Council Regulation No 17/64/EEC of 5 February 1964 on the conditions for granting aid from the European Agricultural Guidance and Guarantee Fund, as last amended by Regulation (EEC) No 2684/74 to be submitted in 1975; whereas a derogration must therefore be made from the final date for the submission. ¹ OJ No L 94, 28 April 1970, p. 13 ² OJ No L 295, 30 December 1972, p. 1 ³ OJ No L 34, 27 February 1964, p. 586/64

of such applications laid down by Council Regulation (IEC) No 1215/75⁽¹⁾ of 5 May 1975 on the allocation for 1974 of appropriations from the Guidance Section of the European Agricultural Guidance and Guarantee Fund and deferring certain final dates for the years 1974 and 1975, HAS ADOPTED THIS REGULATION :

Article 1

Article 40 (4) of the <u>ZEO Treaty shall apply</u> to the French overseas departments as reparts the Guidance Section of the European Agricultural Guidance and Guarantee Fund is concerned.

<u>Article 2</u>

The final date for the submission of applications for aid under Regulation No 17/64/EEC, laid down for 1975 in Article 3 of Regulation (EEC) No 1215/75, is hereby deferred until 31 December 1975 in respect of projects to be carried out in the French overseas departments.

<u>Article 3</u>

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities. This Regulation shall be binding in its entirety and directly applicable in all Member States.

OBSERVATIONS

a) To determine the financial effect of extending the field of action of the E.A.G.G.F. Guidance Section to the D.O.M.'s it is useful to compare both the Utilised Agricultural area and also the Total Active Agricultural population of the D.O.M.'s with that of the Nine.

For the sake of this calculation the increase incurred by the addition of the D.O.M.'s to the Community of Nine is taken as Q.5%.

- b) Budgetary effects of the inclusion of the D.O.M.'s
 - 1. Chapter 80, Regulation No. 17/64/EEC : projects financed in the D.O.M.'s shall be treated as applications from France and shall be subject to the constraints of the limited finance for this regulation.
 - 2. Chapter 81 Common actions in the field of the reform of agricultural structures.

The effect of the inclusion of the D.O.M.'s will be to increase by a $\frac{1}{2}$, the provisions :

- c) Considering the level of imprecision in estimating the expenditure on Common Actions, it is not necessary to modify the proposed Budget for 1976 to take into account this additional expense. In future years, the inclusion of the D.O.N.'s within the field of application of E.A.G.G.F. Guidance Section will be taken into consideration when establishing future budgets.
- d) The estimated cost of this action over the next four years is 2.8 mua.
