IRON AND STEEL PROBLEMS -AID

The Council took note of the reports from Mr VOUEL and Mr DAVIGNON, Commissioners, on their contacts with certain Member States in an effort to resolve the remaining problems standing in the way of Community rules for aid to the iron and steel industry.

The Council welcomed the decisive progress made in this respect and noted that, once the internal procedures in certain Member States had been completed, there was no further major obstacle to a final decision by the Council at a forthcoming meeting on the consent requested by the Commission to the draft Decision establishing Community rules for specific aids to the iron and steel industry

PORUGAL

In the light of information provided at the meeting by Viscount DAVIGNON, the Council requested the Commission to ascertain the current situation and possible developments in the motor vehicle industry in Portugal.

The Commission was requested to report back to the Permanent Representatives Committee which will examine the problems still outstanding as quickly as possible with a view to providing the Commission with directives for the negotiation of an Additional Protocol to the EEC-Portugal Free Trade Agreement of 1972.

SPANISH ACCESSION NEGOTIATIONS

The Council prepared the second session of the negotiating Conference on the accession of Spain to the Community, which was held on the same day.

GATT

Pursuant to the Commission's talks with the Government of Thailand and following an exchange of views on the problem of imports of manioc into the Community, the Council noted that the Commission would be submitting proposals concerning the negotiation of a voluntary restraint agreement with Thailand, and the various problems posed by such an agreement, for its next meeting and agreed to give an opinion on the substance of the whole file on the basis of these proposals.

The Council also agreed to the Commission embarking on exploratory talks with the United States with a view to the advance implementation of the Agreement on trade in civil aircraft negotiated as part of GATT trade negotiations, and it agreed to give an opinion on the substance of this matter before the end of September on the basis of the report to be submitted by the Commission.

ISRAEL

The Council held a detailed discussion on the negotiations with Israel under Article 22 of the Agreement (review clause) and instructed the Permanent Representatives Committee to continue its study of the matter in the light of this discussion.

EMERGENCY AID

The Council was informed by the Commission of the implementation of the decisions taken by the Council on¹ 24 July 1979, following the Geneva Conference, on aid for refugees from South East Asia and for the people of Cambodia, and also on action taken to aid Nicaragua following the typhoon which recently devastated that country.

INTERNATIONAL CONVENTION ON THE PHYSICAL PROTECTION OF NUCLEAR MATERIALS

The Council gave the Commission the directives which will enable it to negotiate in Vienna, on behalf of the Community, the International Convention on the Physical Protection of Nuclear Materials.

EURATOM-AUSTRALIA RELATIONS

The Council also gave the Commission the negotiating directives for the conclusion with the Australian Government of an agreement concerning imports of Australian uranium into the Community.

CHAPTER VI OF THE EURATOM TREATY

The Council, which had before it a Commission communication on the supply of nuclear fuel to the Community and a French memorandum on the amendment of Chapter VI of the Euratom Treaty, held a policy debate on the issues raised by these two documents. The discussions enabled the delegations to outline their initial reactions to the documents in question and their basic approach to the question of the future supply of nuclear fuel to the Community.

The Council noted that for the purpose of examining the problems at issue the Commission would seek the assistance of a group of high-level independent experts and that following this it would submit a report to the Council, accompanied by any proposals it considered appropriate.

Trade policy

The Council adopted in the official languages of the Communities the decisions

- authorizing the extension or tacit renewal of certain trade agreements concluded by Member States with third countries;
- on the cancellation of the quantitative restrictions on the importation into Italy of certain products falling within headings 27.10, 27.11 and 27.14 of the Common Customs Tariff and originating in Romania.

The Council also adopted in the official languages of the Communities the Regulation adjusting national shares in respect of certain quantitative limits on imports of textile products originating in third countries.

Other decisions

The Council adopted in the official languages of the Communities the Directive amending for the sixth time the Council Directive of 27 June 1967 on the approximation of the laws of the Member States relating to the classification, packaging and labelling of dangerous substances, the decision of principle on this subject having already been taken on 19 June 1979 (see Press Release 7583/79 (Presse 75) of that date).

The Council agreed to the signing by the Community of the Convention on the conservation of European Wildlife and Natural Habitats (Convention of the Council of Europe). The signing - with regard to the spheres within the competence of the Community - will take place on 19 September 1979 at a meeting of the Ministers for Environment of the member countries of the Council of Europe in Berne.

Appointment

On a proposal from the Danish Government, the Council appointed Mrs Anny Elisabeth HANSEN, adviser to the "Dansk Sygeplejeråd", an alternate member of the Advisory Committee on Training in Nursing, to replace Mrs Greta AHLSTRØM for the remainder of her term of office, which runs until 14 January 1982.

FOREIGN AFFAIRS COUNCIL - ATOMIC QUESTIONS (R. ELPHICK)

THE COUNCIL RECORDED CONSIDERABLE PROGRESS IN THREE PROBLEMS WHICH HAVE BEEN SUBJECTS OF CONTROVERSY FOR YEARS - UPDATING CHAPTER SIX OF THE EURATOM TREATY, AND THE MANDATES FOR PARTICIPATING IN THE CONVENTION ON PHYSICAL PROTECTION IN VIENNA, AND FOR DRAWING UP A FRAMEWORK AGREEMENT WITH AUSTRALIA.

THE KEYNOTE WAS SET BY M. FRANCOIS-PONCET OF FRANCE WHO PRESENTED HIS COUNTRY'S MEMORANDUM WHICH SEEKS A MODIFICATION OF THE SUPPLY CHAPTER OF THE TREATY TO BRING IT MORE INTO LINE WITH PRESENT DAY REALITY. FOR THE COMMISSION MR BRUNNER WELCOMED THE FRENCH PRESENTATION, REMINDED THE COUNCIL THAT THE COMMISSION ALSO HAD PROPOSALS ON CHAPTER SIX ON THE TABLE, AND SAID HE NOW FELT A CERTAIN SOBER OPTIMISM AT THE PROSPECTS OF SOME POSITIVE OUTCOME. OTHER DELEGATIONS SHARED THE DESIRE [REDACTED], AS THE UNITED KINGDOM MINISTER PUT IT, OF TACKLING THE GAP BETWEEN LAW AND REALITY, ALTHOUGH OTHERS LIKE THE NETHERLANDS AND LUXEMBURG EXPRESSED RESERVATIONS ABOUT CHANGING TREATY REQUIREMENTS. THE SETTING UP OF AN AD HOC HIGH LEVEL GROUP TO ADVISE THE COMMISSION ANNOUNCED BY MR BRUNNER WAS WELCOMED GENERALLY AND THE [REDACTED] COUNCIL WILL RETURN TO THE PROBLEM IN DUE TIME.

THE GOOD ATMOSPHERE, EVINCED DURING THIS FIRST ORIENTATION DEBATE ON CHAPTER SIX, ENCOURAGED MR BRUNNER TO SUGGEST ADDING THE QUESTION OF THE AUSTRALIAN MANDATE TO THEIR DISCUSSION. HE EXPLAINED THAT ON THE PROBLEM OF COMMUNITY PARTICIPATION IN THE TALKS ON AN INTERNATIONAL CONVENTION ON PHYSICAL PROTECTION, HE WISHED TO STATE FOR THE RECORD THAT THE COMMISSION HAD NO, REPEAT NO INTENTION [REDACTED] OF MIXING IN ANY WAY IN AFFAIRS SUCH AS POLICE PROTECTION WHICH WAS EXPRESSLY AND EXCLUSIVELY THE AFFAIR OF INDIVIDUAL MEMBER STATES. THAT SAID, FRANCE WITHDREW ITS RESERVE AND THE COMMUNITY WILL NOW BE ABLE TO TAKE PART IN THE NEGOTIATIONS WHICH ARE SET TO RESUME IN VIENNA ON 15 OCTOBER.

THE FINAL PROBLEMS WITH THE AUSTRALIAN MANDATE WERE ALSO CLEARED AWAY WITH DISPATCH WITH THE SIMPLE DELETION OF REFERENCES TO BI-LATERAL OR PARALLEL AGREEMENTS IN THE PREAMBLE. THEREFORE AFTER NEARLY TWO YEARS THE COMMISSION CAN NOW BEGIN THE NEGOTIATIONS PROPER.
