DANISH "GREEN" KRONE

The Council adopted the Commission proposal for a Regulation amending Regulation No 878/77 on the exchange rate to be applied in agriculture to the Danish krone. The aim of this Regulation is to align the "green" krone on the official rate following the recent devaluation of the Danish krone, and will consequently avoid the application of monetary compensatory amounts to Denmark.

The following table indicates the effects of this measure:

In addition, Mr GUNDELACH referred to the undertaking which the Commission had already entered into to submit a fresh proposal in the agri-monetary sector at the beginning of October. He said that the Commission would also submit the result of the examination it had made of the problems of distortion of competition arising from the system of compensatory amounts.

WINE MARKET

The Council took note of a statement by the French delegation, which the Italian delegation endorsed, concerning the wine market situation and the measures to be taken to alleviate difficulties as a result of the 1977 harvest.

The French Government had asked the Commission to examine all the measures which might be taken pursuant to Article 38 of the basic wine regulation, including the granting of aid for the use of concentrated musts to enrich the 1977 wine harvest.

Mr GUNDELACH informed the Council of the need for essential additional information before the Commission could state its conclusions in the matter.

HOP MARKET

The Council took note of a statement by the German delegation, endorsed by the Belgian delegation, concerning the situation in the hop market and the measures to be introduced to alleviate the difficulties which had arisen.

The Commission announced its intention, not only of forwarding to the Council in the near future a proposal for implementing the structural arrangements already contemplated, but also of bringing forward the submission of its report on aid in this sector.

MILK

The Council briefly considered a number of questions connected with the implementation of its decision concerning the co-responsibility levy in the milk products sector. It agreed to return to the subject at its next meeting on 26 and 27 September 1977 on the basis of a Commission report.

MISCELLANEOUS DECISIONS

The Council adopted the Regulation concluding an agreement with Austria, under Article XXVIII of the GATT, on the unbinding by that country of the tariff concessions for cheese.

The Council adopted, in the official languages of the Communities, the Decision setting up a consultation procedure on relations between Member States and third countries in shipping matters and on action relating to such matters in international organization.

- Mr O.J. MIKKELSEN, Direktoratet for Erhvervsuddannelserne, to replace J.A. MORTENSEN, full member, who has resigned, for the remainder of their terms of office, i.e. until 20 June 1978.

Acting on a proposal from the United Kingdom Government, the Council appointed Mr A.B. MARTIN, Health and Safety Executive, as a full member of the Advisory Committee on Safety, Hygiene and Health Protection at Work to replace Mr D. RICHARDSON, full member, who has resigned, for the remainder of his term of office, i.e. until 4 May 1978.

Acting on a proposal from the Irish Government, the Council appointed Mr H.J. CURLIS, General and Municipal Workers' Union, as a member of the Economic and Social Committee to replace Mr B.G. HARKIN, member, who has resigned, for the remainder of his term of office, i.e. until 16 September 1978.

Acting on a proposal from the Danish Government, the Council appointed Mr Morten Kjaergaard HANSEN as an alternate member of the Advisory Committee on Medical Training to replace Mr SCHIØLLER, alternate, for the remainder of his term of office, i.e. until 5 April 1979.

LE CONSEIL A ADOPTE LA PROPOSITION DE LA COMMISSION VISANT A DEVALUER DE 5 0/0 LE TAUX DE LA COURONNE DANOISE VERTE. LE NOUVEAU TAUX (1 DKR = 0,116733 UC AU LIEU DE 0,122877) ENTRERA EN VIGUEUR LE 16 SEPTEMBRE PROCHAIN SAUF POUR LES PRODUITS DONT LA CAMPAGNE N'A PAS ENCORE COMMENCE (P.EX.
