PROPOSAL FOR A COUNCIL REGULATIONS (EEC)

amending Regulation (EEC) No 1721/81, opening, allocating
and providing for the administration of a Community tariff quota
for certain wines having a registered designation of origin,
falling within subheading ex 2205 C of the Common Customs Tariff
and originating in Morocco (1981/82)

EXPLANATORY MEMORANDUM

On the basis of Article 21 of the Cooperation Agreement between the Community and Morocco the Council opened for ^{1981/82} by means of its Regulation (EEC) n° 1721/81 for the import into the Community of Nine a Community tariff quota of 50 000 hectolitres of certain wines having a registered designation of origin and originating in Morocco.

From the entry into force of Regulation (EEC) n° /81 of the Council laying down the arrangements applicable to trade between the Hellenic Republic and Morocco (1), Greece is required to apply this tariff measure. An amendment to the abovementioned regulation is therefore required.

(1) This regulation provides for an anticipatory application of the provisions of the Adapting Protocol to the Agreement EE/Morocco.

THE COUNCIL OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas the Community opened by Regulation (EEC) No 1721/81⁽¹⁾ a Community tariff quota for the importation into the Community of Nine of certain wines having a registered designation of origin and originating in Morocco; whereas Regulation (EEC) No ⁽²⁾ provides that, from its entry into force, Greece is required to apply this tariff measure; whereas Regulation (EEC) No 1721/81 should therefore be amended,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 1721/81 is hereby amended as follows:

This Regulation shall be binding in its entirety and directly applicable in all Member States.

1. The following sentence shall be added at the end of Article 1 (2):

'Within this tariff quota, Greece shall apply customs duties calculated in accordance with the relevant provisions of the 1979 Act of Accession and of Regulation (EEC) No /81.'

2. The following paragraph shall be added to Article 2:

4. If Greece should find that there is a demand for the product in question, it shall draw an appropriate share from the reserve in so far as the level of the reserve permits.'

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.
