On 18 May 1983 the European Parliament adopted the decision granting the discharge for the 1981 financial year, but deferred the decision on the final discharge to the accounting officer for that year.

The rapporteur, Mr Saby, was instructed by the Committee on Budgetary Control on 28/29 April 1983 to carry out the work requested by the European Parliament.

At its meeting on 28 March 1984 the Committee on Budgetary Control considered the draft report and adopted the discharge decision by 19 votes to six.

#### The European Parliament

- Grants the final discharge to the accounting officer of the institution in

respect of the 1981 financial year and stresses that:

- 1. it is necessary for the respective independence of the authorizing officer, the financial controller and the accounting officer to be specified in the financial regulation and the internal rules;
- data-processing equipment and operational terminals must be installed as a matter of urgency in the Members' cash offices in Strasbourg and Brussels.
