

## EUROPEAN PARLIAMENTARIANS TO VISIT WASHINGTON

Nineteen members of the European Community's Parliament are to meet with members of the U.S. Congress and administration next week in the 14th annual exchange visit between Congress and the European body.

The four-day visit holds particular significance as the final one in which members of the delegation are appointed from and by their national parliaments to the European Parliament. In June this year, in the world's first international elèctions, more than 175 million voters in the nine nations of the Community will directly elect 410 representatives to the European Parliament.

The delegation will be led by Mario Zagari, vice president of the European Parliament and an Italian Socialist who was for 20 years editor of a magazine called "The European Initiative." In addition to Zagari, the delegation is made up of two other deputies from Italy, four from Britain, four from Germany, three from France, two from the Netherlands, two from Ireland and one from Denmark. Luxembourg and Belgium are not represented.

In the Parliament, deputies are grouped according to political rather than national lines. According to these distinctions, the delegation includes six Socialists, five Christian-Democrats, two Conservatives, two Communists, two Liberals and two Progressive Democrats. Seventeen officials of the Parliament's Secretariat are also traveling with the delegation.

U.S. organizers of the visit are Representative Clement Zablocki, (D-Wis.), who heads the House Committee on International Relations; Representative Sam Gibbons, (D-Fla.), a member of the House Ways and Means Committee; and Representative Larry Winn, (R-Ks.), a member of the House Committee on International Relations.

A parliamentary exchange between European deputies and members of the U.S. Congress has taken place regularly since 1972, when a group of legislators from the United States first visited Luxembourg, the site of the European Parliament's Secretariat. The Parliament divides its meetings between Luxembourg and Strasbourg, France. In April last year a U.S. delegation of eight congressmen met with their European counterparts in Sicily.

Next week's meetings with U.S representatives include three plenary sessions, the first at 9:30 a.m. Tuesday in the Rayburn House Office Building. Topics scheduled for discussion are multilateral trade negotiations, energy policy, the international monetary situation and the European Monetary System, the situation in the Middle East and Iran, human rights issues and U.S. and EC relations with African nations.

Meetings have been arranged for the delegation with administration officials on Thursday and Friday. Among those whom the European deputies will see are Secretary of Energy James Schlesinger, Presidential Adviser on National Security Affairs Zbigniew Brzezinski, Under Secretary of State for Political Affairs David Newson, Assistant Secretary of the Treasury for International Affairs C. Fred Bergsten, Chairman of the President's Council of Economic Advisers Charles L. Schultze, Special Trade Representative Robert S. Strauss and Assistant Secretary of Agriculture for International Affairs Dale Hathaway.
