EC LEGISLATORS ARRIVE SUNDAY FOR TALKS WITH US CONGRESS AND OFFICIALS


WASHINGTON -- September 10 -- A delegation from the European Parliament arrives in Washington Sunday for the second round of three-day talks this year with their American counterparts and for meetings with Secretary of State Henry A. Kissinger and other US officials.

The 14-member group will be led initially by Acting President of the EP delegation Pierre-Bernard Cousté. Georges Spénale, the Parliaments's President, will take over when he arrives Tuesday, following the expected signing in Brussels of a convention providing for election of the Parliament's members by direct universal suffrage (see Background Note 39).

A list of EP delegation members and biographical sketches is annexed to this release.

On the American side, the visit was organized by Representative Donald M. Fraser (D-Minn.), chairman of the House Subcommittee on International Organizations, subcommittee members Representative Benjamin S. Rosenthal (D-NY), and Representative Paul Findley (R-III.), and by Representative Sam Gibbons (D-Fla.), member of the Ways and Means Committee.

The first official EC-US parliamentary exchange took place in January 1972, when Congressmen went of Luxembourg, site of the European Parliament's Secretariat. The exchange now occurs twice a year, with one meeting on each side of the Atlantic.



Topics of Discussion

A major topic on the agenda will be a discussion of ways the European Community and the United States could, through their political and economic relations with other countries, promote democratic development and respect for human rights. US and European foreign policies of the past will be examined to see what lessons they hold for the future. The legislators will also debate whether the principle of non-interference in other countries internal affairs should preclude any serious attempts to foster democratic development and respect for human rights.

A "Draft Code of Principles on Multinational Enterprises and Governments" will also be reviewed. This code, presented and amended at the April meetings in Dublin, was the outgrowth of previous discussions between the US and the EC legislators.

Other Appointments

The Europeans are scheduled to meet with Secretary of State Henry A. Kissinger, Speaker of the House Carl Albert (D-Okla.), President of the American Federation of Labor and Congress of Industrial Organizations George Meany, President of the US Chamber of Commerce Richard Lesher, Secretary of Commerce Elliot L. Richardson (or, in his absence, Under Secretary of Commerce Edward Vetter), Deputy Secretary of the Treasury George H. Dixon, Treasury Under Secretary for Monetary Affairs Edwin Yeo, Treasury Assistant Secretary for International Affairs Gerald Parsky, Chairman of the President's Council of Economic Advisers Alan Greenspan, and Ambassador Clayton Yeutter, Deputy Special Representative for Trade Negotiations.

Visit to Illinois

On September 23, members of the EC delegation will fly to Springfield, Illinois, where they will attend a reception given by Governor Daniel Walker. On September 24, the Europeans will attend a banquet, to be addressed by President Gerald R. Ford, given by the Illinois Press Association. The EC delegation will return to Europe on September 25th.
