Unless the Assembly decides to the contrary, they cannot be put to the vote until they have been printed and distributed in the official languages.")

Amendment No. 1 was rejected.

The preamble to the Resolution moved and the whole of paragraphs 1, 2 and 3 were adopted.

Paragraph 4 remained deleted.

Paragraph 5 was adopted and became paragraph 4.

The Assembly adopted the whole of the Resolution moved, in the following wording:

RESOLUTION

concerning

the setting-up of a Working Party, under the Resolution adopted on December 2, 1954.

"THE COMMON ASSEMBLY.

- "having regard to the Resolution adopted by it on December 2, 1954, concerning the powers of the Common Assembly and the manner in which they are to be exercised,
 - "(1) decides to set up a Working Party of some 26 members, ranking as a special temporary Committee, to report to the Assembly upon the questions enumerated in Part V of the aforementioned Resolution;
 - "(2) instructs the Bureau to lay before the Assembly proposals worked out in consultation with the Bureaux of the General Committees and the political groups concerning the membership of the Working Party. These proposals shall first be submitted to the Committee of Presidents augmented by the Presidents of the political groups;
 - "(3) requests the Working Party to forward to the Bureau the Reports referred to in Part V (a) of the aforementioned Resolution concerning the agreements to be concluded with various international organizations;
 - "(4) empowers the Bureau to authorize the Working Party to undertake, in consultation with the Committee of Presidents, a detailed study of the questions referred to in Part V (b) of the aforementioned Resolution where this is necessary for the progress of the work, and in the event of such a step to organize the contacts between the Working Party and the General Committees."

DEBATE ON THE REPORT BY M. von MERKATZ,

on behalf of the Committee on the Rules of Procedure of the Common Assembly, Petitions and Immunities, on the desirability of investing one of the Committees of the Assembly with competence to issue legal opinions on the interpretation and application of the provisions of the Treaty in so far as these provisions relate to the Assembly's exercise of its powers (Document No. 24).

M. MOTZ, Vice-President, took the Chair in place of M. FOHRMANN.

M. MOTZ, Vice-President, in the Chair.

Speakers: M. von MERKATZ, Rapporteur, Mlle. KLOMPE, MM. Van der GOES van NATERS, WIGNY, FAYAT and KOPF.

The general debate was closed.

MM. WIGNY and Van der GOES van NATERS spoke to Amendment No. 1.

Amendment No. 1 was rejected.

Mlle. KLOMPE spoke to the Draft Resolution considered as a whole.

The Assembly adopted the whole of the Resolution moved, in the following wording:

RESOLUTION

concerning

the investing of the Committee on the Rules of Procedure of the Common Assembly, Petitions and Immunities with competence to issue legal opinions on the interpretation and application of the provisions of the Treaty in so far as these provisions relate to the Assembly's exercise of its powers.

"THE COMMON ASSEMBLY.

- "in accordance with Article 35 of the Rules of Procedure;
- "as a supplement to its Resolution No. 4, of January 10, 1953;
- "in view of the many legal points which have arisen and are continuing to arise in the course of the Assembly's proceedings and those of its Committees;
 - "with a view to the more effective accomplishment of its tasks;

"DECIDES

"to empower the Committee on the Rules of Procedure of the Common Assembly, Petitions and Immunities to issue legal opinions on the interpretation and application of the provisions of the Treaty, in so far as these provisions relate to the Assembly's exercise of its powers, and to transmit such opinions to the petitioning Committee or to the Assembly. The Committee will in future be known as "the Committee on Legal Questions, Rules of Procedure of the Common Assembly, Petitions and Immunities."

"Whenever the Committee meets to examine legal questions, it shall co-opt for purposes of deliberation a spokesman on behalf of each of the different views put forward. These representatives shall be entitled to speak in an advisory capacity.

"The opinions issued by the Committee on legal questions submitted to it by another Committee of the Assembly, or by the Assembly itself, shall not be binding, and shall not be taken as establishing any kind of precedent."

RESOLUTION

concerning

the Auditor's Report for the second financial year (July 1, 1953-June 30, 1954).

"THE COMMON ASSEMBLY

"notes the Auditor's Report concerning the second financial year, ending June 30, 1954;

"approves that Report and the observations of the Budgeting and Administration Committee;

"adopts the accounts of the Secretary-General and Secretariat for the financial year 1953-54, closed at Bfr. 46 862 771.55;

"proposes that the Committee of Presidents requests the Auditor to see that his Report on the accuracy of the accounting and financial administration of the institutions of the Community is confined to this specific objective, while leaving him free to provide the Committee of Presidents with such additional information as he may think fit, in the form of special analyses and reports on particular questions;

"considers that, in the interests of proper Parliamentary procedure, the time-limit set for the submission of the Auditor's Report under Article 78, paragraph 6 of the Treaty establishing the European Coal and Steel Community must be respected."

RESUMPTION OF THE DEBATE

on Report No. 15 and supplementary Report No. 36, presented by M. KAPTEYN.

The Assembly adopted the following Resolution:

RESOLUTION

concerning

transport problems in the Community

"THE COMMON ASSEMBLY

"stresses once again the particular importance of the transport problem not only for the development of the Community, but also for the integration of the European economy;

"notes with satisfaction the progress made by the High Authority during the past year, in co-operation with the Governments, and in particular the introduction of tapering international through-rates;

"points out, nevertheless, that quick action is called for in regard to the abolition of disparities in inland water-transport rates and discriminations in coastal shipping and road haulage, in order to prevent detrimental and persistent repercussions on the Common Market;

"requests the Council of Ministers, accordingly, to invite the Governments to intensify their co-operation in this field with the High Authority, in order to arrive at a solution with the least possible delay. Close co-operation of this kind is particularly necessary inasmuch as the Treaty, while clearly stipulating that these disparities and discriminations must be done away with, does not invest the High Authority with adequate powers for doing so. Care must also be taken, in the endeavour to work out such a solution, lest there come into being organizations amounting to cartels outside the jurisdiction of the High Authority.

"THE COMMON ASSEMBLY.

"in the conviction that no wholly satisfactory solution to the problem of transport in the Community can be found unless the whole field of transport is progressively co-ordinated and integrated, considers that the harmonization prescribed in Section 10, paragraph 3,3 of the Convention containing the Transitional Provisions should provide the member States of the Community with the opportunity to work for co-ordination and integration also in respect of the transport of those goods which do not come under the Community's jurisdiction, in order, on the one hand, to avoid anomalies in the transport economies of the States, and, on the other, to contribute to the unification of European transport, an aim which amounts to an economic necessity. It holds that, to this end, public opinion should be kept informed as fully as possible.

"THE COMMON ASSEMBLY

- "requests the Special Council of Ministers, accordingly, to recommend to the Governments of the six countries that they adopt the following proposal:
- "A Commission shall be set up, to consist of a limited number of experts who shall not be regarded either as national representatives or as agents for a particular method of transport.

- "The task of this Commission shall be to work out proposals for the co-ordination and integration of European transport as a whole, after consultation with existing bodies specifically dealing with transport.
- "It would be desirable to invite the Governments of Switzerland and Austria to send observers.
- "The Commission shall submit its proposals to the Ministers of Transport, the Special Council of Ministers and the High Authority. It shall keep in touch with the Transport Committee of the Common Assembly.
- "The Common Assembly shall receive from this Commission an annual Report, as well as all draft proposals drawn up by it, and shall debate them in public session, in order to keep both the national Parliaments and public opinion informed concerning the problems to be dealt with.
- "The members of the Commission could be appointed by the Governments from a list of candidates submitted by the High Authority".

General debate was closed.

M. BIRKELBACH spoke on a point of order.

DEBATE ON REPORT No. 39

concerning labour problems, and on proposed Resolutions Nos. 33 and 35, concerning the levy.

M. BIRKELBACH presented a Report on Resolutions Nos. 33 and 35.

Document No. 35 was withdrawn.

Speakers: MM. de SMET and ECKHARDT.

The general debate was closed.

Paragraphs 1—33 of the Resolution submitted by the Social Affairs Committee, as the findings of Report No. 39, were adopted.

MM. MOLLET, MONNET, President of the High Authority, MOLLET, BERTRAND, POHLE, NEDERHORST, SASSEN, KAPTEYN, VIXSEBOXSE and MOLLET spoke to Amendment No. 1.

MM. MOLLET, de MENTHON, CHUPIN and MOLLETT spoke on a point of order.

Amendment No. 1 was put to the vote by roll-call, and rejected by 29 votes to 14 and 2 abstentions (see Annex).

MM. CHUPIN and SASSEN spoke to Amendment No. 2.

MM. POHER and CHUPIN spoke on a point of order.

The Assembly agreed to take Amendment No. 2 as a separate Resolution.

This Resolution (previously Amendment No. 2) was put to the vote by roll-call, and adopted by 13 votes to 9 and 23 abstentions (see Annex), in the following wording:

RESOLUTION

concerning

the reduction in the rate of the levy

"THE COMMON ASSEMBLY

regrets that the decision by the High Authority to reduce the rate of the levy should have been taken before its long-term policy had been debated by the Common Assembly, and in ignorance of the measures which will be taken by the Council of Ministers on June 1".

MM. de MENTHON, MARGUE and BLANK spoke to Amendment No. 2.

MM. POHER, POHLE und de MENTHON spoke on a point of order.

The Assembly agreed to take Amendment No. 3 as a separate Resolution.

This Resolution (previously Amendment No. 3) was put to the vote by roll-call, and rejected by 26 votes to 17 and 1 abstention (see Annex).

The Assembly adopted the following Resolution:

RESOLUTION

concerning social questions

"THE COMMON ASSEMBLY.

- "1. having noted the Reports submitted on behalf of the Committees concerned, and heard the statements of the High Authority on its action in the social field:
- "2. whereas the solution of social problems forms an integral part of the policy of economic expansion which is to raise the standard of living of the peoples of the Community, and to form the basis for the sound construction of the united Europe:
- "3. observes that the solution of these problems, which are constantly growing in acuteness, urgency and importance, is clashing more and more with certain provisions of the Treaty, which are limiting action in the social field within the Community;

as regards the freedom of movement of workers:

- "4. conscious of the fact that the introduction of freedom of movement and freedom of migration for workers will be of considerable assistance in hastening and facilitating the progressive harmonization of the standard of living and of working conditions, and that a broader application of Article 69 will at the same time ensure an increased continuity of employment;
- "5. considers that the interpretation placed by the Governments on Article 69 is unnecessarily restrictive;
- "6. emphasizes the need, while paying due regard to the points brought out in the Report submitted by the Social Affairs Committee (Document 14), to amend Articles 11, 17, 18, 19, 20 and 21 of the decision taken recently, in application of Article 69 of the Treaty, by the representatives of the member States;
- "7. invites its members to take all such action as may be indicated in their national Parliaments, in order that the measures required for the implementation of the above-mentioned decision may be initiated without delay;

as regards readaptation:

- "8. regretting that the steps taken in connection with readaptation have not as yet yielded the results expected;
- "9. asks that all provisions in the Treaty concerning readaptation be applied as extensively and assiduously as possible, and in particular
 - (a) invites the High Authority to make use of all the discretionary powers and exceptions which the text allows, in its application of Section 23 of the Convention and Article 56 of the Treaty;

- (b) recommends that the Council of Ministers, when approached for exceptions under Section 23, paragraph 6 of the Convention and Article 56, paragraph (b) of the Treaty, afford such applications its most sympathetic consideration;
- (c) urges the Governments to notify the High Authority as quickly as possible of all cases calling for the application of Section 23 and Article 56 in their respective countries, and of the studies to be undertaken in accordance with Article 46 regarding possibilities of re-employment, and to see that their financial contribution towards the cost of readaptation, as provided for in the Treaty, is made available as speedily as possible;
- "10. draws the attention of the High Authority to the psychological difficulties involved in the transfer of workers:

as regards occupational training:

- "11. congratulates the High Authority on having assembled a valuable collection of material, and invites it, to institute an inquiry, with the help of all the means placed at its disposal by the Treaty, into the shortage of skilled labour and the lack of opportunities for expansion in the various industrial centres of the Community;
- "12. considers that more should be done to improve the occupational-training programmes, which are of particular importance—especially from the point of view of industrial safety—for the trades in the coalmining and iron and steel industries;
- "13. invites the Governments to take all measures required to enable instructional material to be exchanged between the six countries, by doing away with customs formalities;

as regards developing opportunities for employment:

- "14. considering that the drop in the number of workers employed in the basic industries can be regarded as a sign of social progress only where it is accompanied by the creation of new openings for employment;
- "15. trusts that the High Authority will press the Governments concerned to pursue a general economic policy aimed at expansion;
- "16. having noted the letter from M. BECH, stating that the Foreign Ministers of the six countries have fixed their meeting for June 1, and will on that occasion, in addition to appointing a President and Vice-Presidents of the High Authority, examine the course of action to be pursued with the aim of furthering European integration;
- "17. asks that the Governments incorporate in their plan of action provisions based both on the principles enumerated above and on the following considerations:
 - (a) the Assembly asks that the creation of new activities to provide redundant labour with productive re-employment on the spot, or with re-employment in other enterprises, be pursued with vigour, and that to this end the levy provided for in the Treaty, and all similar European funds, may be used directly to facilitate this work of creating activities providing openings for re-employment;

(b) it further asks that the solidarity of the Community in covering risks of unemployment, at present limited by the Treaty to the consequences of the introduction of the Common Market and of technical progress, be extended as quickly as possible to cover total or partial unemployment affecting all or part of the industries coming under the jurisdiction of the Community as a result of fluctuations in trade, as also to the means of ensuring that, in the interest of preserving the continuity of employment, any shutting-down of enterprises will be gradual;

as regards the building of workers' houses:

- "18. whereas, if the social objectives of the Treaty are to be attained, it is, in particular, essential that healthy housing accommodation should be available on an adequate scale;
- "19. observing that in many cases workers who are unemployed as a result of rationalization measures can be re-employed only if accommodation is made available at their new place of employment;
 - "20. invites the High Authority
 - (a) to place the data obtained from experimental building schemes, as soon as they are known, at the disposal of all those concerned with the construction of workers' housing as quickly as possible, in whatever form may seem most desirable;
 - (b) to launch, at an early date, a further project as part of the technical and economic research provided for in Article 55 of the Treaty, in order to be able to examine certain special problems in greater detail:
- "21. requests the High Authority to carry into effect as soon as possible its expressed intention of replacing that portion of the American loan which had been intended for the building of workers' houses by an equivalent amount derived from other loans, to be set aside for the building of workers' houses:
- "22. invites the High Authority to reduce, by all means at its disposal under the Treaty, such obstacles resulting from currency exchange risks as may stand in the way of the financing of workers' houses when using loans contracted by the High Authority for that purpose;
 - "23. approves the endeavours of its Social Affairs Committee in regard to
 - (a) joining with the High Authority in working out the extent to which, in accordance with Article 56 of the Treaty, assistance may be granted for the building of workers' houses as part of the scheme for the re-employment of labour;
 - (b) examining whether there are possibilities for granting loans at reduced interest, in accordance with the provisions of Articles 49 and 50 and Article 54, paragraphs 1 and 2, of the Treaty;
- "24. invites the Social Affairs Committee and the Committee on Investments, Financial Questions and Production Development to designate by common agreement a Sub-Committee to study the problems just listed from the legal angle, requesting, where appropriate, the opinions of experts;

- "25. while hoping that new sources of financing may be opened up for investments in the Community, emphasizes the need to accord to investments in connection with the building of workers' houses their rightful place alongside of the technical investment programme;
- "26. urges that the High Authority make sure that the workers' housing schemes which it is helping to finance are genuinely supplementary to the schemes which can ordinarily be carried out with the funds available in the member countries themselves:

as regards the improvement and harmonization of living and working conditions:

- "27. invites the High Authority to persevere in its work of assembling the material needed to enable the organizations concerned to draw up model collective agreements;
- "28. asks the High Authority and the Governments of the member States to prepare, in co-operation with the employers' and workers' organizations, the measures to be taken in respect of the progressive harmonization of the regulations in force in the various countries in connection with working conditions, and in particular those on the number of working hours, the calculation and payment of overtime, the holidays allowed and the rates of holiday pay;
- "29. congratulates the High Authority on the way in which it has handled the inquiry into the various aspects of the living and working conditions of workers employed outside their country of origin;
- "30. expresses the hope that in the near future direct contact may be established between its Social Affairs Committee and the workers' and producers' representatives;
- "31. asks the High Authority to assemble, by means of levies, all such funds as may be required for the full implementation of its social mission;
- "32. asks the High Authority to keep the Assembly and the Committees concerned constantly informed as to what results have been achieved in the social field, what its projects are, and whether or not there are sufficient funds to cover them:
- "33. emphasizes that the preliminary estimates drawn up by the High Authority, on its instructions, require to be constantly revised, particularly in the event of the High Authority's terms of reference in the social field being extended, in accordance with the express desire of the Assembly."

The Assembly adopted the following Resolution:

RESOLUTION

concerning

the Community's relations with Great Britain

"THE COMMON ASSEMBLY,

- "1. whereas it has since January 1953 drawn constant attention to the importance of an association with Great Britain;
- "2. whereas it has supported by all the political means at its disposal the conclusion of the Agreement signed in London on December 21, 1954;

- "3. whereas it recognizes the capital importance of the relations between "Great Britain and the Community for further development of the Community;
- "4. whereas, in the present political situation, it is in the highest degree desirable that the provisions of the Agreement may be put into effect, to enable the Council of Association to assume its duties during 1955;
- "5. recommends that the Foreign Ministers of the Community forthwith "take all such measures as may be indicated for the implementation of the "Agreement, and that they consult together to that end at their next meeting, "now fixed for June 1."

DEBATE TO DEFINE THE POSITION OF THE ASSEMBLY

before the meeting of Ministers to be held on June 1.

With reference to this debate, the Assembly noted that Resolution No. 41 had been tabled.

It decided not to refer this to a Committee, but to debate it forthwith.

Speakers: Mile. KLOMPE, MM. DEHOUSSE, RIP, KAPTEYN, NEDERHORST, KOPF, BLANK, CHUPIN and SCHOENE.

The general debate was closed.

The Assembly decided to divide on the proposed Resolution considered as a whole.

Paragraphs 1, 2 and 3 were adopted.

Upon the proposal of M. NEDERHORST, paragraph 4 was deleted.

Paragraph 5 (a) was adopted.

Amendment No. 1 concerning paragraph 5 (b), was rejected.

Paragraph 5 (b) was adopted in the wording submitted by the Committee.

Amendment No. 2, for the insertion of a new paragraph before paragraph, 6, was adopted.

Paragraph 6 was adopted.

MM. KOPF and RIP gave explanations of their vote.

The Assembly adopted the whole of the following Resolution:

RESOLUTION

defining the position of the Assembly before the meeting of Ministers to be held on June 1, 1955.

"THE COMMON ASSEMBLY,

- "1. whereas the mission of the Community is defined in Articles 2 ff. of the Treaty, and whereas it is the object of the Treaty to bring about not only economic but also social progress;
- "2. whereas at the end of its second financial year the Community can note with satisfaction that undoubted progress has already been made towards the attainment of its objectives;

- "3. whereas, according to the Reports by the High Authority and by the "Committees of the Assembly, further progress is impeded by certain articles delimiting the powers of the various institutions of the Community;
 - "4. requests the Foreign Ministers at their meeting on June 1
 - (a) to invite the institutions of the European Coal and Steel Community to draft proposals for such extension of its competence and powers as is indispensable if the Community is effectively to fulfil its mission as defined in the Treaty;
 - (b) to instruct an intergovernmental conference or conferences to prepare, with appropriate assistance from the institutions of the Community, the draft treaties required for the further stages in European integration, which began with the establishment of the European Coal and Steel Community;
- "5. expects that the appointment of a President and two Vice-presidents, which has been in abeyance for some months, will finally be made at the meeting of Foreign Ministers to be held on June 1;
 - " 6. asks the High Authority
 - (a) to prepare its work of providing guidance for a Common Market by fixing the time-limit within which it proposes to comply with the binding provisions of Article 46 of the Treaty, under which it is obliged to set out general objectives and draw up programmes giving forecasts;
 - (b) to take all measures to ensure that at the end of the transition period, half of which has already elapsed, the adaptation of the national industries will have been effectively carried out."

ADJOURNMENT OF THE ORDINARY SESSION

The Assembly decided to adjourn its Ordinary Session, for resumption on Tuesday, June 21, 1955, at 4 p.m.
