IN THE COUNTRIES OF THE COMMUNITY**

















**Development of gross national product  
in EEC countries, 1953-1963**



## **Breakdown of national expenditure in EEC countries, 1962**





## Livestock of cattle, pigs and poultry in the EEC countries, 1963




## 1 Manpower and tractor-power in farming in EEC countries, 1960








## Industrial production : general index

## Apparent consumption of primary energy


