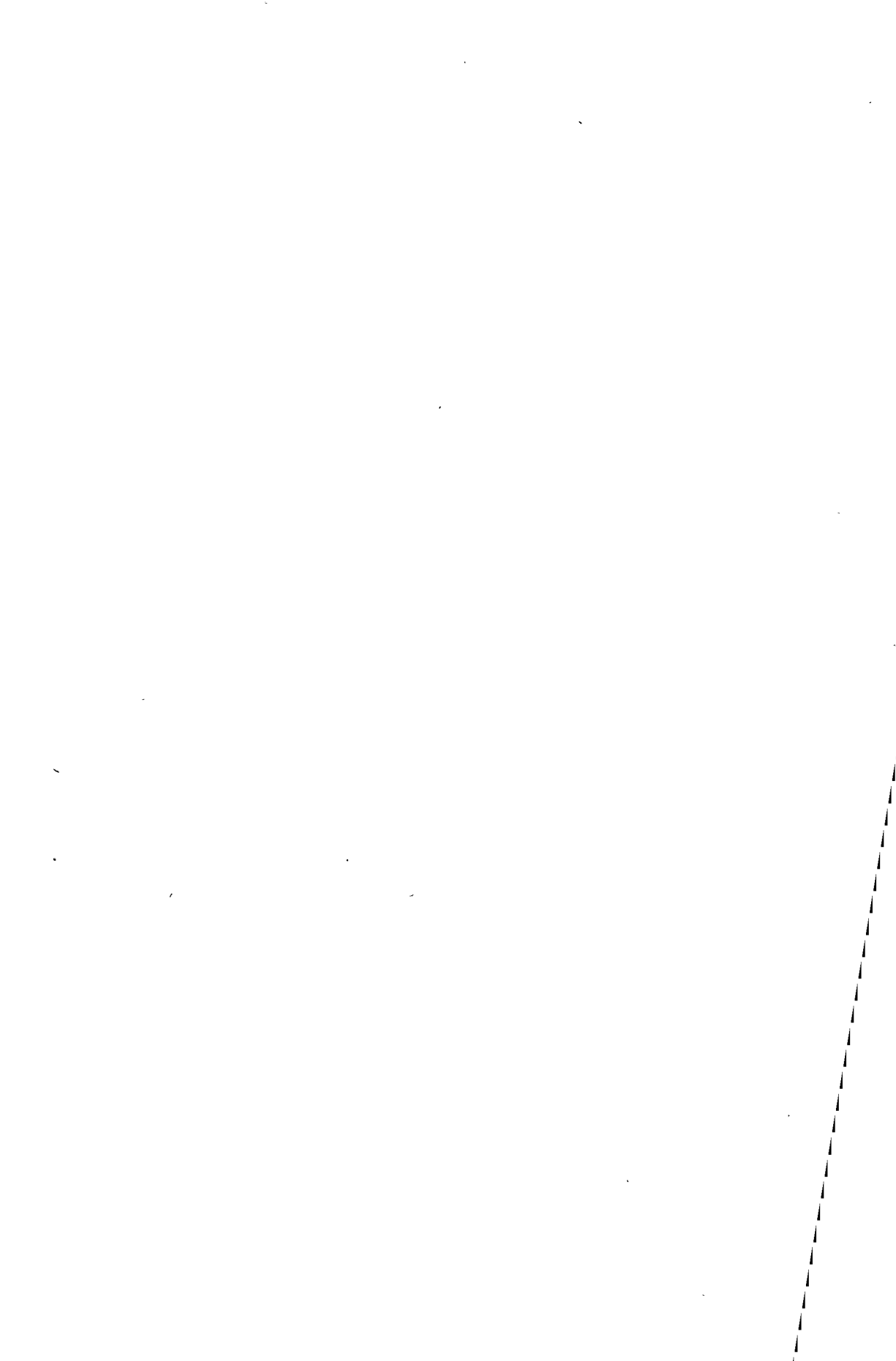

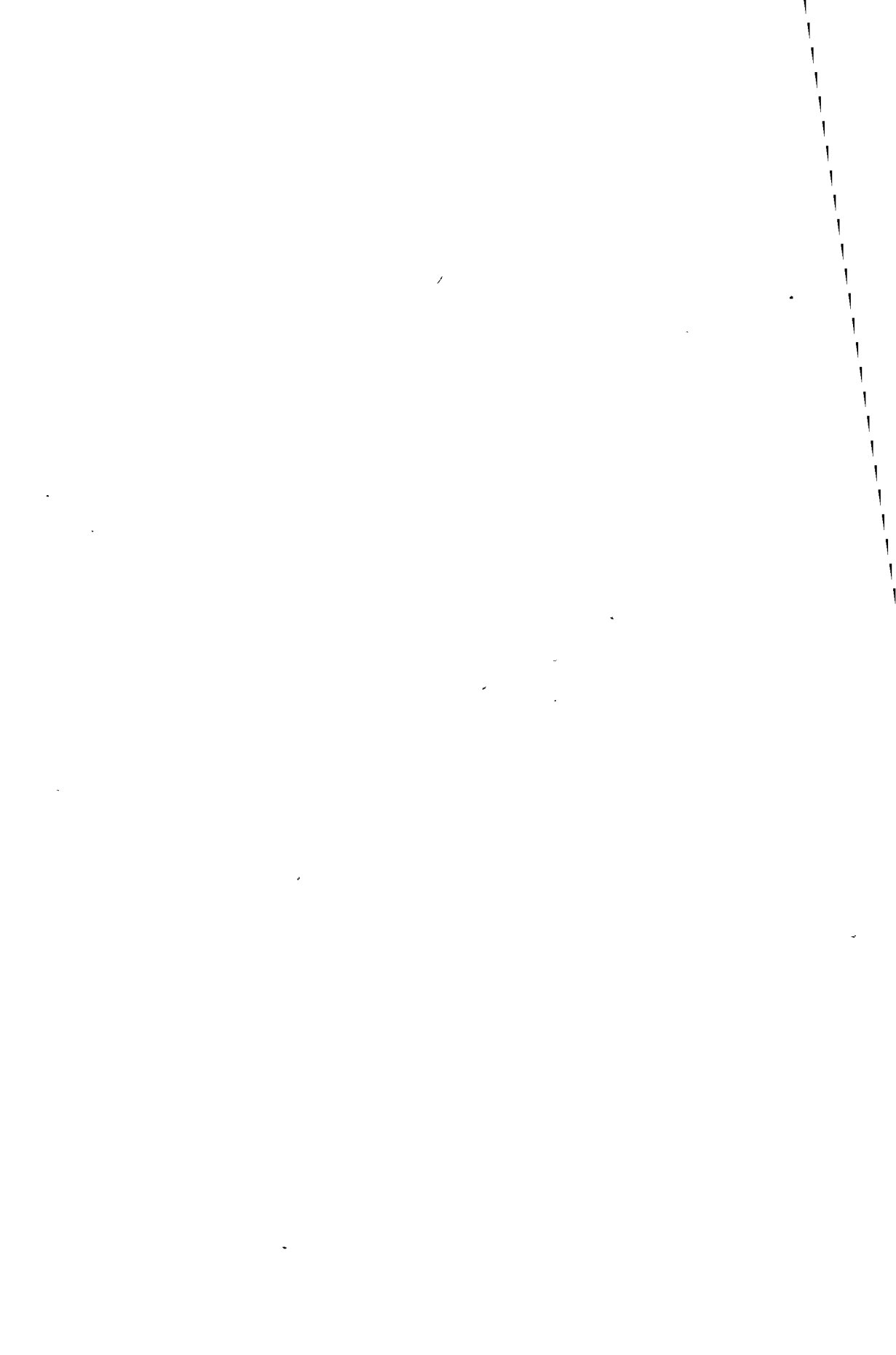
The Index to the 1970 Bulletin has separate sections for the main chapters:

- VI. Speeches and statements

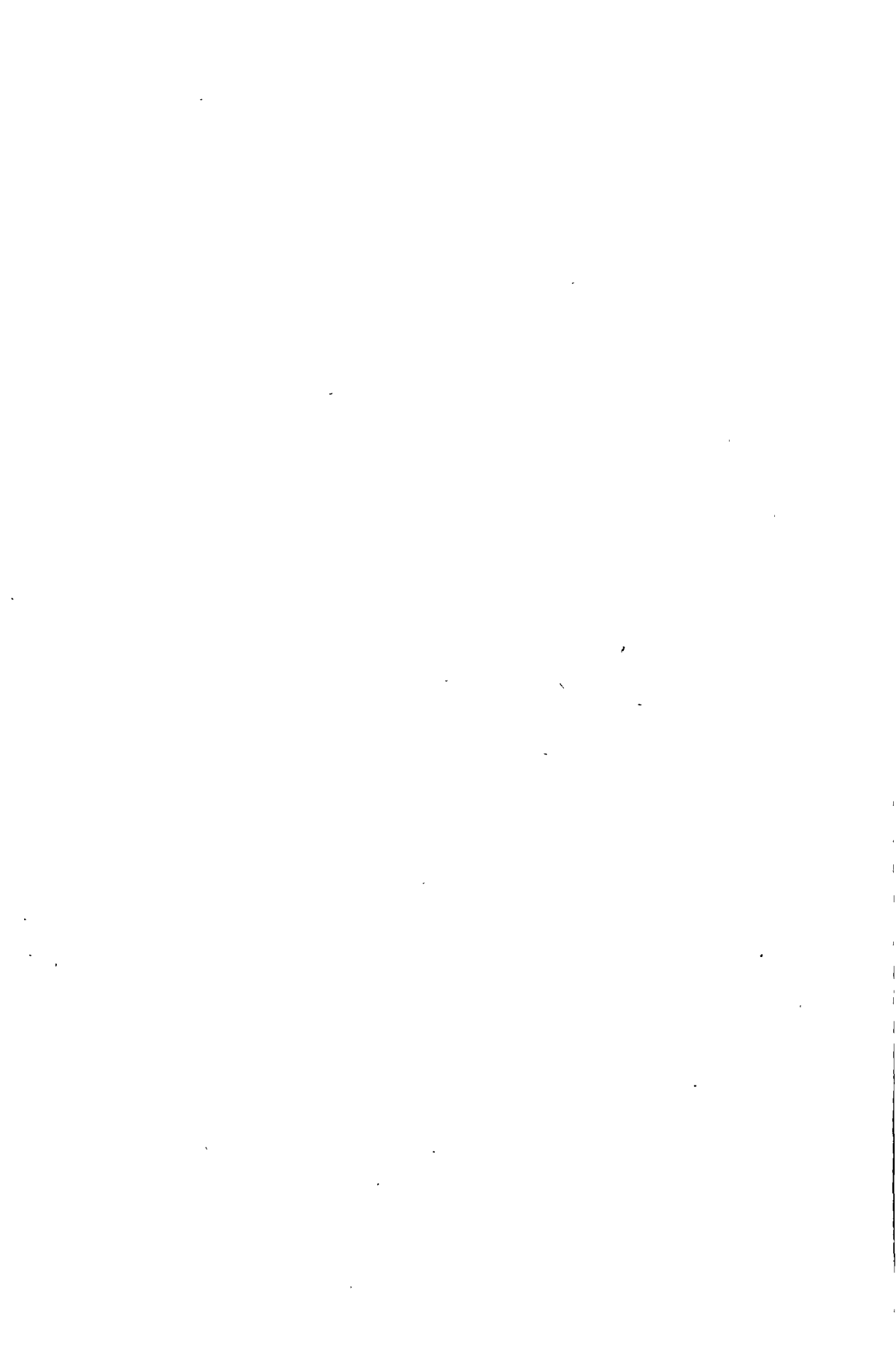

The reference system varies, depending on whether or not items have a section number. It shows:

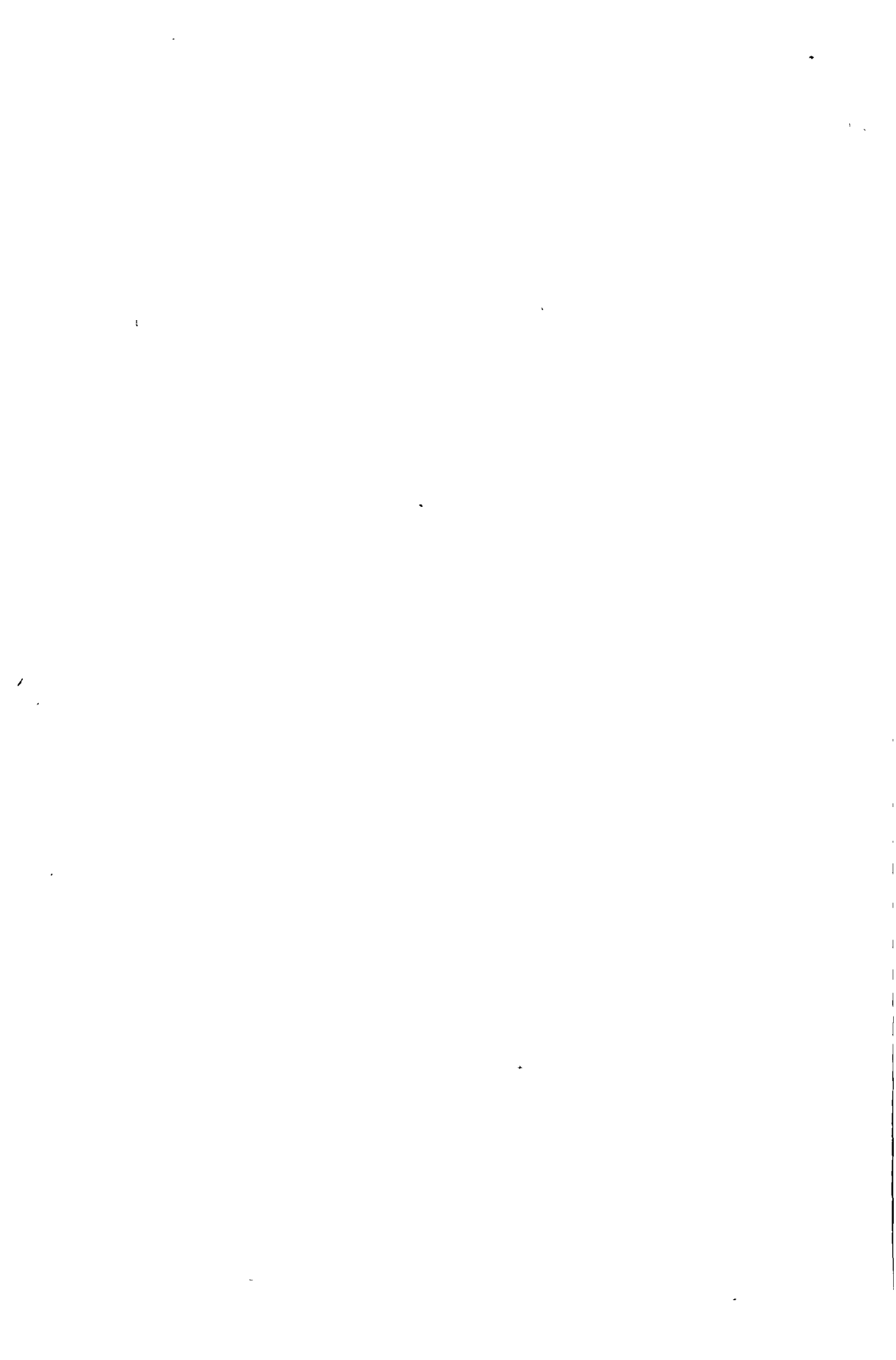
- (a) The Bulletin number, the section and the page for numbered items;
- (b) The Bulletin number, part ("A" or "B"), chapter and page for unnumbered items.



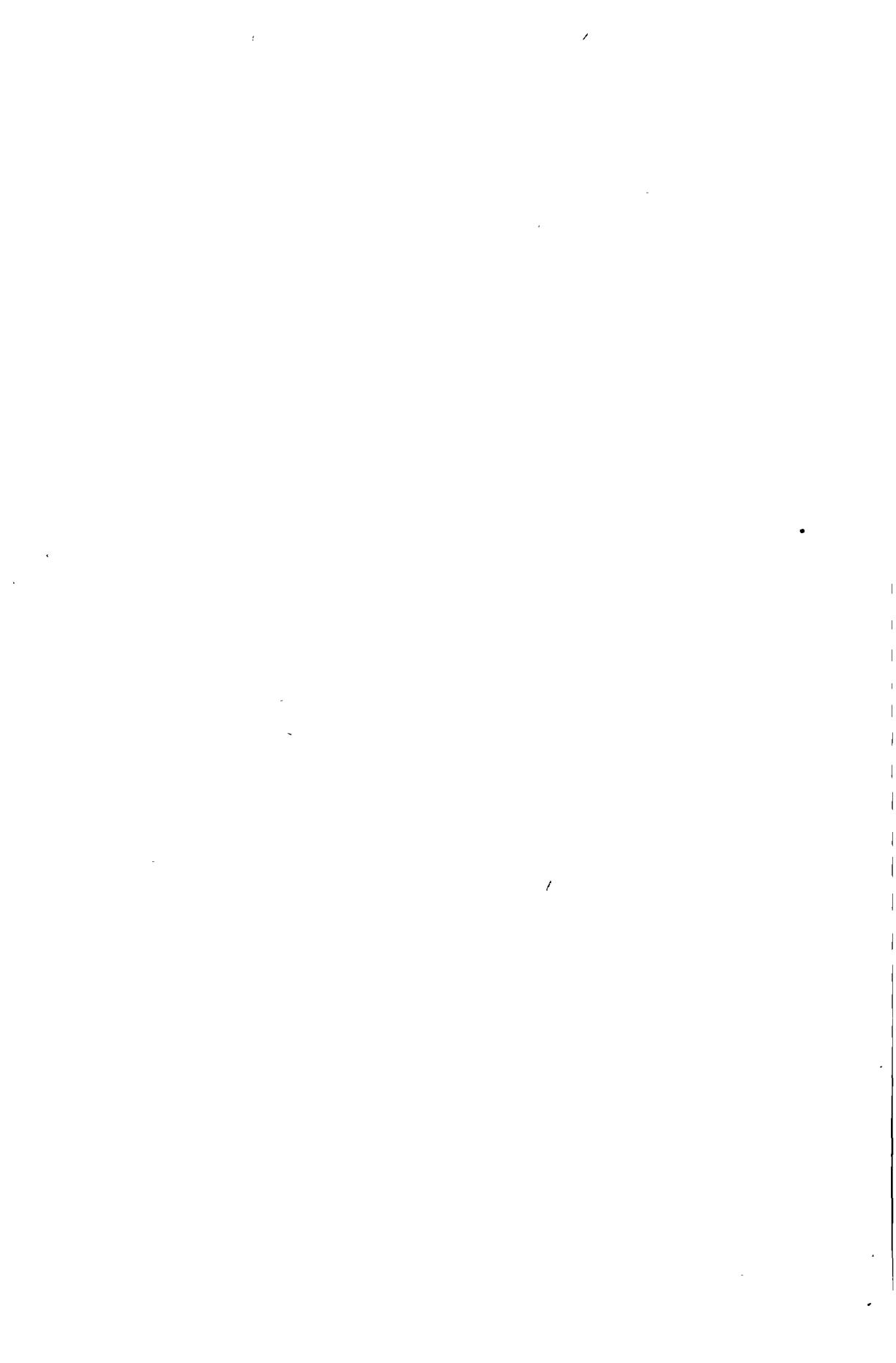

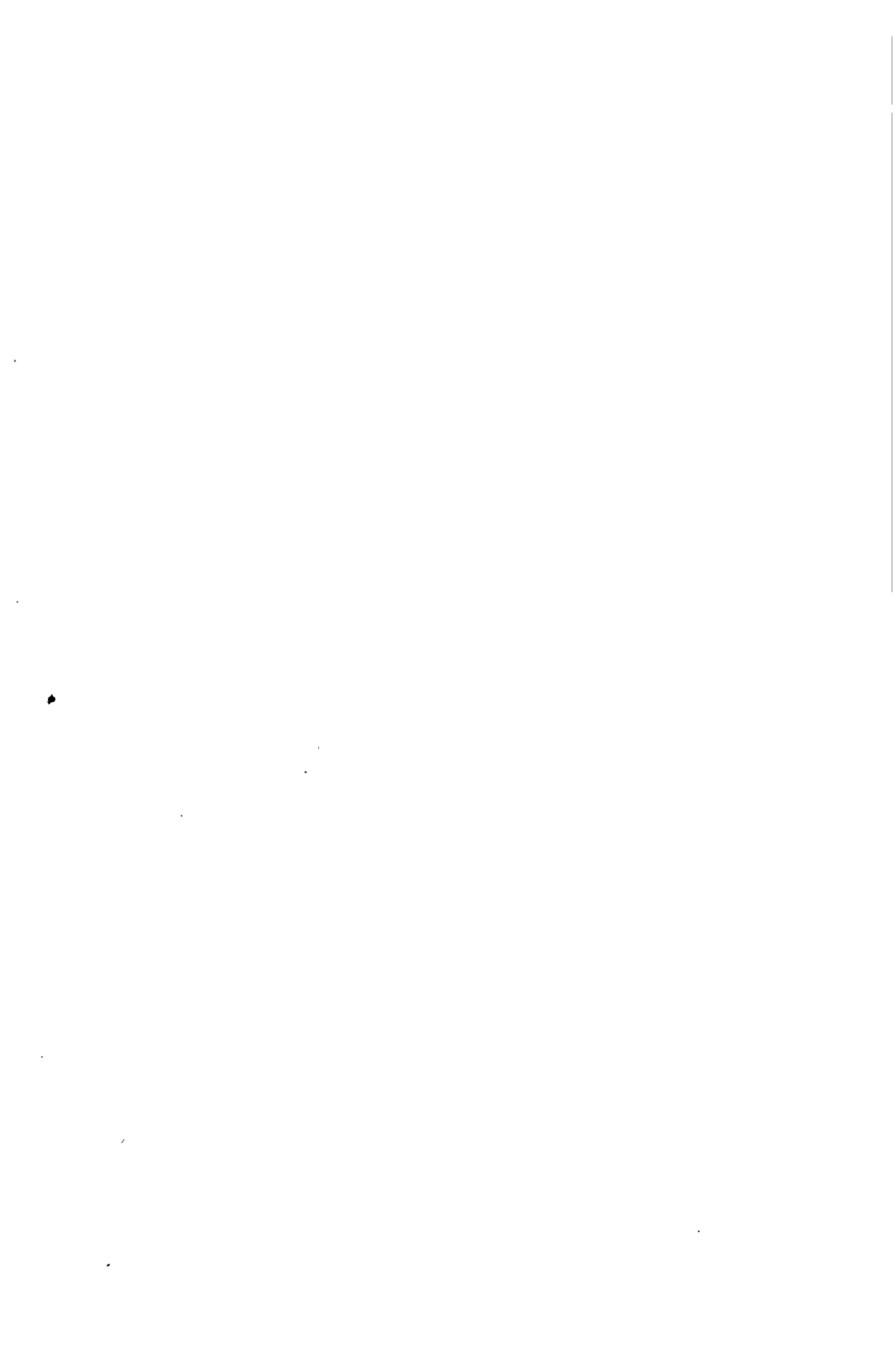
