1956-63: Joined the Planning Division of the Ministry of

In 1961, he was appointed Head of the Long-Term Planning of the same Minstry. In this capacity, he participated in the Mediterranean Regional Project of OECD on Human Resource Development and was appointed Project Manger for Greece. During the same time he was appointed Member of the Transport Sub-Committee of Association with the EEC. 1972-74 :

In 1972 he took the post of Managing Director of the Planning and Development Company S.A. in Athens responsible for the development of the property of the

Church of Greece.

1974-77 :

In June 1974 joined American Express International Banking Corporation. In 1975, together with three A.E.I.B.C., he executives of established ERGOBANK with which he stayed as General Manager until November 1977, at which time he was invited by Prime Minister Constantine Karamanlis to ioın government.

1977 to date :

In November 1977 he was appointed Under-Secretary of State at the Ministry of Coordination. he remained in this position until 1980 while, in 1978, he was elected Deputy of the Greek Parliament for the first time. In September 1980 Mr. Paleokrassas was promoted to Alternate Minister of the same Minstry, and in June 1981 he was appointed Minister of Coordination.

In the general elections of October 1981 Mr. Paleokrassas was elected Deputy for the Cyclades Islands and kept this seat being successively reelected in 1985, 1989 (twice), until 1990, when he decided not to run as he was appointed campaign manger for the April 1990 elections, which his party won. During the period 1981-90 in which his political party (Nea Dimokratia) was in the opposition, he served as Secretary General of the Parliamentary Group, Chairman of the Financial Committee of the Party, Chairman of the N.D. Parliamentary Group on National Economy.

1990-92 :

In April 1992 Mr. Paleokrassas was appointed Minister of Finance.
