REGULATION (EEC) OF THE COUNCIL

amending Regulation No 213/67/EEC establishing the list of representative markets for pigmeat in the Community

(submitted to the Council by the Commission)



EXPLANATORY MEMORANDUM

Regulation N° 121/67/EEC on the common organization of the market in pigmeat makes provision for intervention measures to be adopted when on the representative markets of the Community, the average price for pig carcases is below 103 % of the basic price.

The list of these representative markets was fixed by Regulation N° 213/67/EEC of the Council of 27 June 1967. This Regulation last amended by Regulation (EEC) N° 2708/72 of the Council at the accession of the three new Member States to the Community, with respect to the United Kingdom designates Guildford as the representative market.

It was agreed at the time of the adoption of the last mentioned regulation that the list of representative markets of the new Member States should be provisional, and consequently should be amended if experience showed that it was necessary.

It is proposed that the representative market of Guildford should be replaced by five representative markets situated throughout the territory of the United Kingdom, in accordance with an application by that State.

For the sake of clarity and to simplify the utilization of the provisions in Regulation N° 213/67/EEC it seemed advisable to publish a complete list of the representative markets at present designated.

THE COUNCIL OF THE EUROPEAN COMMUNITIES -

Having regard to the Treaty establishing the European Economic Community;

Eaving regard to Council Regulation No 121/67/EEC⁽¹⁾ of 13 June 1967 on the common organization of the market in pigment, as last amended by Regulation (EEC) No $1861/74^{(2)}$, and in particular the first indent of Article 4 (5) thereof:

Having regard to the proposal from the Commission;

Whereas Council Regulation No 213/67/EEC⁽³⁾ of 27 June 1967 establishing the list of representative markets for physical in the Community, as last smended by Regulation (EEC) No 2708/72⁽⁴⁾, laid down under heading no 7 of the Annex the market of Guildford as the only representative market in the United Kingdoms

Whereas experience over the first two years following the accession of the United Kingdom to the European Economic Community has shown that a single market is not sufficiently representative for the United Kingdom; whereas several representative markets should therefore be established; whereas, furthermore, the whole Annex to Regulation No 213/67/EEC should, for the sake of clarity, be replaced;

HAS ADOPTED THIS REGULATION !

Article 1

The Annex to this Regulation shall be substituted for the Annex to Regulation No 213/67/EEC.

Article 3

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in
